Purpose and Audience:

The Colorado Department of Health Care Policy & Financing (Department) invites the public to comment on proposed waiver amendments to the following Home and Community-Based Services (HCBS) waivers: Persons with Brain Injury (BI), Children's Extensive Support (CES), Children's Home and Community-Based Services (CHCBS), Children's Habilitation Residential Program (CHRP), Children with Life-Limiting Illness (CLLI), Community Mental Health Supports (CMHS), Developmental Disabilities (DD), Elderly, Blind, & Disabled (EBD), Persons with Spinal Cord Injury (SCI), and Supported Living Services (SLS).

Information:

The Department intends to submit the amendments to the Centers for Medicare & Medicaid Services (CMS) on April 2, 2021. The Department will request an effective date of July 1, 2021 for the amendments.

The proposed waiver amendments include the following changes:

- Update waivers to reflect new Level of Care Screen (LOC Screen), Assessment, and Person-Centered Support Plan (PCSP) (BI, CES, CHCBS, CHRP, CLLI, CMHS, DD, EBD, SCI, SLS);
- Addition of Telehealth as a Service Delivery Option for specific HCBS waiver services (BI, CES, CHRP, CLLI, CMHS, DD, EBD, SCI, SLS).
- Update Appendix G Participant Safeguards (BI, CES, CHCBS, CHRP, CLLI, CMHS, DD, EBD, SLS, SCI).
- Addition of Relative Provider to the Community Connector Service (CHRP).
- Addition of Sick Pay to Consumer-Directed Attendant Supports and Services (BI, CMHS, EBD, SCI, SLS).
- Language updates to performance measurements (BI, CES, CHCBS, CHRP, CLLI, CMHS, DD, EBD, SCI, SLS).
- Update Appendix J Projections and Unduplicated Counts (BI, CES, CHCBS, CHRP, CLLI, CMHS, DD, EBD, SCI, SLS).
