A. Emergency Adoption

Document 10, MSB 23-02-27-C, Revision to the Medical Assistance Act Rule Concerning Inpatient Payment Rates for Opioid Antagonist, Section 8.300.5.D

Andrew Abalos, Rates Division, presented the rule and explained that House Bill 22-1326 appropriates funding allowing the Department to reimburse opioid antagonist drugs outside of its current reimbursement methodology. Currently, there is not distinct reimbursement for the opioid antagonist drug Naloxone in the payment bundles used for outpatient hospital payment calculation. This rule change will allow the Department to make payment outside of the payment bundles, creating greater incentive to inpatient hospitals to provide take-home Naloxone to patients at-risk for opioid overdoses.

Nancy Dolson, Special Financing Division, presented the rule and explained rule is back for emergency adoption to include Attorney General revisions. Purpose of legislation, stakeholder outreach. Advisory committee reviews applications.

Andrew Abalos, Rates Division, presented the rule and purpose to reimburse providers for naloxone. Aligns reimbursement with legislation.

Board Discussion – Board discussion included a question about the timing of the emergency rule earlier to the final adoption and how a gap in coverage would occur without the emergency adoption.

Russ Zigler, Operations Section, and Haylee Rodgers, Benefits Section, presented the rule and explained revisions adding providers to authorized individuals ordering Durable Medical Equipment.

Document 08, MSB 23-01-26-A, Revision to the Colorado Dental Health Care Program for Low-Income Seniors, Section 8.960 Schedule A

Chandra Vital, Special Financing Division, presented the rule and explained revisions including two procedures recommended by the Dental Advisory Committee.

Board Discussion – Board discussion included support of the changes and if the funding allocation will be going up. The Committee oversees copay and benefit cost and the funding comes from the Legislature.

Public Testimony – Phyliss Hirschfeld, Colorado Gerontological Society, grantee under LIS program. Support addition of partial denture codes.

Dr. Nguyen moved for the initial approval of Document 08. Dr. Fraley seconded the motion.

The Board voted the initial approval of Document 08, 8:0.

Document 09, MSB 22-12-13-B, Creation of the Medical Assistance Rule concerning the Secure Transport Benefit, Section 8.019

Alex Lyons, Operations Section, and John Lentz, Behavioral Health Initiatives and Coverage, presented the rule and explained legislation creates a new benefit, secure transportation for individuals to a facility.

Board Discussion – Board discussion included the definition of a mental health crisis in the rule. Discussion also included no limit on distance to a facility, including the ability to be transported to additional facilities if the original facility does not have capacity. The return trip was discussed with stakeholders and now not in crisis and Non-Emergency Medical Transportation should be used. The communication plan was discussed.

Galia Spychalska – PDN updates, lack of communication, hours authorized but still required to submit PARs with no guidance on info required. Stakeholder outreach has begun and the Member Experience Advisory Committee is working hard to get letters out the door.

Katie Wallet – Colorado Center on Law and Policy – the end of continuous coverage requires States to perform ex-parte renewals. Colorado's ex-parte rate is 34% and the optics of 34% is misleading.

Karen Leh – Still very concerned with PDN issues, unclear on PAR requirements.
