Appendix A – Payment Comparison Methodology

Appendix A includes details of the benchmark creation and payment comparison methodology. The Department contracted with Optumas, an actuarial firm, to provide support in comparing Colorado Medicaid rates to those of other payers. This appendix was prepared and written by Optumas.



Home and Community Based Services (HCBS) Waivers

The Department contracted with the actuarial firm Optumas to provide support in comparing Health First Colorado provider rates to those of other payers. This analysis comprised three main steps: 1) Data Validation, 2) Re-pricing Validation, and 3) Payment Comparison. The following Home and Community Based Services (HCBS) waivers, as well as the Targeted Case Management (TCM)¹ service, were reviewed:

- Elderly, Blind, and Disabled (EBD)
- Community Mental Health Supports (CMHS)
- Brain Injury (BI)
- Spinal Cord Injury (SCI)
- Children's Home and Community Based Services (CHCBS)
- Children with Autism (CWA)
- Children with Life-Limiting Illness (CLLI)
- Children's Extensive Support (CES)
- Children's Habilitation Residential Program (CHRP)
- Developmental Disabilities (DD)
- Supported Living Services (SLS)

Payment rates were compared with those of Connecticut, Ohio, Oklahoma, Utah, and Montana.² Results of this analysis are shown in Table W1, which displays the percentage at which Colorado reimbursed relative to each benchmark state and, all else being equal, the impact to total HCBS waiver expenditures for FY 2015-16 if Colorado were to reimburse at 100.00% relative to each benchmark state.

Among these states, it was notably difficult to locate appropriate comparisons for CLLI and CHRP services (Table W1 does include results for a small amount of CLLI respite care). Therefore, an additional effort was made to incorporate states that could produce more complete results for these waivers only.

¹ CCR 8.500.1, Targeted Case Management is a State Plan benefit for a target population. ² The five states selected for the analysis were provided by the Department. However, because these five states did not have enough comparable services for CLLI and CHRP, three additional states were provided by the Department and incorporated into the analysis for these specific waivers.

Table W2 shows similar figures for North Dakota, California, and Wisconsin, which were suggested by the Department for comparison with CLLI and CHRP respectively.

Separate comparison results for all the above states, broken down by waiver and service, can be found in Appendices WC and WD respectively.

Data Validation – HCBS Waivers

The Department provided FY 2014-15 and FY 2015-16 fee-for-service claims data for HCBS waiver services to Optumas. The data validation process included: volume and dollar checks over time to identify potential inconsistencies; a frequency analysis across all fields to fully account for the contents of the claims; and a comparison with datasets from previous fiscal years. Additionally, total dollars were compared with the Department's Budget Division numbers and other external sources for consistency. Results of this process suggested that the relevant HCBS waiver data was both complete and reliable. Next, the data was reviewed to determine the relevant utilization and account for applicable exclusions. The exclusion criteria adhere to the general guidelines set forth in the Rate Review Schedule. Claims with denied status or that were otherwise zero paid were excluded, and claims associated with members enrolled in the capitated CHP+ program were also excluded. The total unadjusted paid dollars for FY 2014-15 totaled \$789,292,616, and for FY 2015-16 totaled \$848,179,157.

Furthermore, the validation process accounted for several additional exclusions:

- Codes paid at negotiated rates such as home/vehicle modification do not have a rate for comparison. Their removal accounted for \$32,740,488 (3.86% impact to paid dollars).
- A0100 (taxi) is a non-medical transportation service with rates controlled by the Public Utilities Commission. Its removal accounted for \$3,426,809 (0.40% impact to paid dollars).
- T2025 (consumer directed attendant support services (CDASS)) and T2040 (CDASS admin) are reimbursed as part of the CDASS delivery model, in which beneficiaries have the flexibility to pay for services at their discretion. Their removal accounted for \$103,460,102 (12.20% impact to paid dollars).
- Codes paid at \$1.00 per unit are manually priced. Their removal accounted for \$6,447,035 (0.76% impact to paid dollars).
- A9900 (community transition services items purchased) and T2038 (community transition services – coordinator) are limited to a \$2,000 maximum lifetime benefit. Their removal accounted for \$3,271 (negligible impact).
- T2033 (supported living program) was excluded when present on claims attributed to individuals residing outside of Colorado. Its removal accounted for \$452,922 (0.05% impact to paid dollars).
- T1017 (targeted case management) with modifiers other than only U4 was deemed to be
 outside the scope of this analysis. Its removal accounted for \$656,190 (0.08% impact to paid
 dollars).

Home and Community Based Services Waivers

After removing these services, the paid dollars for FY 2015-16 totaled \$700,992,340. The summary of exclusions from the FY 2015-16 base data can be found in Appendix WA.

Finally, FY 2015-16 claims data was used to make up the base utilization for the payment rate comparison analysis. This approach was selected because it yields an annualized result derived from the most recent experience. However, since these claims were only provided with 4.5 months of runout, an adjustment was necessary to account for claims incurred but not reported (IBNR). The claims processing lag inherent within the FY 2014-15 claims (17.5 months of runout) was used to infer the completion rate for each waiver. Following this adjustment, the paid dollars for FY 2015-16 totaled \$702,131,276. The IBNR utilization adjustment factors for each waiver can be found in Appendix WB.

Re-pricing Validation – HCBS Waivers

The re-pricing validation process involves identifying comparable waivers, and comparable services for appropriate rate matching. Since HCBS waiver services are not covered by Medicare, it was necessary to rely on information drawn from other state Medicaid programs. The states included Connecticut, Ohio, Oklahoma, Utah, Montana, North Dakota, California, and Wisconsin. To identify comparable rates, publicly available documentation on these states' 1915(c) waiver applications—specifically Appendix J, the demonstration of cost neutrality—was referenced. This section of each application reports the projected yearly average unit cost for all covered services throughout the waiver approval period. The values corresponding to FY 2016-17 were used as they are on the same basis as Colorado's July 1, 2016 fee schedule.

The matching of services required reasonable understanding of services as well as the service per unit denomination. For instance, using procedure codes and modifiers to assign comparable rates was not possible because each state devises its own system of coding. Instead, the individual service descriptions from each state were checked against those of Colorado and used to determine whether services were reasonably equivalent. Wherever possible, rates from similar waivers were prioritized over others for matching, but all services were ultimately considered if rates from an analogous program were not available. When multiple rates from similar waivers were available, the simple average of the rates was used in the comparison.

Multiple rates or tiered rates for one service was another complicating factor for service rate matching. Though some sets of services were readily identified as a matching pair, it was not uncommon for each state's delivery model to be different. For example, Colorado uses an acuity-based system to reimburse various levels of Residential Habilitation services, but the other states used in this analysis pay at a single rate; in other cases, the reverse was true. All instances of these tiered services were handled by calculating the weighted average rate, based on utilization, and incorporating this value into the comparison.⁵

³ There is often a lag between the time when services are rendered and the time when claims are paid. For example, a claim may not be paid for five months after the service has been rendered. To account for this lag, the IBNR adjustment is necessary to increase the base paid dollars and utilization.

⁴ Other states selected for this analysis were provided by the Department. North Dakota, California, and Wis consin were specifically incorporated to match services for the CLLI and CHRP waivers.

⁵ Utilization figures for other states' services were also found in the Appendix J information.

Finally, mismatched unit definitions were reconciled to preserve the validity of each comparison. Most of these situations were resolved with a straightforward conversion, such as reducing an hourly rate by a factor of four to produce a rate for 15-minute increments. More complex discrepancies required larger assumptions, and a listing of these follows in Table W3:

Once the service descriptions and unit definitions were aligned, a final check was performed to ensure reasonability. The nature of this analysis is such that variance between Colorado's rates and those of other states was expected, and thus the tolerance for differentials was high. Prospective matches were only eliminated from the final comparison when services clearly differed.

The following section explains how the appropriate identified services rates were applied to each waiver services and corresponding utilization.

Payment Comparison – HCBS Waivers

The final step consisted of applying the adjusted base utilization to re-price claims at Colorado's July 1, 2016 fee schedule as well as the matched rates from other states. This task entailed multiplication of Colorado's adjusted FY 2015-16 utilization and the corresponding rates from each state, followed by subtraction of third-party liability and copayments, to calculate the estimated total dollars that would theoretically be reimbursed by each state.

Regarding these estimates of total expenditures, two caveats must be mentioned that lend additional perspective to their interpretation:

1. Combining utilization with the fee schedule is an imperfect method of computing final responsibility in Colorado due to the "lower of" payment policy. This policy compares allowed charges with provider billed charges, and reimbursement is then based on the lower of the two.

2. Estimated expenditures were only compared for the subset of HCBS waiver services that are common between Colorado and each state respectively. In other words, if no comparable rate could be found within a given state for a specific service offered in Colorado, then the associated utilization and costs were not counted within that state's comparison results. An example of this dynamic is laid out in Table W4:

Only the claim for service B would be used for comparison. However, the discounted portion of the base utilization and costs was relatively small and does not detract from the overall validity of the analysis.

Once prices were defined, the adjusted utilization was re-priced by using Colorado's and other states benchmark rates. The total FY 2015-16 Colorado re-priced amount net of third party liability (TPL) and copay totaled \$713,253,013. Table W5 contains a summary illustrating the comparison of total dollars that would be reimbursed by each state. Separate comparison results for all states, broken down by waiver and by waiver services, can be found in Appendices WC and WD respectively. Given that North Dakota, California, and Wisconsin were not selected for the purpose of matching across all waivers, their results are not included in Table W5 but under Appendix WD. Please note that differences may exist when independently calculating these figures due to the rounding of numbers.

The first row in Table W5 "Colorado as a Percent of Other State's Expenditures" depicts how Colorado pays compared to the benchmark. The second row "Colorado 7/1/2016 Re-priced Amount with a Matching Rate" shows Colorado re-priced dollars for other states that had comparable services rates. The totals under the "Other State's Re-priced Amount" row shows the total re-priced dollars by using other states rates for comparable services. Finally, the "Estimated Impact Total Fund" includes an estimation of total impact by moving Colorado's rates to the comparable benchmark assuming FY 2015-16 utilization.

For example, the second column in Table W5 can be interpreted to mean that Colorado pays an estimated 20.18% less than Connecticut for HCBS waiver services. Had Medicaid reimbursed at 100.00% of Connecticut's rates in FY 2015-16, it is estimated that Colorado would have spent an additional \$177,563,526 in total funds.

These results may be interpreted as the minimum impact for two reasons:

- 1. As mentioned previously concerning the limitation of data to relevant HCBS waiver experience, claims that were denied or zero paid were removed along with their corresponding utilization.
- 2. A small portion of Colorado's expenditures was excluded from the comparison since there were some services for which a comparable rate could not be found.

Appendix WA: Base Data Summary

⁶ This statement must be evaluated in the context of both access and quality before drawing conclusions about the appropriateness of rates. There are services for which the Department pays more than 79.82% of Connecticut's rate, and others for which the Department pays less. In situations where access is sufficient, standards of quality are met, and the intent of the Department is to purchase value, a lower percentage of the benchmark would be acceptable.

⁷ The Total Fund and General Fund split refers to federal financial participation. The Total Fund includes both federal and state responsibility, and the General Fund consists of the state portion only.
