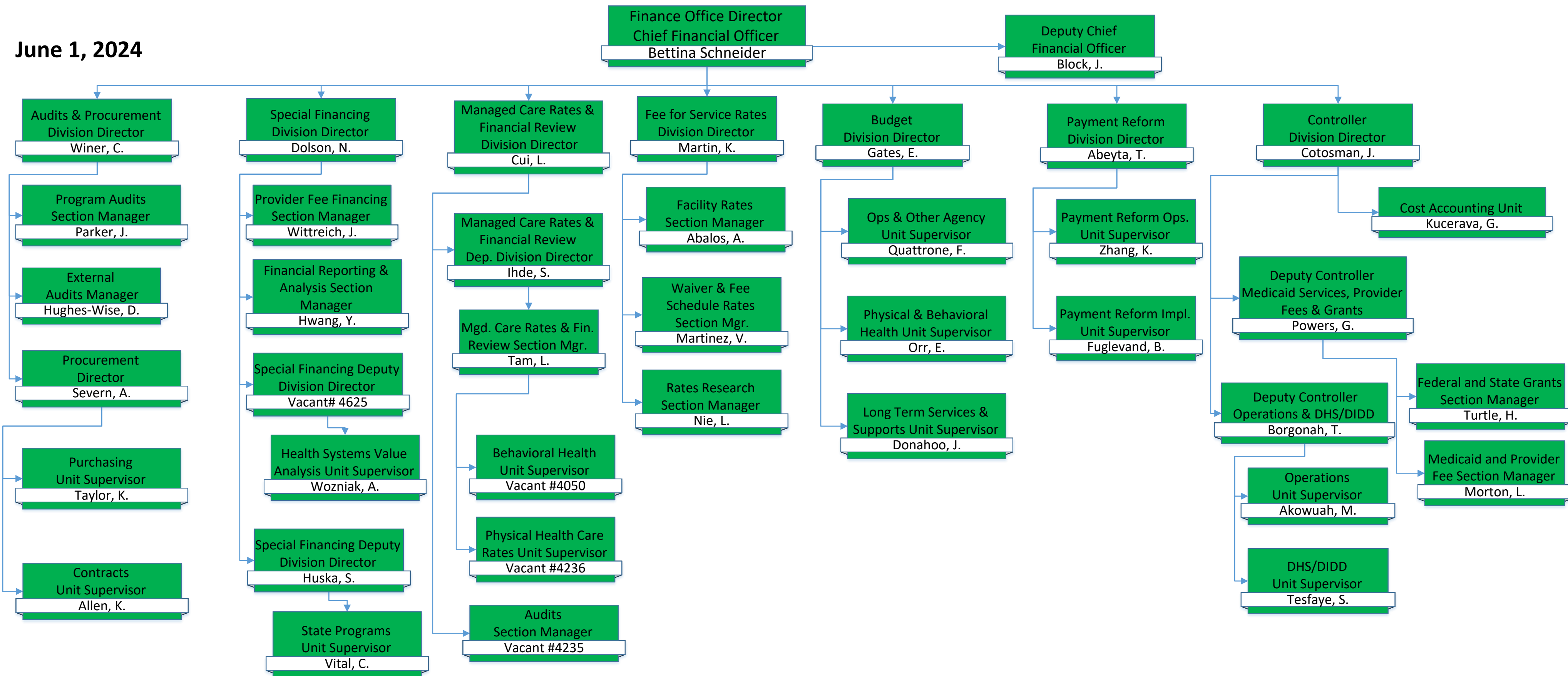
# Behavioral Health Initiatives & Coverage Office

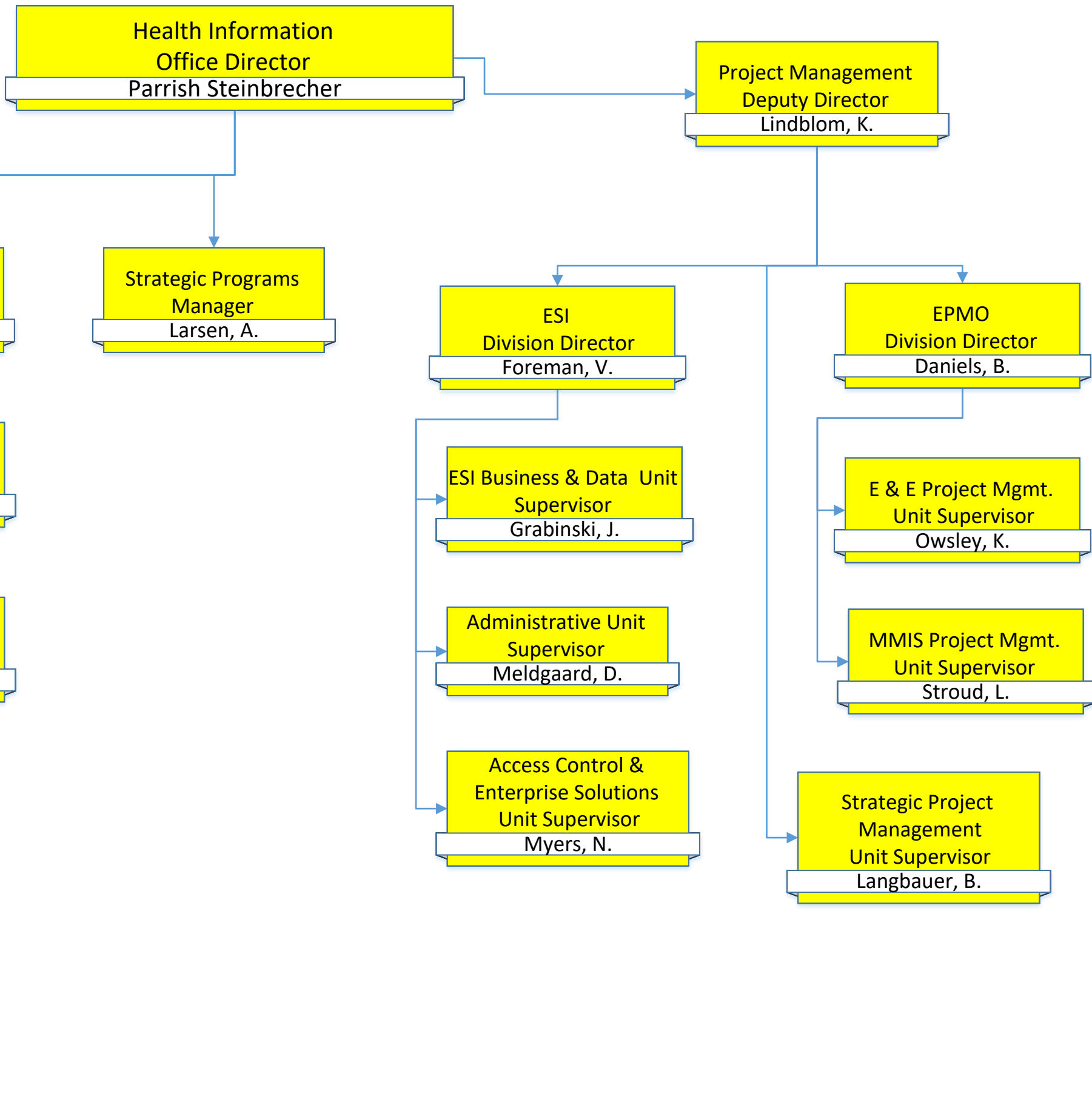

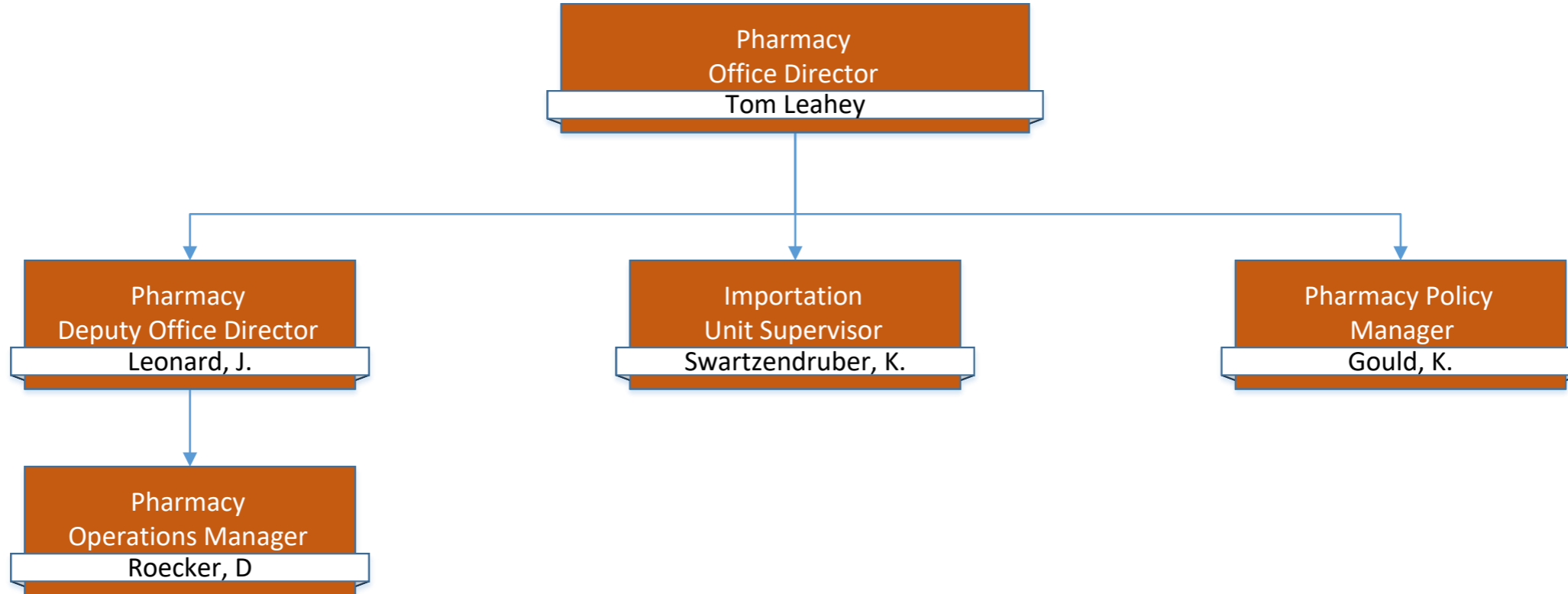

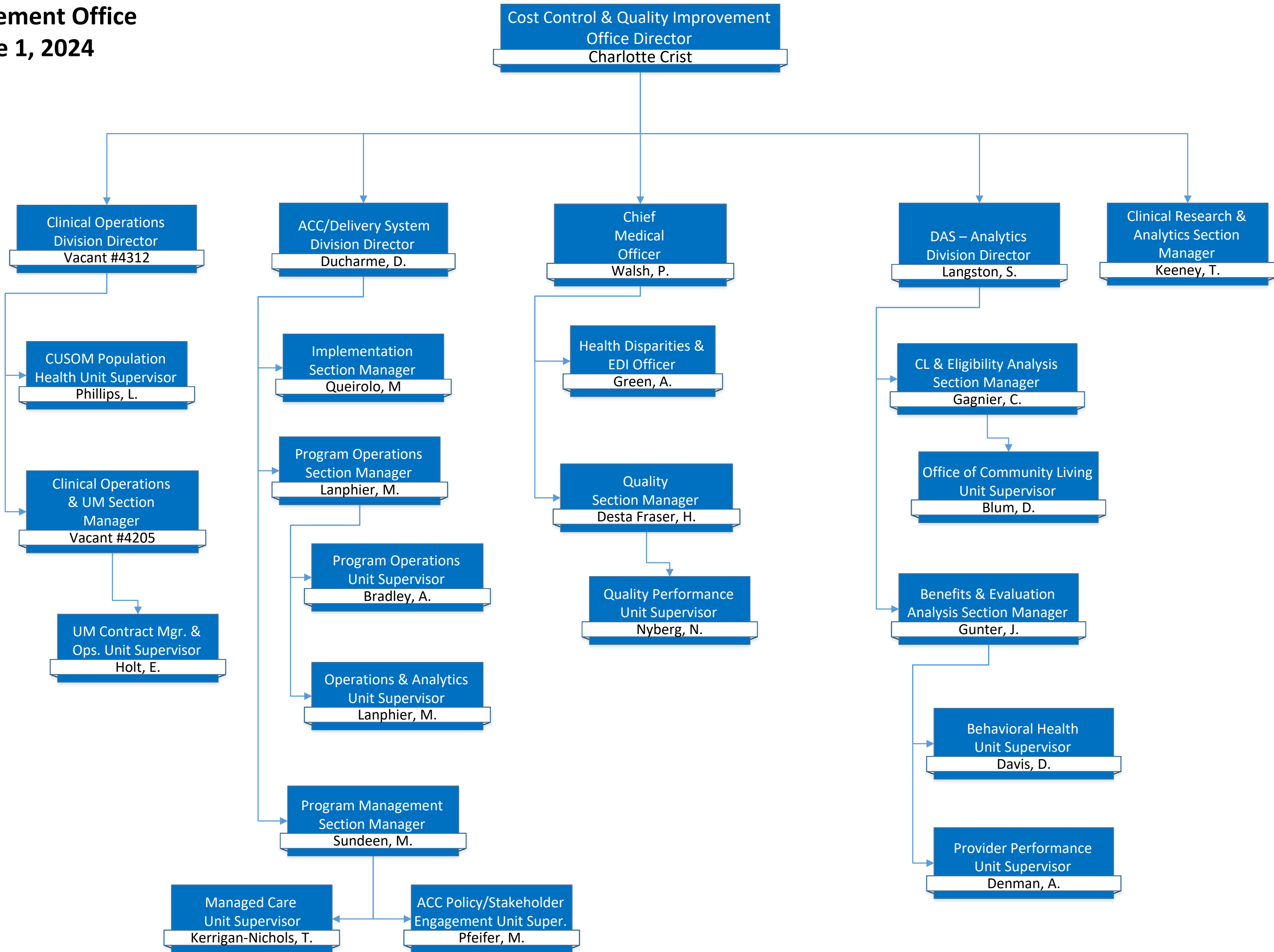
