

Doula Provider Enrollment: Attestation(s) and Pathways

- How can doulas enroll with Medicaid? What are our requirements?
- Doula's must attest to one of the following:
 - **Option 1:** Certification Pathway
 - **Option 2:** Experience Pathway



Option One: Certification Pathway

Four Attestations:

(1) I attest that have received training as a Doula from one of the Department approved Training Organizations. List can be found on the Doula Billing Manual found here. Attach a copy of this certification. (Note: we are going to discuss training organizations on the next slide today)

(2) I attest that I have attended at least three births (not including your own) within the last five years. Attach a copy of a complete Birth Attendance Attestation Form found in the Doula Billing Manual found here.

(3) I attest that I have current CPR Training Credentials. Attach a copy of this certificate/card.

(4) I attest to follow the Doula Code of Conduct found here. Attach a copy of this signed Code of Conduct.



Attestation #1:

I attest that have received training as a Doula from one of the Department approved Training Organizations. List can be found on the Doula Billing Manual found here. Attach a copy of this certification.

What you need to know:

- "Doula Training Organization Form" to be released next month. This form will ask interested organizations to fill out some key information including # of hours, languages offered, competencies covered, and contact information.
- We will ask any interested organizations to fill this out for evaluation to add to the list. This list will live on our website so it can be fluid.
- The minimum # of training hours required will be 18. \bullet



Attestation #2:

I attest that I have attended at least three births (not including your own) within the last five years. Attach a copy of a complete Birth Attendance Attestation Form found in the Doula Billing Manual found here.

What you need to know:

- "Birth Attendance Attestation Form" to be released next month.
- The minimum # of births in addition to certification will be three (3).

I attest that I have current CPR Training Credentials. Attach a copy of this certificate/card.

Option Two: Experience Pathway

Five Attestations

(1) I attest that I have attended at least 10 births in my role as a doula AND at least 5 of them in the past two years. Attach a copy of a complete Birth Attendance Attestation Form found in the Doula Billing Manual found here.

(2) I attest that I have attached four letters of recommendation. Two (2) letters of recommendation MUST be from clinical providers who were the primary obstetric provider at births I have attended and two (2) letters of recommendation from previous clients.

(3) I attest that I will follow the Doula Code of Conduct (linked here). Attach a copy of this signed Code of Conduct.

(4) I attest that I have current CPR Training Credentials. Attach a copy of this certificate/card.

(5) As a doula applying for inclusion in the Colorado Medicaid Doula Benefit, I attest to having knowledge and competency in the following areas: (Please initial to indicate competency):

Enrollment and Billing

- Medicaid Enrolled Providers -Need NPI & Other Enrollment Criteria
- Submit Claims through online Portal -Billing Details (who, what, when, where, why?)
- Reimbursement or Denial -Based on accuracy of claim submission

Funding for training and troubleshooting to support providers in this process

Billing Methodology:

As a reminder, each member is eligible for up to \$1,500 per pregnancy

Physician Oversight Rule



COLORADO Department of Health Care Policy & Financing

Colorado Code of Regulations Section 8.200.2.D.1

- Physician services that may be provided by a non-physician provider when supervised by 8.200.2.D. an enrolled provider.
 - 1. With the exception of the non-physician providers described in Sections 8.200.2.A. through 8.200.2.C. and 8.200.2.D.1.a., a non-physician provider may provide covered goods and services only under the Direct Supervision of an enrolled provider who has the authority to supervise those services, according to the Colorado Department of Regulatory Agencies rules. If Colorado Department of Regulatory Agencies rules do not designate who has the authority to supervise, the non-physician provider must provide services under the Direct Supervision of an enrolled physician, with the exception of doulas.
 - Registered Nurses (RNs) are authorized to provide delegated medical services a. within their scope of practice as described in the Colorado Department of Regulatory Agencies rules under General Supervision.
