What is NEMT?

- Non-emergent medical transportation (NEMT) is transportation to and from medically necessary services covered by Health First Colorado for members who have no other means of transportation.
- NEMT can only be utilized to access non-emergency services.
- NEMT can be used for trips to Medicaid covered services at Medicaid-enrolled places of service. NEMT must be used to access the closest qualified Health First Colorado provider willing and able to treat the member.
- The appropriate mode of transportation is the least costly mode suitable to the member's condition. Mileage reimbursement is also available, and out-of-state travel when necessary and approved in advance.

NEMT Administration

- IntelliRide is the Department's NEMT broker for nine counties (Adams, Arapahoe, Boulder, Broomfield, Denver, Douglas, Jefferson, Larimer, Weld).
- As the broker, IntelliRide handles administrative functions such as mileage reimbursement; they are not a transportation provider, but they maintain a network of subcontracted providers and drivers.

How to Utilize NEMT Services

- Members in counties that do not schedule through Intelliride please visit(https://www.healthfirstcolorado.com/nemt/) to find local NEMT providers
- Members in the nine existing IntelliRide counties should call IntelliRide to schedule trips at 1-855-489-4999 or 303-398-2155 (State Relay: 711)
- Trips can also be booked online using the web chat feature at https://www.gointelliride.com/colorado. This is the recommended option to schedule rides.
- Trips must be scheduled at least 48 hours in advance.

Mileage Reimbursement


- Mileage reimbursement may be used with a personal vehicle, or a family member or friend can drive and submit the mileage for reimbursement.
- Submit mileage forms, receipts and any documentation to claims@transdev.com.
- Please include an updated mailing address and phone number when the forms are submitted.

- VERY IMPORTANT Please contact Intelliride to get an assigned trip number PRIOR to driving to the appointment.
