

Billing Family Planning Services

Billing Family Planning Services

- To indicate that a claim is for family planning purposes:
 - >CMS 1500 Professional Claims
 - Detail Level Modifier (FP or FP+32)
 - >UB-04 Facility Claims
 - Covered Codes

Purpose of the Modifiers

- FP and FP+32 modifiers used for ALL benefit plans (including members with full Medicaid coverage)
 - >Reimbursement
 - >Out of network patients
- Family Planning Expansion Benefits:
 - >Claims without the FP modifier will **not** pay for FAMPL and EMS members
 - ▶Billing guidance can be found in our Billing Manual

Family Planning Expansion Benefit Plans

Family Planning Expansion Benefit Plans

- Effective July 2022, Colorado Medicaid has two limited benefit plans that cover family planning and family planning-related services for eligible individuals who do not qualify for full Medicaid coverage
- 1. Emergency Medicaid Services (EMS/RHCP)
- 2. Family Planning Limited Benefit Plan (FAMPL)



EMS Benefit Plan

Emergency Medicaid Services & Reproductive Health Care Program



Eligibility

- ✓ Meets ALL Medicaid eligibility requirements with exception to citizenship status.
- ✓ SSN requested on application, but not needed
- ✓ No gender or age restrictions
- √ 12 months of coverage between renewals

Using/Applying for EMS coverage is not considered in public charge test LEARN MORE

Coverage

Covers:

- ✓ Emergency Services
- ✓ Family Planning Services
- √ Family Planning-Related Services

EMS BENEFIT PLAN INCLUDES

AND EMERGENCY SERVICES THERE
ARE NOT SEPARATE PLANS



FAMPL Benefit Plan

Family Planning Limited



Eligibility

- ✓ Meets ALL Medicaid eligibility requirements with exception to income.
- ✓ Income 133%-260% FPL
- ✓ Members can be presumptively eligible for coverage
- ✓ No gender or age restrictions

Coverage

This is a limited benefit that does NOT cover full Medicaid services

Covers:

- ✓ Family Planning Services
- ✓ Family Planning-Related Services

NOT Covered:

- Maternal health services, including prenatal care and labor
- Other non-family planning or related services

FQHC Billing

Due to common practices and billing procedures of Federally Qualified Health Centers and Rural Health Centers, billing guidance is slightly different.

- 1. Intent of the visit should be for family planning services.
- 2. Only covered services should have the modifiers and be on the claim.
- 3. Non-covered services should go on the cost report.

Balance Billing

- Medicaid members cannot be billed for services covered by their benefit plan
 - Informational Provider Bulletin
 - Policy Statement
 - Get help through <u>provider support page</u>
- For NON-COVERED services, members must sign a consent form agreeing to financial responsibility
- Since FAMPL/EMS are limited benefit plans, there is a wider range of non-covered services.

Consent Form

- No specific format for consent form
- Not specific to family planning services- same form your site uses for billing any Medicaid member for non-covered services.
- Needs to include:
 - 1. Lists the service to be provided and explains that the service is not covered by Medicaid
 - 2. Lists the amount due and makes it clear that, by signing, the member agrees to pay for the non-covered service, and
 - 3. Is signed and dated by the member, prior to services being rendered.

EMS Enrollment

Concern

EMS/RHCP Members being disenrolled from benefit plan after end of pregnancy

- EMS/RHCP benefit plan covers family planning and emergency services for span of 1 year
- Members should NOT need to reapply after their pregnancy ends
- If application is **not** filled out accurately, member may be ONLY covered temporarily and disenrolled after their pregnancy ends
- NOTE: This has NOT been a commonly reported issue

Solution

Application <u>MUST</u> indicate that they are applying for coverage of FP/emergency services.


