Re: Child Health Plan Plus and Medicaid Program Changes

Dear County and Medical Assistance Site Director:

The Child Health Plan Plus (CHP+) and Medicaid programs would like to inform you about the following changes in our programs:

# **CHP+ HMO Enrollments**

Effective January 1, 2013, children on CHP+ will be passively enrolled into a Health Maintenance Organization (HMO) if there is more than one HMO option in their county. Choosing an HMO will no longer occur when the family fills out the application; the HMO selection question will be removed from both the online and the paper applications.

After a child has been determined eligible for CHP+, the parent or guardian will have 90 days to change the HMO selection by calling CHP+ Customer Service at 1-800-359-1991.

### CHP+ is Expanding Eligibility to State Employees

Effective January 1, 2013, CHP+ will be expanding eligibility to children and pregnant women of State employees who have access to State of Colorado health insurance. CHP+ rules (10 CCR 2505-3 120.1.B) still require those clients who have had health insurance through their employer and their employer pays more than 50% of their premium to wait three months before being qualified for CHP+. Prenatal women and State employees applying for their children may apply after January 1, 2013.

# The CHP+ at Work Program

This program will be eliminated as of December 31, 2012. CHP+ at Work was a pilot program available to employees of Denver Health and Hospital Authority to help qualified families pay a portion of the premium for their health plan offered at work. These children and pregnant women will be able to apply for CHP+. This is a qualifying event and there is not a 3 month waiting period for them.

### **Increasing Medicaid Income Eligibility for Pregnant Women**

Effective January 1, 2013, the Medicaid income level for pregnant women will increase from 133% Federal Poverty Level (FPL) to 185% FPL. Women enrolled in the CHP+ Prenatal Care Program within this income bracket will move from CHP+ to Medicaid effective January 1, 2013. This change implements Senate Bill 11-250, which was passed as a condition of renewing the CHP+ Prenatal Care Program waiver and to comply with federal law. An automatic Mass update has been performed to move these women from CHP+ to Medicaid.

# Aligning Medicaid Eligibility for Children at 133% FPL

Effective January 1, 2013, the Medicaid income threshold for children ages 6 through 18 will be increased from 100% to 133% FPL. Children already enrolled in CHP+ and whose families have income between 100% to 133% FPL will be moved to Medicaid at Renewal, Redetermination or when eligibility is re-run due to a change in circumstance. Children in the same family may now be enrolled in the same program.
