HCPF	S9485 will not require covered diagnosis	This historically had not been highlighted in the Billing Manual, but since it is a Crisis code, it should not require a covered dx in line with our policy
HCPF	COCM codes	These are not open in Medicaid at this time. HCPF is considering these for ACC 3
HCPF	Add PT 89 RSSO to H0023 as a billing provider	This will be in the July 1 edition
HCPF	Changes to PT 89 - Title change to Community Support Services Provider (from RSSO) and adding a Specialty Type for Supportive Housing Providers	Announcement



HCPF	H0018 and H0019 removing generic coding pages	This has been an ongoing conversation to understand who is using this code (in generic form) and how appropriate it is. After researching this with the RAEs and provider (specifically CMHCs), and in light of changes happening with Comprehensive providers, (where residential services are not part of CNSP scope of work). It was clear that providers needed to enroll residential programs under their own provider types and use the respective residential codes. We can modify service descriptions on H0019 + HB to ensure this page aligns to more general Adult MH Residential services. For 7/1/2024 will delete generic coding pages.

HCPF	Review IOP/PHP coding pages for both MH and SUD, especially H0016	Adding Rev code language to IOP/PHP codes. Rev codes 912 or 913 (different intensity and time). COA has different rates for these codes. Michelle T will reach out to other RAEs  PT 64 and 78 as only billing providers - for SUD IOP/PHP  POS - asked for recommendations on appropriate POS
HCPF	Review coding pages for H0043 and H0044 Supportive Housing services	New Specialty Type under PT 89 is being created and will be added to the page.
HCPF	Changes to SUD and Mental Health covered diagnosis	Reviewed gap dx list and agreed to add new SUD and MH dx as covered under the RAEs. Covering all SUD dx now. Will add a new list of SDOH diagnoses to address SB23-174. Committee asked for a list of newly added dx. John will send out.
