- Memo provides guidance on the requirement to end date the pregnancy records.
- End dating open pregnancy record timely ensures pregnant members receiving MA receive correct:
 - □ 12-month postpartum benefit
 - □ co-pay exemptions
- Memo recommends sites to develop a process to ensure pregnancy records are end dated

Desk Review Memo Feedback

Added to the purpose: "The purpose of the Administration of Medical Assistance Desk Reviews Operational Memo is to inform county departments of human/social services, Medical Assistance and Eligibility Application Partner sites (herein referenced as "Eligibility Sites") of the process to initiate and complete Medical Assistance Desk Reviews. Desk Reviews of Eligibility Sites ensure compliance with federal and state statute, HCPF rules, and sub-regulatory guidance. The purpose of these reviews is to evaluate and assess actions, policies and/or procedures of Eligibility Sites and for any instances of noncompliance to be addressed. This allows for improvements to be found and addressed locally prior to future audit findings."

Clarification on Desk Review Timelines - Adding examples of Expedited and Urgent Desk Reviews

- Expedited Desk Review is initiated in response to an issue, concern, escalation or non-compliance issue raised to HCPF
- Urgent Desk Review process is for compliance issues that directly affect member access to care
- Where able, HCPF will work with counties on timelines during the review process

| Component | RY 2023 Sample Size | Improper Payment Rate Estimate | Lower Confidence Interval (95%) | Upper Confidence Interval (95%) |
|--------------------------|---------------------------|---|--|--|
| Overall | 1,061 | 5.44% | 2.59% | 8.28% |
| Fee-For-Service | 610 | 3.98% | 1.97% | 5.98% |
| Managed Care | 200 | 0.00% | 0.00% | 0.00% |
| Eligibility ⁴ | 251 | 2.18% | -0.22% | 4.59% |

Table 1: Colorado RY 2023 CHIP Improper Payment Rates

| Component | RY 2023 Sample Size | Improper Payment Rate Estimate | Lower Confidence Interval (95%) | Upper Confidence Interval (95%) |
|--------------------------|---------------------------|---|--|--|
| Overall | 398 | 4.81% | 2.34% | 7.27% |
| Fee-For-Service | 185 | 3.85% | 0.70% | 6.99% |
| Managed Care | 40 | 0.00% | 0.00% | 0.00% |
| Eligibility ⁴ | 173 | 3.01% | 0.99% | 5.03% |

Colorado will not be subject to the 3% Disallowance Rule penalty (they will not be requesting clawbacks) for the RY2023 PERM Audit.
