

Background

Accountable Care Collaborative

- Delivers cost-effective, quality health care services to Colorado Medicaid members to improve the health of Coloradans.
- Coordinates regional physical and behavioral health care services to ensure member access to appropriate care.
- Currently made up of **7 Regional Accountable Entities (RAEs)**

Current RAE Map (Phase II)



- Region 1 ■ Rocky Mountain Health Plans
- Region 2 ■ Northeast Health Partners
- Region 3 ■ Colorado Access
- Region 4 ■ Health Colorado, Inc.
- Region 5 ■ Colorado Access
- Region 6 ■ Colorado Community Health Alliance
- Region 7 ■ Colorado Community Health Alliance



Regional Accountable Entities

- In current phase (Phase II):
 - 7 RAEs operated by 5 organizations
- RAE contracts expire June 30, 2025
- Phase III (new contracts) begins July 1, 2025
- Current stakeholder engagement:
 - What should be the function and responsibilities of the RAEs in Phase III?
 - What should the RAE map look like?

What should the RAE map look like?

- Based on feedback received to date:
 - Stakeholders would like to see the ACC system and structure simplified.
 - Stakeholders felt 3 total RAEs were too few.
 - Specific counties had strong preferences for regional placement.

Behavioral Health Administrative Services

Why BHASOs

- Behavioral health services
- Contracting efficiency
- Interface and align services with HCPF's Managed Care Entities (RAEs)

BHASO Role

- Connect people to care and ensure timely access to services
- Provide a continuum of safety net service
- Receive feedback from communities and make system / service adjustments


BHASO Timeline

Current Proposal

Four-Region Proposal for Regional Accountable Entities



Factors Considered

- Stakeholder feedback
- Geography/number of counties
- Population size & demographics
- Behavioral health needs
- Continuum of behavioral health services
- Medicaid utilization patterns
 - Utilization in member's home county vs adjacent counties
 - Continuity from Phase II to Phase III
- Provider networks
- County identity

What is NOT changing from Phase II?


- **Members** can still see any Medicaid provider statewide for physical health.
- **Members** can still seek behavioral health services outside their region, as RAEs will be required to maintain a statewide BH network.
- **Members** can still seek emergency or crisis services with their nearest provider.
- **RAEs** will still be required to maintain a local focus.

What is changing from Phase II?

- **Providers** will contract with fewer entities.
- **Members** may be assigned to a different RAE.
 - Members receiving care coordination from a RAE may receive different referrals for health-related social needs services if the RAE region changes.

May Renewals, Initial Data Review

May Data: A Snapshot from 6/26



- First month of regular renewals - too early for trends
- Members have additional 90 days to return packets
- May data pulled on June 26 matches pre-pandemic rates:
 - 56% renewed - estimated 57% pre-pandemic
 - 42% disenrolled - 41% pre-pandemic
 - Of those disenrolled, procedural denials were 26% - 12% pre-pandemic

Only 3% voluntarily disenrolled - should be higher given our outstanding unemployment rate

Monitoring Performance through Continuous Coverage

- Through the MAP Dashboard data validation pause, HCPF continues to monitor performance on applications and redeterminations, as well as call center average speed to answer (ASA)
- HCPF will review state performance data and may outreach to counties to offer support
- If your county needs assistance, remember -
 - The Overflow Processing Center is available to assist
 - Additional funding and resources can be requested through the county's PHE Staffing Plan or the County Grant Program

Applications Performance Monitoring

What are we seeing in our review of state *applications* performance data from May?

Applications that are pending Exceeding Processing Guidelines (EPG) seem to be trending down from March to May - great work!

A few counties are struggling with timeliness; if your county is below 90%, we may reach out to see if you need help.

Renewal Performance Monitoring

What are we seeing in our review of state *renewals* performance data from May?

Renewals that are past their RRR due date (that have been initiated in CBMS) are trending higher, though not to an unmanageable level. HCPF is here to support counties on renewals so we mitigate losses in coverage for procedural reasons.

HCPF may outreach to counties where data demonstrates the county's past due renewals are approaching unmanageable levels.



[HCPF OM 23-042](#) includes county allocations for PHE county administration funding; these funds must be spent by June 30, 2024

Targeted grant funding will be available throughout FY 2023-24 for:

- PHE Staff Retention: payments to term-limited staff to remain through June 2024
- Continuous Coverage Support: projects that support timely and accurate processing of renewals through the end of Continuous Coverage
