Vision

Build a system of care that is family-centered, trauma-informed and complete across the continuum for children, youth, families and caregivers that recognizes the distinct needs of this population--from identification of need to treatment.

Payment strategies inadequately supporting services

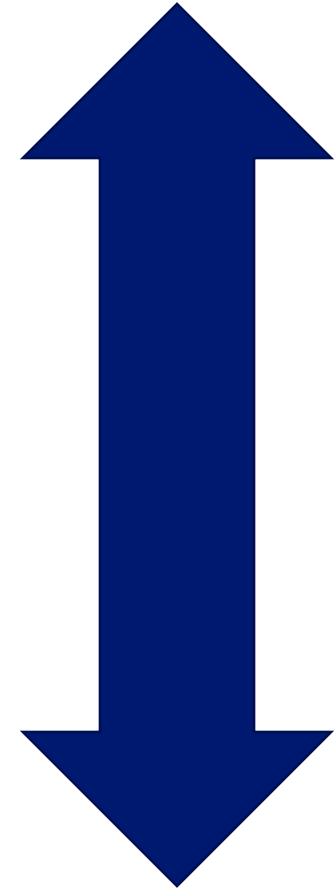
Administrative burden [families + providers]

Inconsistent care coordination across systems

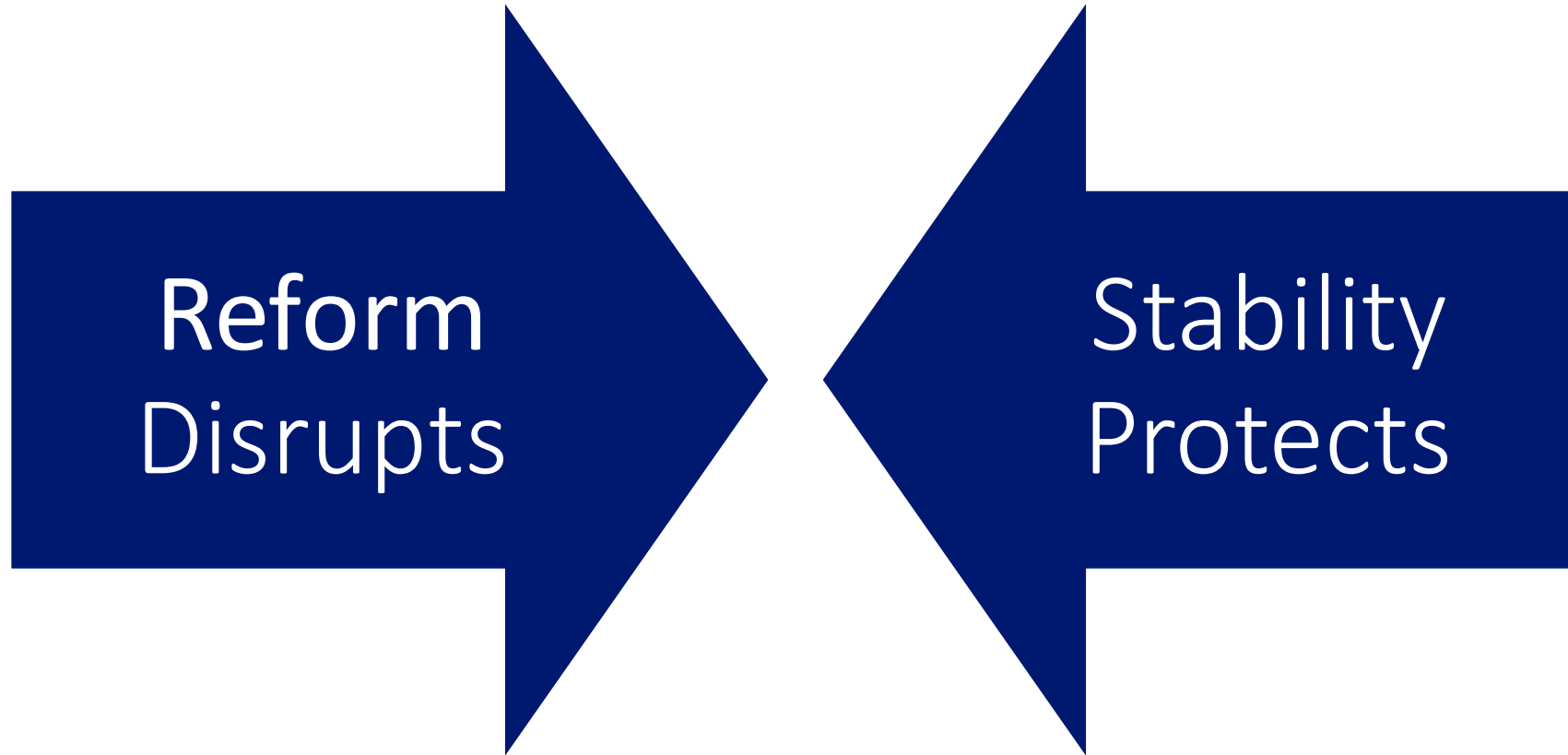
Silos within the health care system

Completing the Continuum of Care

- Develop a **Standardized Child Benefit** to address different needs at different levels of complexity
 - Example: [Texas Resilience and Recovery](#) model
- Addresses goals for Phase III through **simplifying systems**
 - Improves quality of care for members
 - Close health disparities
 - Reduce regional variability, improve consistency and accountability
 - Improve care access
 - Identify missing and available services
 - Improve member and provider experience
 - Manage costs

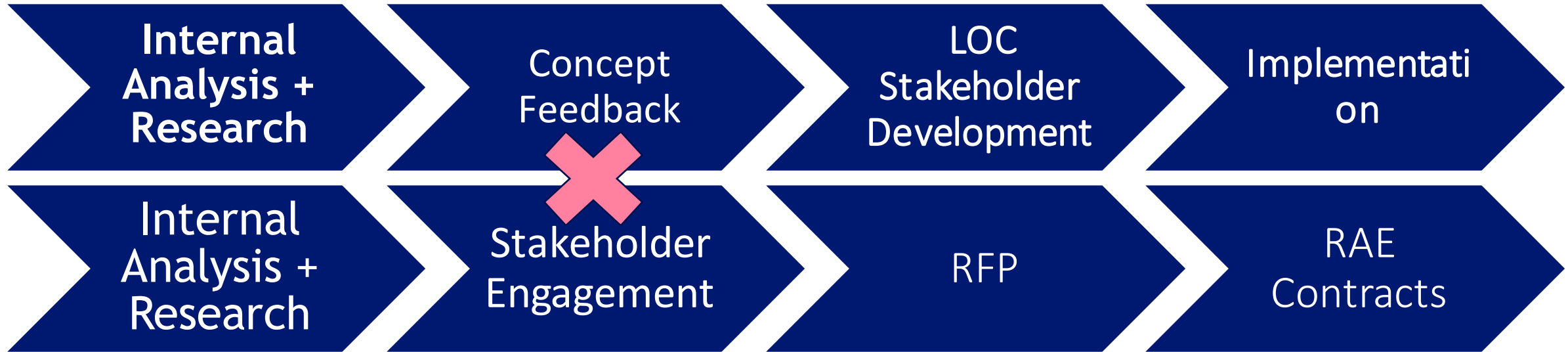
