### 1. Instructions for Using the Network Adequacy Quarterly Report Template

This document contains the March 2023 release of a standardized template for use by all Colorado Medicaid or CHP+ Managed Care Entities (MCEs) for quarterly Network Adequacy (NA) reporting to the Colorado Department of Health Care Policy and Financing (HCPF). Each MCE should generate one quarterly NA report for each applicable line of business (i.e., CHP+ MCO, Medicaid MCO, or RAE); the report shall contain template elements applicable to the line of business. Network categories required for quarterly reporting are defined in the CO Network Adequacy Crosswalk Definitions (December 2022 version).

The practitioners, practice sites, and entities included in the quarterly NA report will include ordering, referring, and servicing contractors that provide care through a Colorado Medicaid or CHP+ MCE. To ensure consistent data collection across MCEs, each MCE must use this HCPF-approved report template (MS Word and MS Excel templates) to present the MCE's quarterly NA report and data for the corresponding practitioners, practice sites, and entities. ### 2. Network Adequacy

### **Establishing and Maintaining the MCE Network**

#### CHP+ MCO, Medicaid MCO, RAE

There are no material changes in the size of our networks since the last reporting period. Rocky Mountain Health Plans (RMHP) provides an inclusive network of Primary Care Medical Providers (PCMPs) in the Regional Accountable Entity (RAE) service area, with 192 PCMP service locations and a tiered structure for Per Member Per Month (PMPM) administrative payments and Key Performance Indicator (KPI) incentive payments. The structure ranges from Tier 1 practices that are open to all Medicaid Members and have accomplished the highest demonstrated practice transformation competencies through Tier 4 practices that meet minimum participation requirements. 41.67% of all practice sites are currently participating at Tier 1 or Tier 2.

RMHP met the time and distance requirements, ensuring accessibility and Member choice to primary care and family planning services, for the majority of network categories in the 14 rural and 8 frontier counties of RAE Region 1. The *Adult Primary Care Practitioner (PA)* and *Family Practitioner (PA)* time/distance standards were not met in Moffat County.

RMHP continues to offer RAE, Prime and CHP+ Members access to CirrusMD for RMHP. This is a free, text-based platform which allows Members to connect with providers 24/7 if they have a health question or if they are not sure if they should go to an urgent care or emergency room.

Prior to FY 22/23 Q3, RMHP was able to track utilization by line of business. However, as of January 1, 2023, there were changes to the eligibility files. As a result, RMHP can continue to track *CirrusMD for RMHP* registrations and encounters but can no longer track utilization beyond a broad Medicaid category. In FY 22/23 Q3 there were 122 unique Member registrations and 151 CirrusMD encounters. This is down from 260 unique Member registrations and 264 CirrusMD encounters in FY 22/23 Q2. RMHP is planning on aligning CirrusMD marketing strategy with UHC and anticipates an increase in encounters and registrations in future quarter's reporting.

RMHP and CirrusMD have a workflow by which CirrusMD providers make referrals to RMHP Care Coordinators when Members have follow-up needs, such as finding a primary care provider. The number of referrals from CirrusMD providers to RMHP care coordinators remained the same from last quarter to this quarter.

#### CHP+ MCO, Medicaid MCO, RAE

Rocky Mountain Health Plans provides a robust network of behavioral health providers to our RAE Membership. RMHP is always open to expanding the network by enrolling new Behavioral Health and SUD providers as they meet our credentialing and contract requirements.

RMHP continues to expand our behavioral health and SUD network. In addition to contracting efforts, RMHP's Care Coordination and Utilization Management teams maintain relationships with SUD providers statewide to find patients the appropriate ASAM level of care when needed.

RMHP met the time and distance requirements, ensuring accessibility and Member choice to behavioral health services, for the majority of network categories in the 14 *rural* and 8 *frontier* counties of RAE Region 1. Most identified deficiencies are within the *SUD treatment facility* network category across all ASAM levels. RMHP contracts with all SUD facilities within RAE Region 1. RAE Region 1 is comprised solely of *rural* and *frontier* counties, all of which fall within the geographic designation for Mental Health Professional Shortage Areas (HPSAs). Please refer to Appendix B for information regarding changes to Geoaccess reporting.

Overall behavioral health claims for RAE Members increased by 20% from last quarter, however telehealth claims decreased by .089% as compared to last quarter (as percentage of all claims). Telehealth services represented 37.68% of claims this quarter, as compared to 38.02% of overall behavioral health claims last quarter.

RMHP Provider Network Management (PNM) staff distributes Appointment Wait Time Surveys to a sample of Members throughout all lines of business who received services from primary care practitioners, high-volume specialists, high-impact specialists, and prescribing as well as non – prescribing behavioral healthcare practitioners on a quarterly basis. The purpose of these surveys is to determine if appointment availability is sufficient for Members based on performance standards defined by the Division of Insurance (DOI), Colorado Department of Health Care Policy and Financing (HCPF), as well as the National Committee for Quality Assurance (NCQA).

RMHP continued to utilize Qualtrics as an electronic method of distributing surveys quarterly during the second quarter of FY22-23. Surveys were sent out in January 2023 with response data being received in February 2023. Statistically valid Member distribution sample size is generated by using claim data reports to first determine the total number of Members who saw each practitioner type. Duplicate and deceased Members, as well as any Members who previously received a survey the quarter prior, are excluded from the total numbers. Once the Members have been identified, sample sizes are determined using a survey sample size calculator with a margin of error of 5% and a confidence level of 95%. In 2022, RMHP began increasing the sample size by an additional 50%, in an effort to improve the number of respondents. FY23 Q2 continued to have a low response rate of 3% overall. The greatest number of responses was seen in the High – Impact specialist category with Members completing the survey, followed by Specialty High – Volume with responses. There were Member responses in the Behavioral health prescribing category and only Behavioral Health non – prescribing. Members who saw a Primary Care Practitioner produced responses in FY23 Q2. It should be noted that although the greatest number of responses came from the High – Impact Specialty category, the largest percentage of response from Members to surveys sent was seen in the Behavioral Health prescribing category with a 5% response rate.

RMHP has continued to work through the barriers associated with the low response rates. Discussions of modifying the survey process to a vendor level with the help from Cotiviti (previously Eliza) have been taking place since early 2023. Weekly meetings with Cotiviti began in March 2023 with input from multiple teams across the organization to revise the survey questions to be more accurate to the services rendered to the Membership. The decision has also been made to survey all Members who receive care from a Primary Care Practitioner, High Volume or High Impact Specialist as well as Prescribing and Non-Prescribing Behavioral Healthcare Practitioner and have valid email addresses on file. This process has an estimated target date to begin in FY23 Q4.



RMHP will continue to implement the following changes to the Survey process:

- RMHP to finalize elements associated with the vendor survey process with a target date of implementation of FY23 Q4 as outlined below.
- Beginning in Q4 of FY23 we will survey <u>all</u> members that had an appointment in the previous month via an Interactive Voice Response (IVR) survey on their experience of getting needed care quickly.
- A newly identified vendor partner, Cotiviti, will conduct the survey and report all metrics on our behalf
- RMHP will conduct the survey monthly for 6-months, at which time we will analyze data to ensure that surveying is taking place at the right cadence as well as evaluating membership sample size. RMHP will adjust this accordingly based on analysis findings.
- The survey will be brief, 3-5 questions and after each completed survey, the Member will receive a \$10 gift card. Note, only Medicaid and CHP+ Members are eligible for the gift card incentive.
- The data will also support our network development plan, provider education and training and will inform RMHP of how well the network is responding to Members' access to care needs.

### 5. Time and Distance Standards

#### **Health Care Network Time and Distance Standards**

<u>Supporting contract reference:</u> The MCE shall ensure that its network has a sufficient number of practitioners, practice sites, and entities who generate billable services within their zip code or within the maximum distance for their county classification. The MCE must use GeoAccess or a comparable service to measure the travel time and driving distance between where members live and the physical location of the practitioners/practice sites/entities in the MCE's Region.

- CHP+ MCO defines "child members" as 0 through the month in which the member turns 19 years of age.
- CHP+ MCO defines "adult members" as those over 19 years of age (beginning the month after the member turned 19 years of age).
- Medicaid MCO and RAE define "child members" as under 21 years of age.
- Medicaid MCOs and RAEs define "adult members" as those 21 years of age or over.

There are two levels of primary care practitioners: primary practitioners that can bill as individuals (e.g., MDs, DOs, NPs, and CNS') and mid-level practitioners that cannot bill as individuals (e.g., PAs); each type of practitioner has its own row in the MS Excel template tabs for time/distance reporting.

A practitioner/practice site/entity should only be counted one time in the MCE's data submission for each associated network category (PROVCAT code). If a practitioner provides primary care for adult and pediatric members at a specific location, count the practitioner once under the Adult Primary Care Practitioner PROVCAT code, once under the Pediatric Primary Care Practitioner PROVCAT code. For example, a primary care nurse practitioner (NP) that serves adult and pediatric members can be categorized with the PV063, PV064, and PV065 PROVCAT codes. That practitioner will then be counted for the minimum network standards for pediatric primary care practitioner (NP) (PV064 and PV065); adult primary care practitioner (NP) (PV063 and PV064); and family practitioner (NP) (PV064).

RMHP's service area counties are all designated as *rural* or *frontier*, however; RMHP has Region 1 attributed Members residing in some urban counties such as in the Denver Metro area. RMHP contracts with numerous providers in those areas although they may not cover all services. RMHP enters into single case agreements with providers in these areas when needed.

Time/distance deficiencies in one or more network categories exist in several counties, which is a function of provider availability in rural and frontier areas. For example, SUD treatment facilities and psychiatric hospitals are limited, despite the inclusion of all active practices and facilities in our networks for the entire geography of Region 1.

RMHP's Care Coordination team assists Members who need a particular service that may not be available in their community. Care Coordinators work with participating providers in nearby communities to facilitate appointment scheduling, as well as transportation.

RMHP continues to offer RAE, PRIME and CHP+ Members access to CirrusMD for RMHP. This is a free, text-based platform which allows Members to connect with providers 24/7 if they have a health question or if they are not sure if they should go to an urgent care or emergency room.

Time/distance deficiencies in one or more network categories exist in numerous counties. In many cases this is a function of care being consolidated in one location within a county and in others cases the pattern of care is to travel to neighboring communities for care.

RMHP's Care Coordination team assists Members who need a particular service that may not be available in their community. Care Coordinators work with participating providers in nearby communities to facilitate appointment scheduling, as well as transportation.

RMHP continues to offer RAE, PRIME and CHP+ Members access to CirrusMD for RMHP. This is a free, text-based platform which allows Members to connect with providers 24/7 if they have a health question or if they are not sure if they should go to an urgent care or emergency room.

RMHP uses SCAs for specific Member needs such as specialized care (in or outside the region) or special circumstance (e.g., hardships around transportation or travel or an existing relationship with a provider who is not in the network).

To Medicaid and CHP+ Stakeholders,

In January of 2023, Rocky Mountain Health Plans (RMHP), A UnitedHealthcare Company (UHC), integrated key technology systems to improve efficiency and accuracy of our operational processes. As a part of this transition, we are now able to leverage UHC licenses for Quest Analytics to produce more accurate network adequacy reports. The UHC license agreement includes two functions that were not previously available to RMHP.

- 1. <u>Counting Providers in Neighboring Counties:</u> The old license (used to produce reports through December 2022) only counted providers that were located within a county when determining if minimum provider count requirements where met. In contrast, the new license counts both providers in each county as well as providers in neighboring counties (if those neighboring providers are within the required time and distance standards).
- 2. Address Clean Up Algorithm: Quest Analytics conducts geo-coding (a process that crosswalks an address to a specific latitude and/or longitude). When there address in-accuracies are present in raw address data, the geo-coding software may not be able to match an address to a specific latitude and longitude (this is true of all geo-coding software). In these instances, Quest Analytics will distribute those addresses within the zip code's geography. Within our new licensing, we have technology that allows us to clean up addresses' errors prior to geo-coding, which means that more addresses are mapped "completely." Our new technology allows us to completely geo-code 97.4% of provider and Member addresses (up from 96.5% with old previous technology.

These technology and licensing change allows RMHP to report network adequacy data more accurately. These changes to improve the accuracy of reporting has resulted in changes in which county and specialty combinations meet or do not meet network adequacy (between the report submitted for State Fiscal Year 2023 Quarter 2 vs Quarter 3). These changes result from more accurate reporting methods (and not changes within our network). These changes are summarized below.
