Featured Announcement

Public Comment: Medicaid Statewide Managed Care System

The Department of Health Care Policy & Financing has opened a 30-day public comment period to collect feedback on the revised Medicaid Statewide Managed Care System rule. The comment period will run from Oct. 25, 2021 through Nov. 24, 2021. Existing rules regarding Medicaid managed care programs have been revised to reflect the changes for Phase II of the Accountable Care Collaborative.

The purpose of the rule changes is to align the language and policies with the following:

- C.R.S. 25.5-5 Part 4 describing the Statewide Managed Care System
- The Department's 1915(b) waiver with the Centers for Medicare and Medicaid Services authorizing the ACC
- Federally approved contracts with the RAEs and Managed Care Organizations (MCOs).

A brief overview of primary changes to the existing rule include the following:

• Language and terminology have been aligned with that in C.R.S. 25.5-5 Part 4 on

the Statewide Managed Care System

- Current Section 8.212 on the Community Behavioral Health System has been integrated into Section 8.205
- New sections were added
 - The 8.205.1 Definitions section has been added for clarity and consistency.
 - The 8.205.10 Utilization Management section has been added to reflect federal requirements and comply with C.R.S. 25.5-5-402 (15)
- Changes were made to reflect current policy
 - Enrollment is mandatory into the Statewide Managed Care System
 - Client eligibility
 - Clients/members can no longer opt out of the Statewide Managed Care System
 - There are new covered services for the inpatient and residential substance use disorder benefit
- Other modifications

RAE Practice Support Plans Posted

RAE Practice Support Plans for the 2021-2022 state fiscal year have been posted for each RAE on the <u>ACC Deliverables webpage</u>. Maternity Report Released

Health First Colorado is a key player in the lives of both expectant parents and their children as it is the primary insurer for more than 40% of births in the state. The program covered the delivery of nearly 27,000 births in 2019 and provided prenatal care, delivery, and postnatal services to expectant parents in 63 of Colorado's 64 counties.

HCPF American Rescue Plan Act (ARPA) funding

The Department has received approval from the Centers for Medicaid and Medicare Services (CMS) and the Colorado Joint Budget Committee (JBC) to use \$530 million from the American Rescue Plan Act (ARPA) to implement initiatives to enhance, expand, and strengthen Home and Community-Based Services (HCBS) in Colorado over the next three years.

The <u>Department's plan</u> categorizes these 72 funded initiatives into eight focus areas as prioritized by our stakeholders:

- Strengthen the Workforce & Enhance Rural Sustainability
- Improve Crisis & Acute Services
- Improve Access to HCBS For Underserved Populations
- Support Post-COVID Recovery & HCBS Innovation
- Strengthen Case Management Redesign
- Invest in Tools & Technology
- Expand Emergency Preparedness
- Enhance Quality Outcomes
