Accountable Care Collaborative (ACC)

- Colorado decides how to implement Federal Medicaid guidelines and rules.
- The ACC is the program design and structure that Colorado created to administer Medicaid to Health First Colorado, CHP+ members.
- Members and their primary care providers belong to Regional Accountable Entities (RAE) within the ACC that helps them get the health care and services they need.
 - We refer to RAEs as "regional organizations" in member communications.

How Regional Accountable Entities Help Members

- Coordinating care with different providers.
- Helping with referrals.
- Working with community groups for other needs (for example, food or housing).

What is Care Coordination & How Can it Help Members?

- **What is care coordination?**

- Care coordination is available to all Health First Colorado members.
- Care coordinators are an extension of your health team. They might be part of a provider office or a RAE.
- RAEs coordinate care with providers and resources to improve member health based on member goals and preferences.
- Care coordinators can also collaborate with others on a member's health team to help avoid gaps in care.

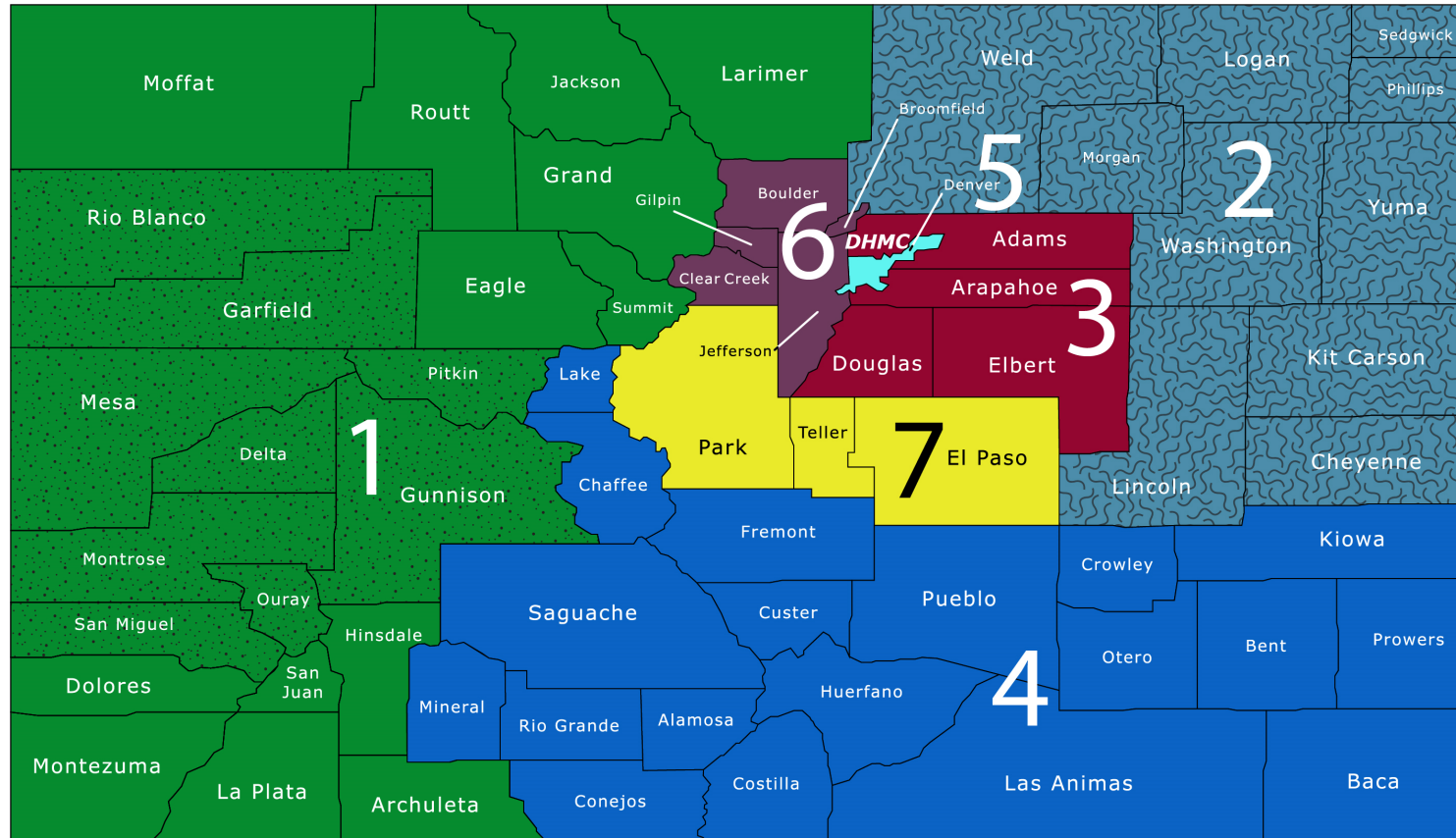
- **How can care coordination help members?**

- Increase communication between all involved in care and avoid duplication.
- Helps members understand and access their Health First Colorado benefits.

How Regional Accountable Entities Help Providers

- Contracting with and paying providers for services.
- Coordinating between different types of providers.
- Helping with paperwork, data, and other technology so that patients don't have to worry about it as much.

What is Changing?

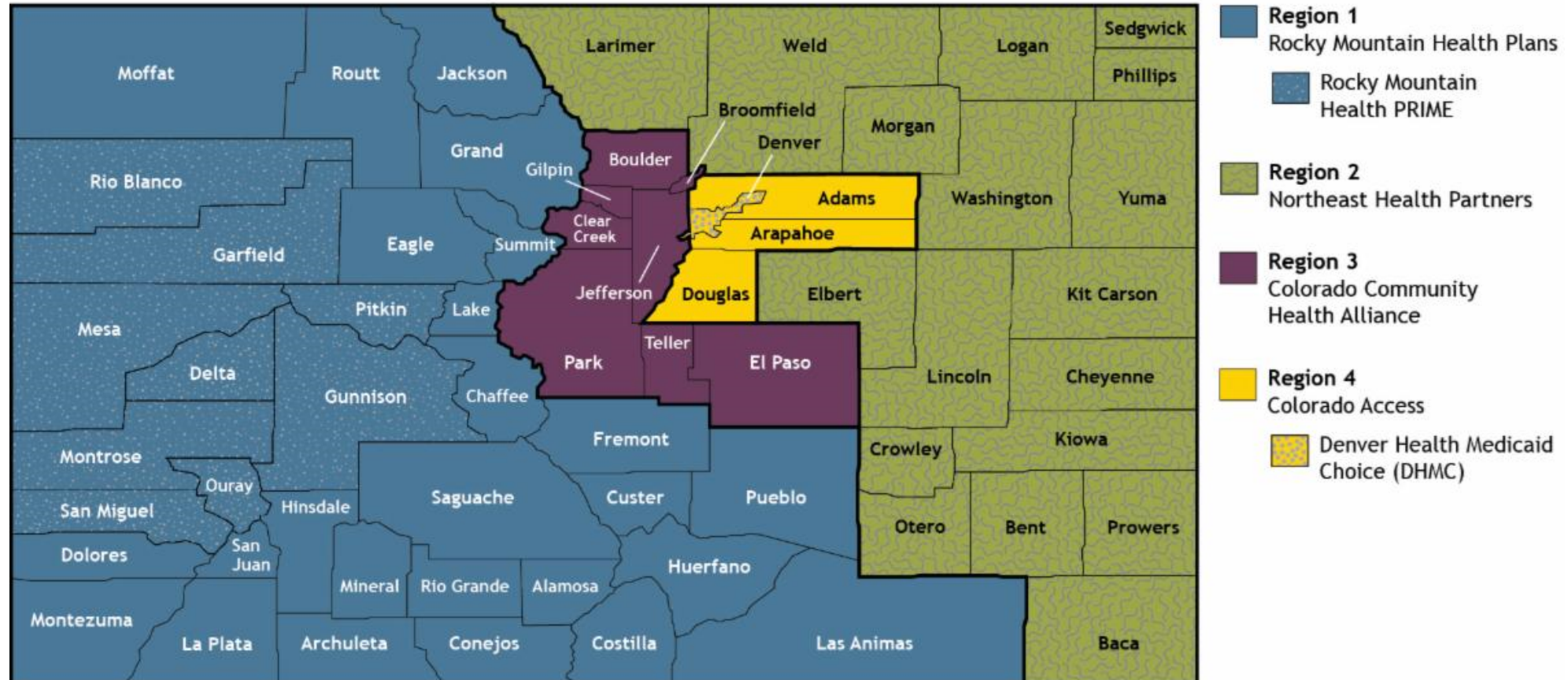
- In July 2025 the current contracts with the RAEs will end and new ones, with some changes, will begin.

1. Improve quality care for members.
2. Close health disparities and promote health equity for members.
3. Improve care access for members.
4. Improve the member and provider experience.
5. Manage costs to protect member coverage, benefits, and provider reimbursements.
