



ACC APM 1 - Measure Set Program Year 2023

Mandatory Measures: All primary care medical providers (PCMPs) must report on the three primary mandatory measures (#1-#3) listed in either the Mandatory Peds or Adults columns.

Specific to the Mandatory Peds Set: The same number appearing in the column twice indicates that a PCMP can select either mandatory measure. (Example: PCMPs can select either Adolescent Immunizations (Combo 2) OR Childhood Immunization Status (Combo 10) as the first mandatory measure).

Specific to the Mandatory Adults Set: * indicates the mandatory measure if the PCMP has a certified electronic health record (EHR). If the PCMP does not have a certified EHR, the corresponding number will serve as back-up.

Roll-in Measures: These measures serve as backup (in the order listed) in the event a PCMP cannot report on one - or all - of the primary mandatory measures.
