

Appendix G- Tariff Survey Analysis Results

Appendix G provides more detailed information on the survey sent to providers for completion regarding federal tariffs.

In May 2025, the Rates Review and Research Team received feedback from providers on the potential impact of federal tariffs on costs and the ability to provide services to Medicaid. To better understand provider experience, a short survey was sent to over 10,000 Colorado Medicaid providers via newsletter with a completion deadline of July 1, 2025.

Exactly 103 providers completed the survey during that time. The figures below detail provider feedback. In the survey, providers were asked if they received communication from suppliers regarding increased prices or reduced services. Any letters received from providers were shared with the MPRRAC. Some examples of specifics mentioned by providers were wiring, batteries, gel, foam padding, and therapy tools.

There are a few important notes about this survey. First is the high participation bias of respondents. That is, providers who have been impacted were more likely to respond to the survey. Secondly, due to resource limitation, this was not a real random survey. Its intended purpose was limited information gathering on provider experience regarding tariffs.

Have you experienced increased costs in equipment, supplies, or other materials due to federal tariffs initiated on April 2, 2025?

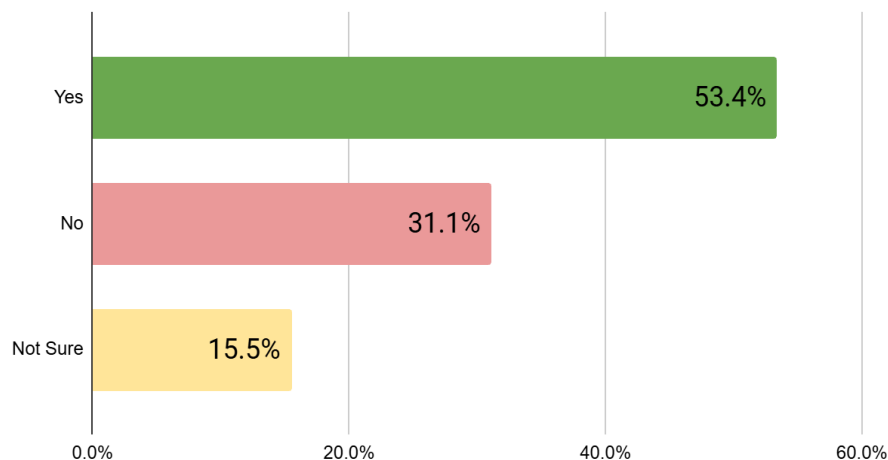

Figure 1 shows a breakdown of how many providers indicated increased costs due to tariffs. Of the 103 providers who completed the survey, 53.4% of providers indicated increased costs in equipment, supplies, and other materials due to federal tariffs.

If yes, what types of products or services have been most affected by these tariff-related cost increases?

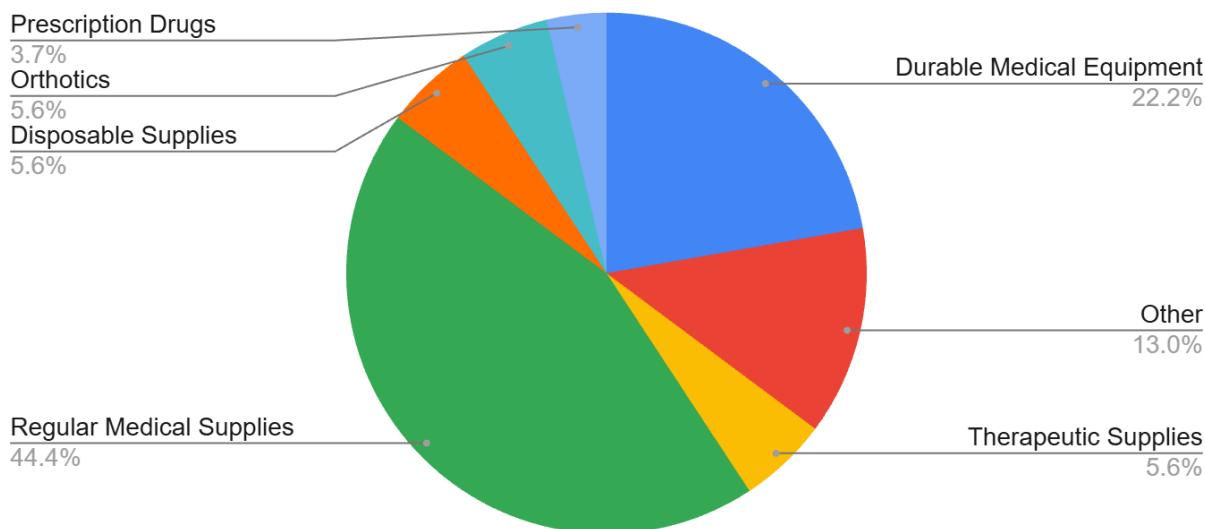

Figure 2 shows that of the providers who answered “yes”, the most indicated cost increases were on regular medical supplies including gloves, cotton swabs, and needles, and durable medical equipment.

Have these increased costs impacted your ability to provide services to Medicaid members?

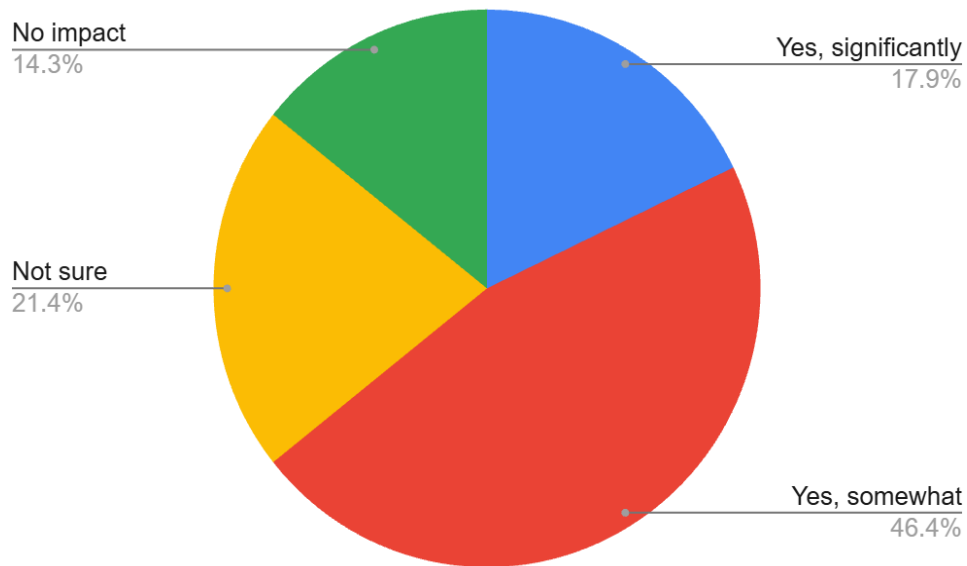

In Figure 3, of those respondent providers who answered “yes”, 17.9% indicated that the increased cost significantly impacted their ability to provide services to Medicaid members and 46.4% indicated that the increased cost somewhat impacted their ability to provide services to Medicaid members.

Have you had to change your billing practices, reduce services, or delay orders as a result of tariff-related costs?

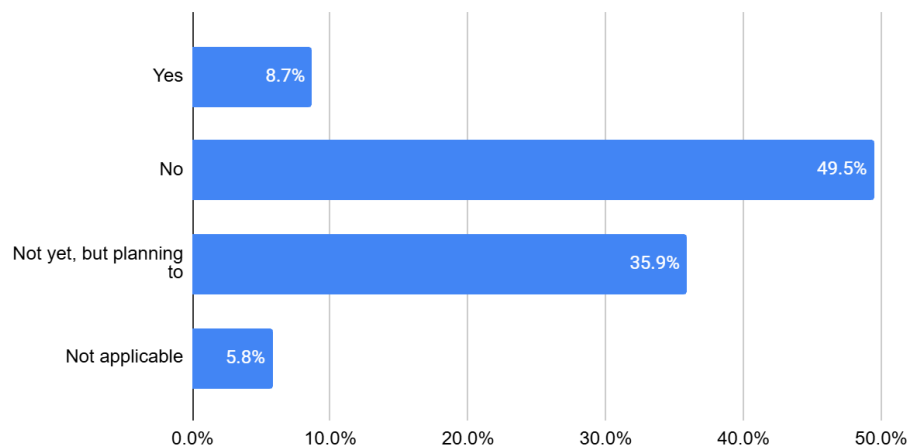

Figure 4 shows that most providers indicated that they have not had to change their billing practices or reduce services. Though 35% responded that they were planning to do so in the future. Figure 5 is the breakdown of how many providers received communication from suppliers regarding increased prices, reduced services, or delayed orders as a result of tariff-related costs. Providers who indicated “yes” were asked to share those communications with the MPRRAC.

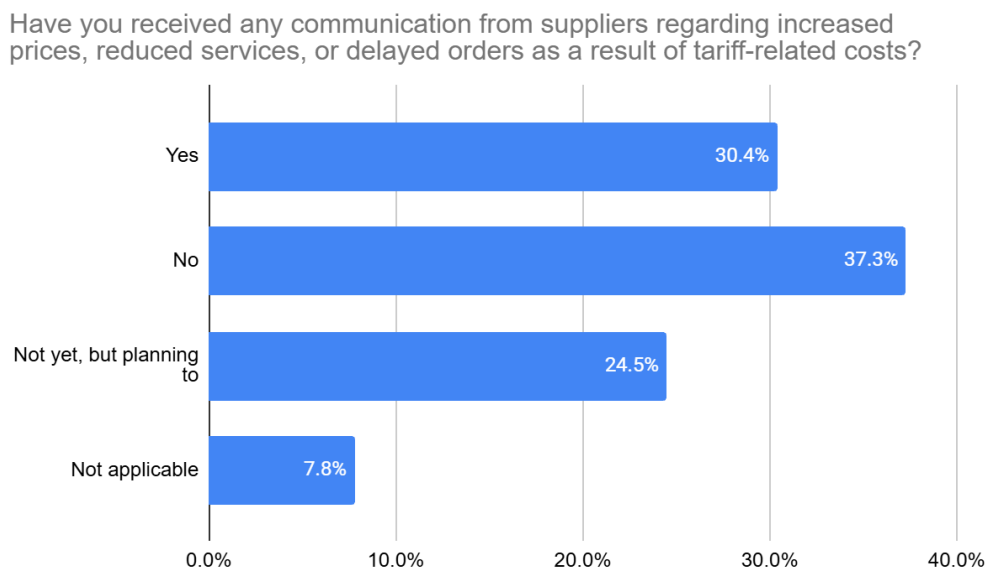

In summary, the department hoped to respond to feedback from providers expressing concern about the potential impact of federal tariffs on costs and their ability to deliver services to Medicaid members with a short survey to gather information about their concerns. This survey was distributed via newsletter to over 10,000 Colorado Medicaid providers, and 103 providers responded.

According to the survey results, 53% of respondents reported increased costs in equipment, supplies, and other materials due to federal tariffs. Among those, the most commonly affected items included regular medical supplies—such as gloves, cotton swabs, and needles—as well as durable medical equipment. Additionally, 17% of respondents stated that these cost increases significantly impacted their ability to provide Medicaid services, while 46% reported a moderate impact. Responses showed that most providers have not yet changed their billing practices or reduced services, though 35% indicated plans to do so in the future. Providers also noted receiving supplier communications about price increases or service reductions, with examples

of affected items including wiring, batteries, gel, foam padding, and therapy tools. Any such letters received were shared with the MPRRAC.

It was noted that the survey has a high participation bias, as providers who were impacted were more likely to respond. Due to resource constraints, the survey was not randomized and is intended solely to offer limited insight into provider experiences related to tariffs.

Following is the raw data received in the survey from providers. The date and time the survey was completed is listed as well as each question to the survey and the response by each participant.
