RE: Critical Incident Reporting (CIR) Change

What is changing?

On Monday, July 3, 2017, a change will be made to the way critical incidents are reported in the BUS.

Why is this change being made?

This BUS change is being made to allow the Department to address the Centers for Medicare and Medicaid Services (CMS) critical incident reporting requirements. The change is designed to help the Department meet CMS guidelines regarding timeliness of reporting critical incidents and determination of whether critical incidents reported in the BUS involved Adult Protective Services (APS) or Child Protective Services (CPS).

Add New CIRS Screen

A new question will be added to the Add New CIRS screen.

“Was APS/CPS involved in this CIR?”

This new question will appear as indicated below.

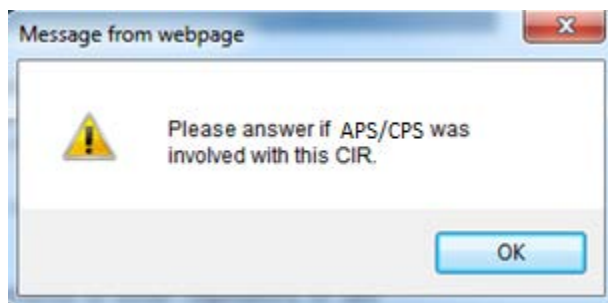

If you try to save the critical incident without answering the question, an error message will pop up as a reminder.
