- Created to ensure managed care providers can easily contact HCPF when they have specific concerns with managed care entities (ex. RAEs)



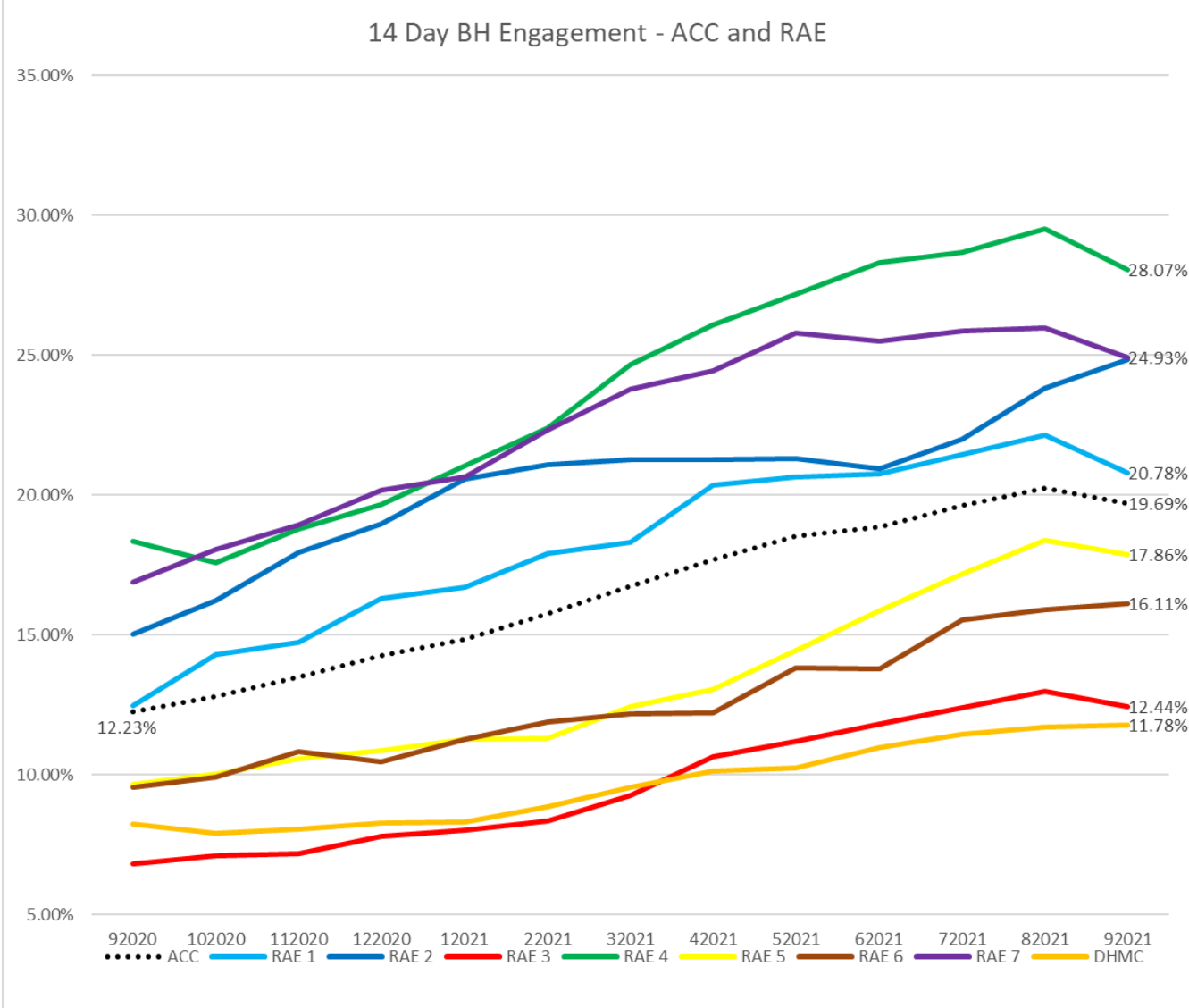
COVID-19 Updates

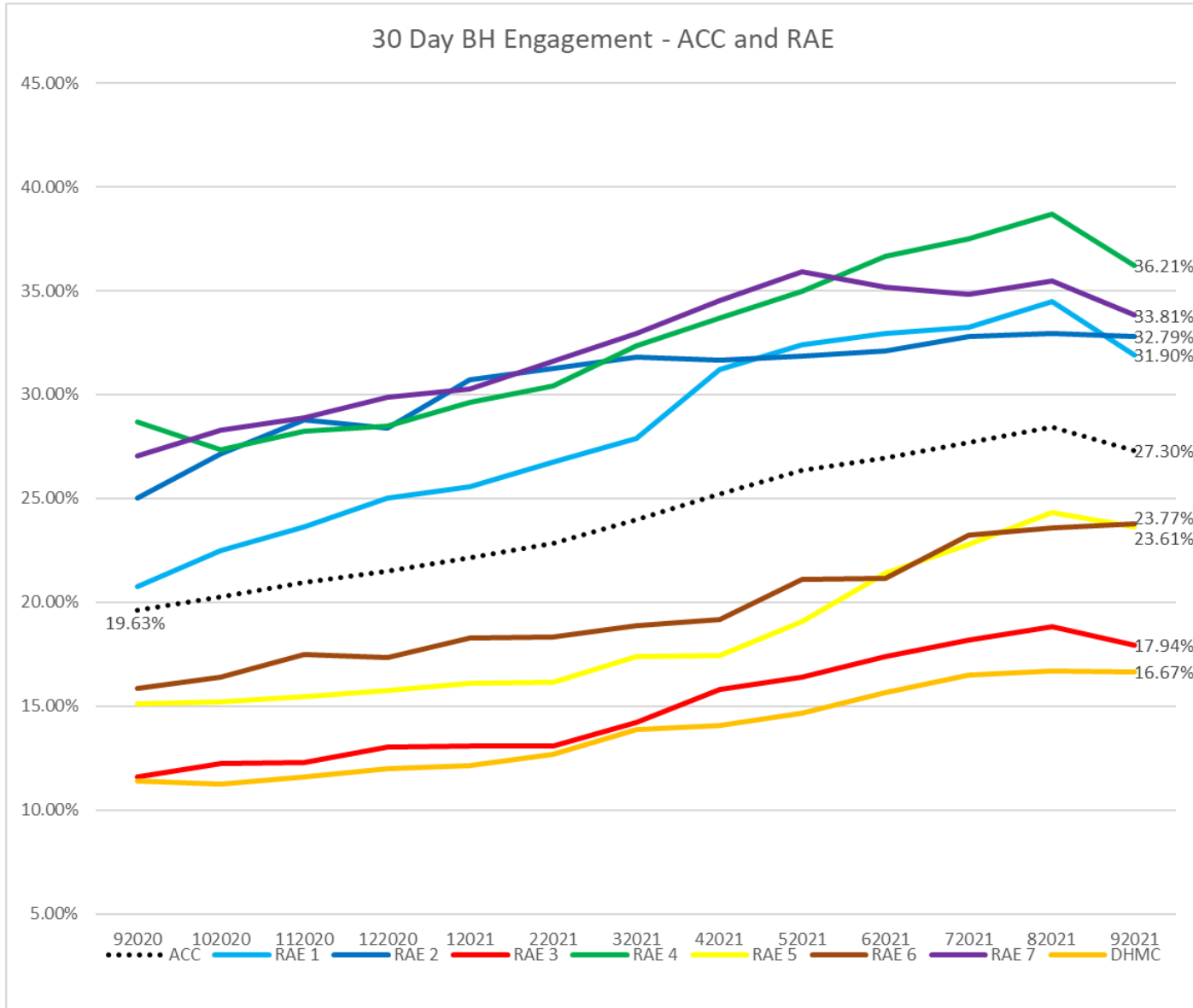


DOC Metric Review: September 2021 Data

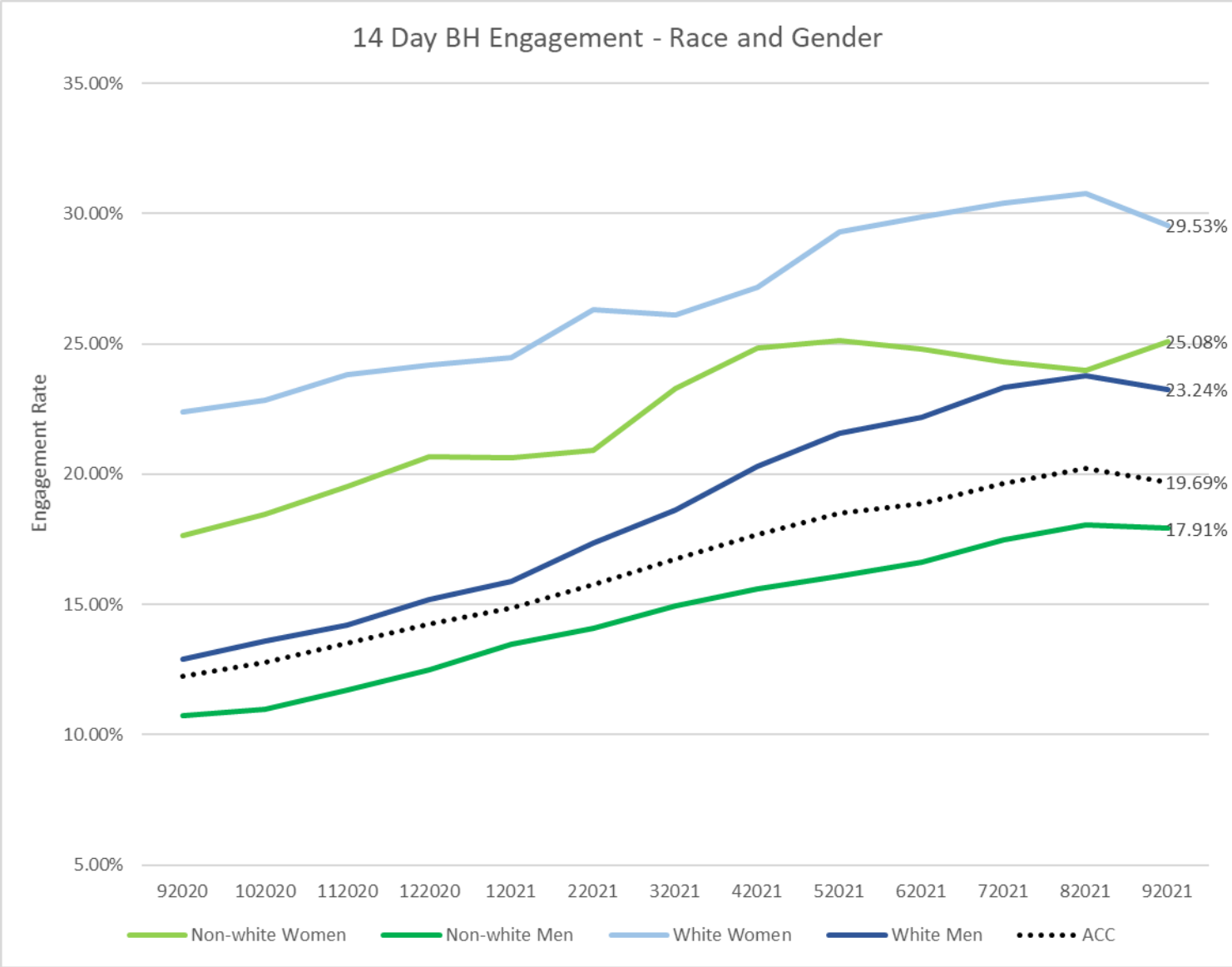
Medicaid Release Volume	Engagement Volume	Performance Rate	Target Rate	Difference (%)	Difference (Members)
5501	1083	19.69%	19.10%	0.59%	32



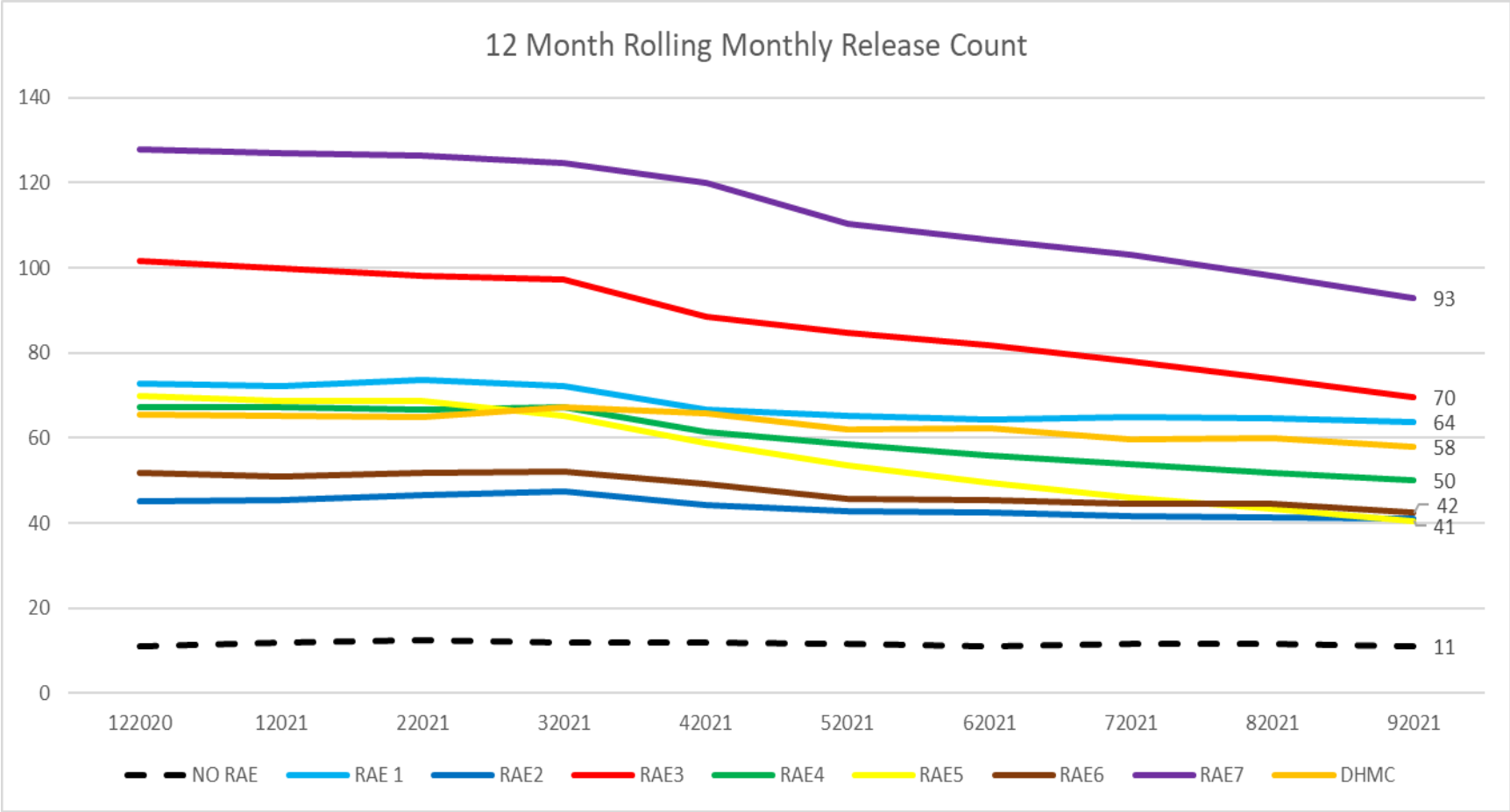
