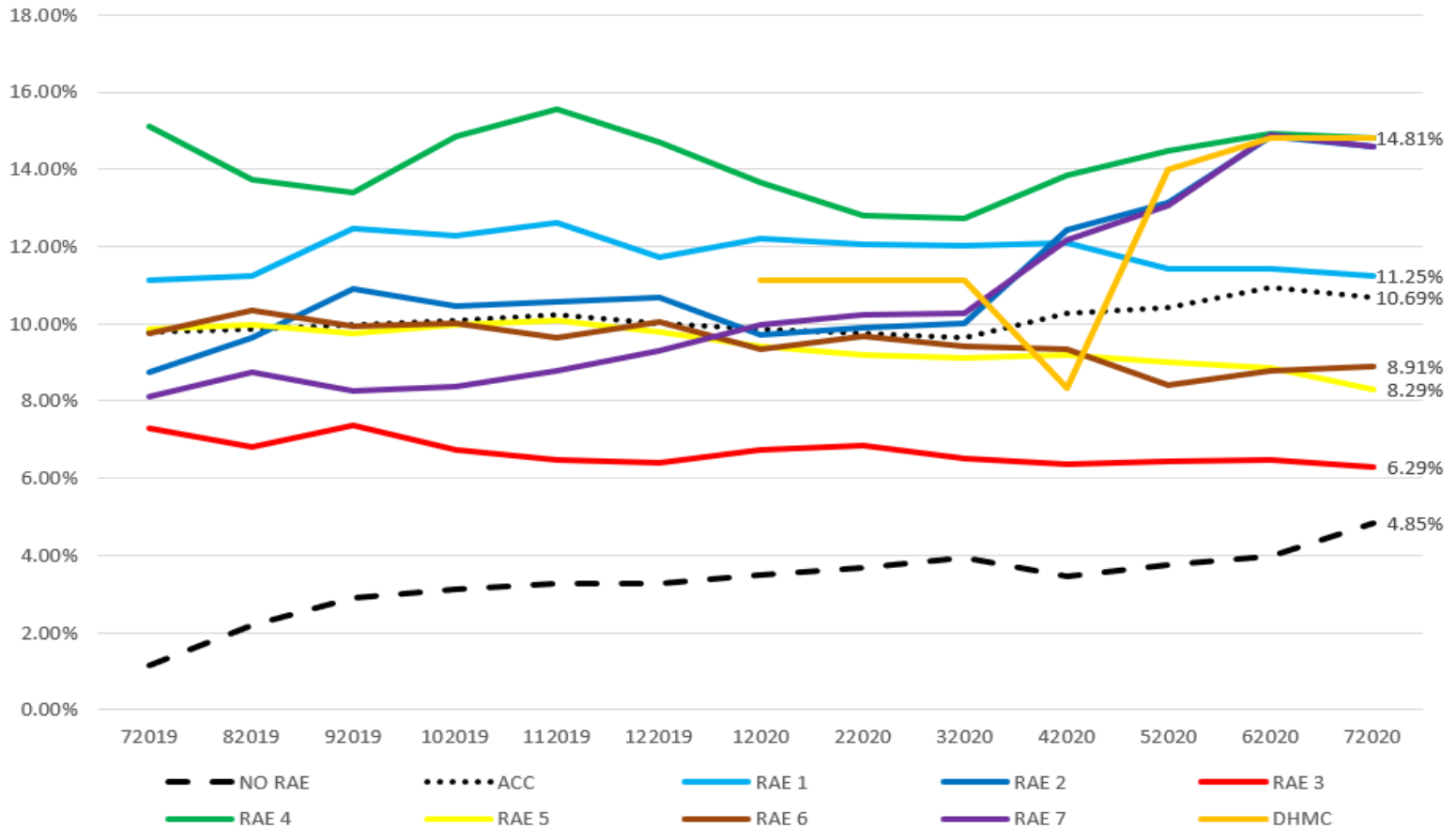

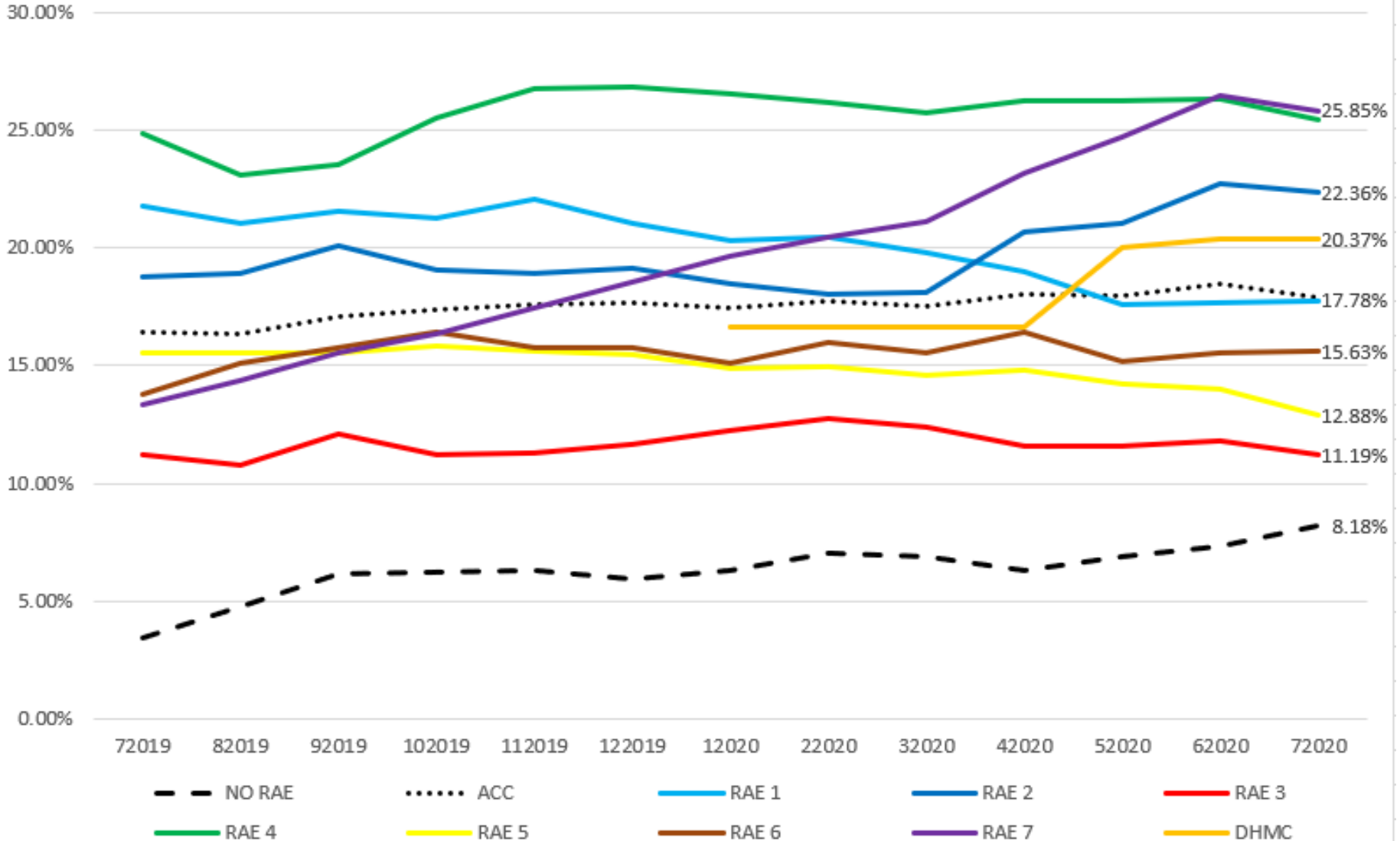

14 Day BH Engagement - ACC and RAE

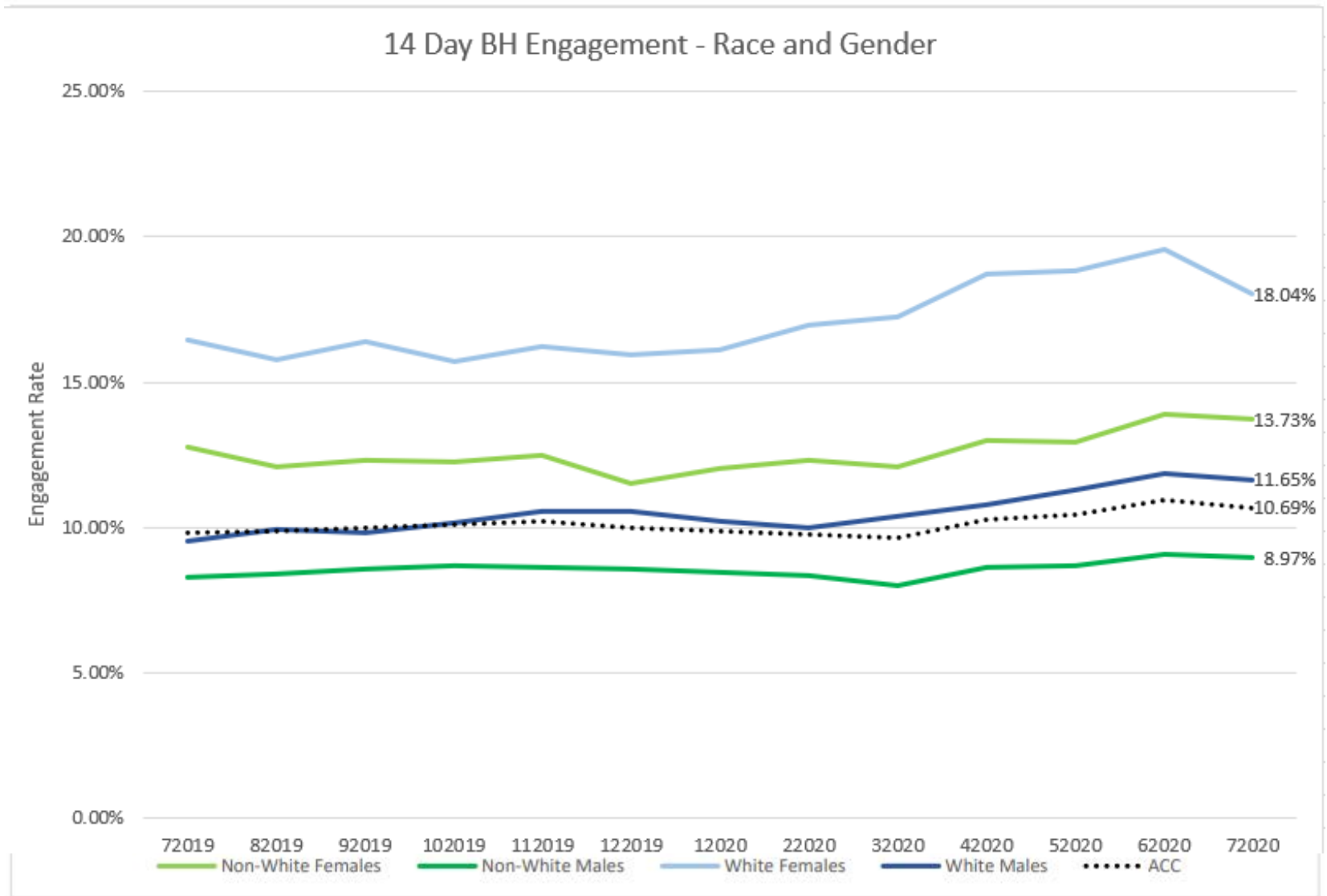

30 Day BH Engagement - ACC and RAE

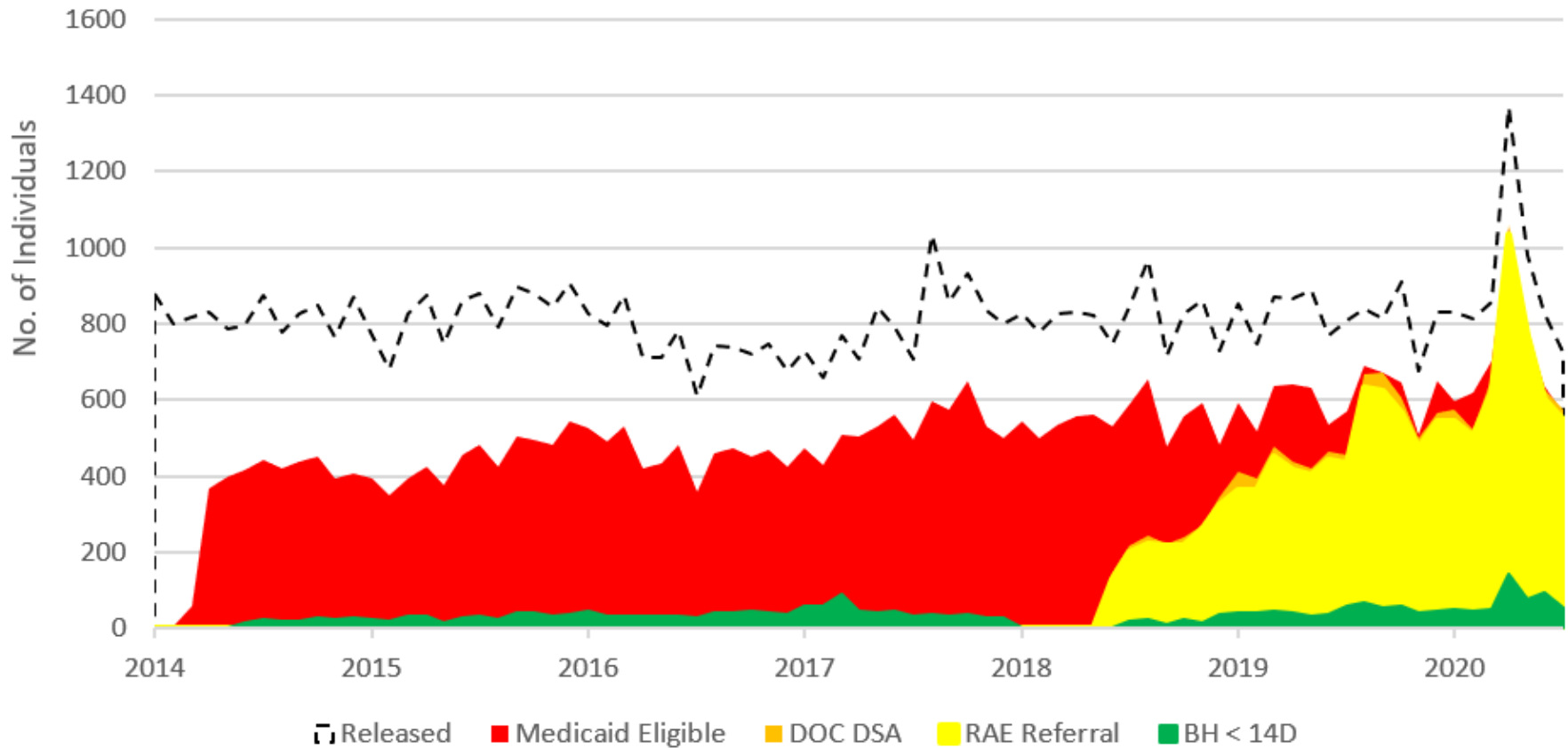

Crisis Service System Recommendations



Recommendation:

Meet: BHIS recommends that HCPF create policy guidance directing program management staff to monitor how RAEs are collaborating with regional ASOs. The guidance should encourage RAEs to initiate or participate in regular meetings between RAEs and ASOs to understand and align performance monitoring as it relates to Medicaid members.

Recommendation:

Replicate: BHIS recommends that HCPF and RAEs duplicate and expand on effective community coordination efforts already in existence. HCPF can use an existing forum such as the Learning Collaborative or create a new forum to address this work. Representatives from existing programs should be included in this work.



Recommendation:

Participate: BHIS recommends that representatives from PIAC, BHIS, HCPF, RAEs and ASOs participate in Behavioral Health Task Force implementation work. Task Force goals that support ASO and RAE alignment should be priorities. These include:

- improving care coordination
- supporting crisis co-responder models
- increasing workforce diversity (in terms of background and provider type)
- developing a statewide behavioral health authority that supports RAE and ASO alignment

Shared Metric

- Discussions indicated that measuring transition from crisis contact to engagement in care might be an ideal measure.
- Should that be called out as a future option for measuring across agencies? Added as a recommendation?

Strategy Screens

How should the recommendations' impact on these populations be described?

- Members who are diagnosed with both a mental health disorder and an intellectual developmental disability (IDD).
- Pediatric members, including those who are involved in Foster Care.
- Geriatrics members.

Measurement and Timeline

- How will we know implementation of recommendations is a success?
- Is this a long-term solution or fix right now?
- What is an appropriate timeline for implementing these recommendations?

- Submission to PIAC
