Q (Mindy): When will the State begin collecting on state-required measures?

A (Gwen): Some measures are based on claims data. We will utilize the calendar year of 2026 to review and reflect on measurement processes and will be collaborating with providers directly to ensure successful data collection. We can also ensure greater clarity of the state's role and responsibility in quality measure collection is reviewed in the next meetings.

Q (Daniel): Curious about the DCO relationship, what is the current thinking on making sure there aren't 2 classes of providers across the network.

A (Mindy): It really is up to the CCBHC if the DCO is the best course of action if a service is not something they are able to meet.

F/U (Daniel): Organizations that are able to pursue being a CCBHC are at an advantage, how do we ensure they are not dependent?

Comment (Nancy): There are also efficiency and accountability issues that are raised in the concept paper that has been presented to the work group.

Comment (Carly): Reminder that any CCBHC must provide the majority of services in house and can only supplement certain services through a DCO contract

Comment (Sara): Yes, Nancy, thank you for that - I think there are a lot of very weed y logistics that will be tough to figure out. The demonstration phase will be a great time to navigate this - I imagine it will take testing, learning, quality improvement, guidance and advice from other states, etc. It's a really important conversation, thank you for bringing it up, Daniel!
