4. Board Discussion

- a. James Johnston, 3:15pm
 - i. Changes to Hospital Financial Transparency Report (see slides).
 - The 2024 report will not contain any information obtained from hospitals prior to the passage of House Bill (HB) 23-1226.

- iii. Jon Alford asked about the section referring to the impact of COVID-19.
- iv. James Johnston replied that it will have to do with changes in fees, salaries and wages due to the COVID-19 pandemic.
- v. Jon Alford asked about what will be included in the financial analysis section and whether or not the analysis could show negative amounts when calculating gains and losses. James Johnston confirmed that it could.
- vi. Some but not all hospitals use Electronic Municipal Market Access (EMMA), which is a non-standard reporting group, so data will be incomplete. This discrepancy will be taken into account for the report.
- vii. The new Hospital Financial Transparency web page is live. It shows the differences between HB19-1001 and HB23-1226.
- viii. Bob Vasil asked if there would be a meeting to discuss the new requirements with hospitals.
 - ix. James Johnston said yes, and that once those requirements are finalized, that information will be dispersed.

 - i. Hospital Quality Incentive Payment (HQIP) update (see slides).
 - ii. Two (2) 2023 measures within HQIP that require action today: Cesarean section (C-section) scoring distribution recommendation, and Hospital Consumer Assessment of Healthcare Providers and Systems (HCAHPS) scoring distribution recommendation.
 - iii. Review of 2023 calculated bounds for C-section scoring (see slides).
 - iv. Jon Alford asked if the percentages are the C-sections amount divided by live births.
 - v. Matt Haynes confirmed yes.

- vi. The HQIP subcommittee did a great job in reviewing the literature and creating a fair scoring system.
- vii. C-section rates were similar across the country, but were higher in for-profit hospitals than in not-for-profit hospitals.
- viii. Review of 2023 calculated bounds for HCAHPS scoring (see slides).
 - ix. Jason Amrich requested additional detail about the questions in the composites. Matt Haynes said he'd get that information as soon as possible.
 - x. Jason Amrich also asked if the ranks are responding in the positive. Matt confirmed that yes, they are.
 - xi. Dr. Kim Jackson expressed concern that numbers could be affected by people not understanding how to answer the questions on the survey.
