




CO EMS Supplemental Payment Help Desk Statistics





CO EMS Supplemental Payment Provider Statistics


Participating Provider Count







Stakeholder Feedback



Emergency Triage, Treat, and Transport (ET3) Model

- Voluntary five-year program
- Initiative led by the CMS Innovation Center (CMMI)
- Offers treatment and transportation alternatives such as Treatment in Place (TIP) or Alternative Destination Partners for EMS providers serving Medicare Fee for Services (FFS) beneficiaries



Mobile Integrated Healthcare-Community Paramedicine (MIH-CP)

• Provided by various healthcare entities that are administratively or clinically integrated with EMS agencies

Both initiatives are meant to lower costs and improve care but are separate and distinct from the CO EMS Supplemental Payment.



Medicare Ground Ambulance Data Collection (MGADC)

Some information about the required MGADC:

- At this time, all Providers have been selected for either year 1, year 2, year 3, or year 4.
- Selections can be found in the zipped files here: <u>Medicare Ground</u>
 <u>Ambulance Data Collection System | CMS</u>
- Between 2020 and 2024, all ground ambulance Providers will be required to collect and report expenditures, revenues, utilization, and other departmental statistics
- Please note that this requirement is separate and distinct from the CO EMS Supplemental Payment
 - You will <u>not</u> be able to use the same cost report for both initiatives
