# Colorado System of Care (CO-SOC) Provider Enrollment & Billing Guidance

---

January 2026

## Overview

The Colorado Department of Health Care Policy and Financing (HCPF) is working toward expanding and improving implementation of the Colorado System of Care (CO-SOC) that includes intensive in-home and community-based mental health services, intensive care coordination, mobile crisis intervention, and stabilization services. This will support Colorado Medicaid beneficiaries under the age of 21 for whom these services are medically necessary. The improved services will be culturally relevant, family-centered, and child-driven so that these services are provided in the most integrated and least restrictive setting.

## CO-SOC Services

CO-SOC Services include the following:

- Enhanced Standardized Assessment (ESA)
- Enhanced Multi-Systemic Therapy (EMST)
- Enhanced Functional Family Therapy (EFFT)
- Enhanced High Fidelity Wraparound (EHFW)

These services are covered regardless of diagnosis, as long as a member meets program criteria and are medically necessary. ## Provider Enrollment Guidance

HCPF will not create new provider types for providers that will perform CO-SOC services, as most of these providers participate in other spaces. Instead, HCPF will allow appropriate billing providers to add a CO-SOC flag to their Medicaid enrollment that will allow them to be reimbursed for the CO-SOC services. While this functionality is being built, the Workforce Capacity Center will host an updated list of allowable CO-SOC providers.

These enhanced services cannot be billed by Comprehensive Safety Net Providers (CSNPs), Federally Qualified Health Centers (FQHCs) or Rural Health Clinics (RHCs); these providers are required to have a separate enrollment as a provider type 77-388 or 77-389 to bill for CO-SOC services. HCPF will assist in expediting new provider type 77-388 or 77-389 enrollments for providers intending to offer CO-SOC services.

### Additional Billing Guidance:

- T2022 HT can only be billed once per member per month.
- T2022 HK OR HA can be billed once per member for each month the member receives a T2022 HT.
- MST services can be billed by CSNPs, FQHCs or RHCs under Multisystemic Therapy (MST) H2033 and included on their respective cost reports.
- FFT services can be billed by CSNPs, FQHCs or RHCs under Functional Family Therapy (FFT) H0036 +HA or H0037 +HA and included on their respective cost reports.
