### Colorado's Unemployment Rate Increase

February: 2.5%

March: 5.2%

April: 11.3%

May: 10.2%

- Doubled Feb to March and March to April
- Highest since state began tracking in 1976
- Prior record was 8.9% during Great Recession in Fall 2010
- Compares to 14.7% nationally highest since U.S began tracking in 1948


517,000 Coloradans filed initial unemployment claims since mid-March (through April)

### Medicaid, CHP+ Membership Surge Forecast

- Expecting a membership surge of more than 500,000 Coloradans this coming Fiscal Year
- 40%+ increase to the 1.3M members covered by Medicaid and CHP+ as of March 2020
- When the public health emergency period ends (presumed Dec. 31), we project an estimated disenrollment of more than 300,000 members who do not meet eligibility criteria.
- Net annual surge of 350,000 Coloradans



### Types of emergencies

- Currently under all types
- Under HHS public health emergency, Section 1135 of the Social Security Act allows for Medicaid (and other) emergency waivers and amendments
- Changes last until termination of public health emergency, or for the length approved by CMS, or at discretion of Department
- FMAP bump is through Families First Legislation and ends the last calendar day in the quarter that the emergency ends

## Rates Discussion

- "Enhanced" COVID-19 rates end 6/30/2020
- Across the board rate decrease of 1% approved, goes into effect 7/1/2020
  - Information Memo 20-027 has more information
  - ➤ Includes most fee-for-service HCBS rates and Targeted Case Management
- Denver City and County increase goes into effect 1/1/2021
  - Working on distinction. Understanding is it is for services provided within geographical area
  - Department concerned about overall impact to Metro area
  - Continue to work on workforce related issues

# New "Normal" Idea Highlights Case Management

#### Changes to Keep

- No PMIP
- Online/remote visits
- Not terming people because they can't find providers
- Electronic signatures

#### Challenging Changes

- Missing true connection through virtual visits
- Not being able to close cases for clients not responding to us or can't find them as it impacts caseload sizes
- Technology challenges for CMs and members
- Longer time to collect signatures makes it difficult to track

# New "Normal" Idea Highlights Benefits and Services

#### Changes to Keep

- Delivery of services via Telehealth Methods
- Alternative settings for Day Programs
- 30-day exemption for PASRR
- 1:1 Day Program

#### Challenging Changes

- Only being to have one client in a vehicle at a time
- Home Health Providers are struggling with the 24/7 responsibility with minimal Day Program services
- Rates not being able to support 1:1 or smaller group programs

## OM 20-063

TITLE: UPDATED OPERATIONAL CHANGES TO THE HCBS NON-MEDICAL TRANSPORTATION (NMT) BENEFIT FOR COVID-19

#### NMT rides shall be limited to:

- One member per 5-passenger vehicle
- Two members per 7-passenger vehicle
- Five members per 15-passenger van or bus
- If members reside in the same household, Group Home, or Assisted Living of 20 residents or less, they may ride in the same vehicle to activities or day programs without restriction

Providers shall use disinfectant wipes on areas and objects in the vehicle that may have come into contact by the previous rider prior to any subsequent ride.

- Providers shall follow these basic hygienic steps to mitigate the risk to themselves and members:
  - Wash your hands often with soap and water for at least 20 seconds, especially after going to the bathroom; before eating; and after blowing your nose, coughing, or sneezing.
  - If soap and water are not readily available, use an alcoholbased hand sanitizer with at least 60 percent alcohol.
  - Avoid close contact with people who are sick.
  - Avoid touching your eyes, nose, and mouth.
  - Cover your cough or sneeze with a tissue, then throw the tissue in the trash.
  - Clean and disinfect frequently touched objects and surfaces using a household cleaning spray or wipe.
  - Disinfect vehicles daily.
  - Have tissues and hand sanitizer available in vehicles for drivers and/or passengers.

# Staffing Update

#### ConnectToCareJobs.com

- As of 6/23, 47 facilities and 502 job seekers registered
- Emails sent Tuesday to 145,476 individuals with active licenses (RN, LPN, CNA, PT, OT) and to all CNA training programs and nursing school contacts
- Emails sent yesterday to individuals on OnwardCO that had identified 'healthcare' as an area of interest

#### Rapid Response Staffing

- Identified 4 top potential solutions to pursue
  - > Recruit recent nursing graduates who have not yet completed their exams
  - Explore utilizing Colorado Hospital Association's Colorado Staffing Collaborative
  - Explore developing a Home Care Agency collaborative to draw from home health agency staff
  - Pursue using volunteers through the Colorado Volunteer Mobilizer

# Facility Reopening Update

- Outdoor visitation guidance released this week
  - > Guidance for residential care facilities outdoor visitation

 Indoor visitation requires a new public health order, so time exists to add/clarify details



# EM Resource

- Provides insight into bed capacity, PPE needs and staffing shortages
- Data inputted daily
- As of 6/23, 103 (45%) nursing homes and 79 (11%) are utilizing the tool
- CDPHE is offering training and technical assistance on using the tool
- Group homes to be added within the next few weeks
- Use of EM Resource to be required per new public health order
