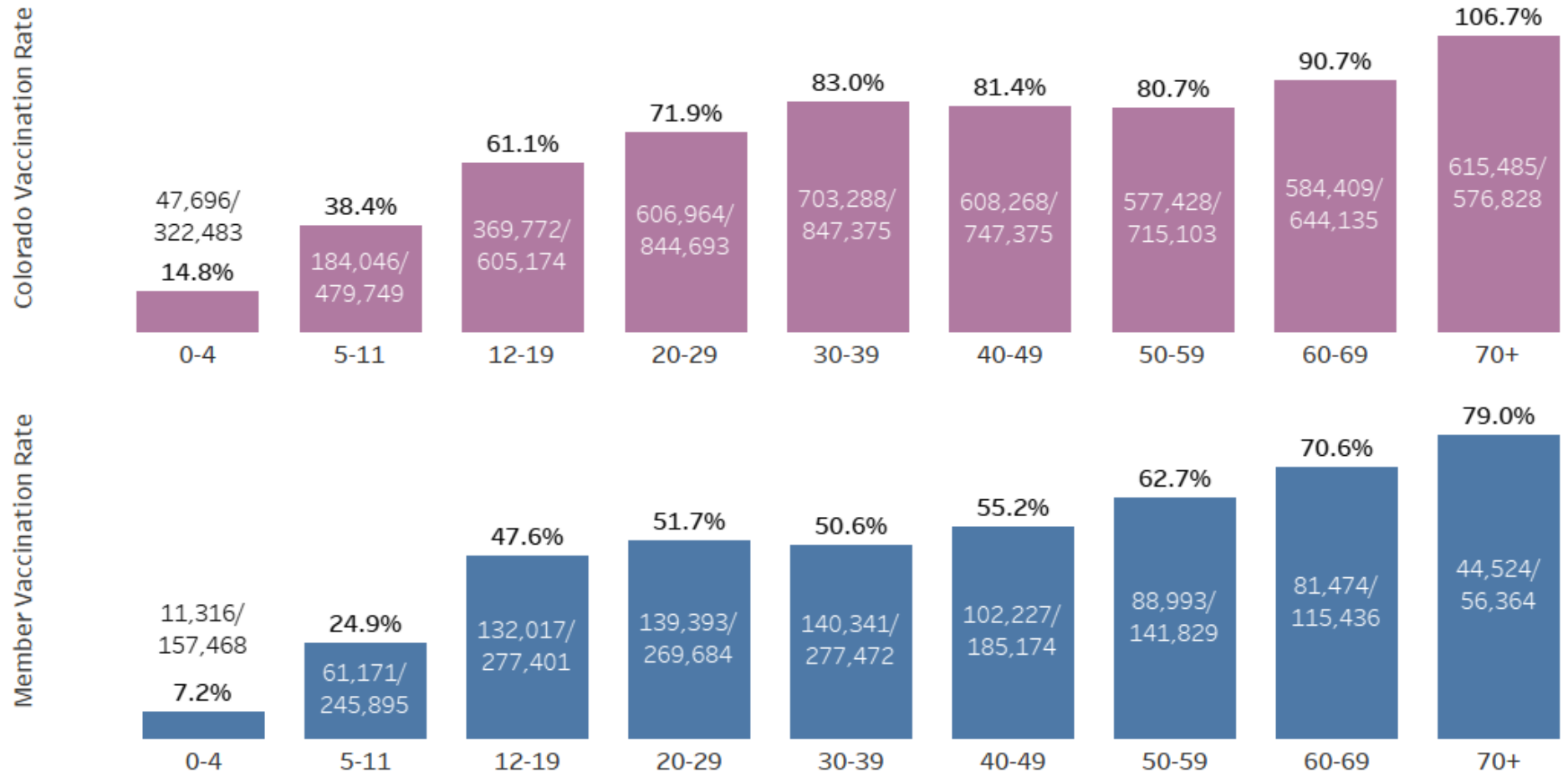


COVID-19 Vaccination Rates: Statewide vs Medicaid and CHP+

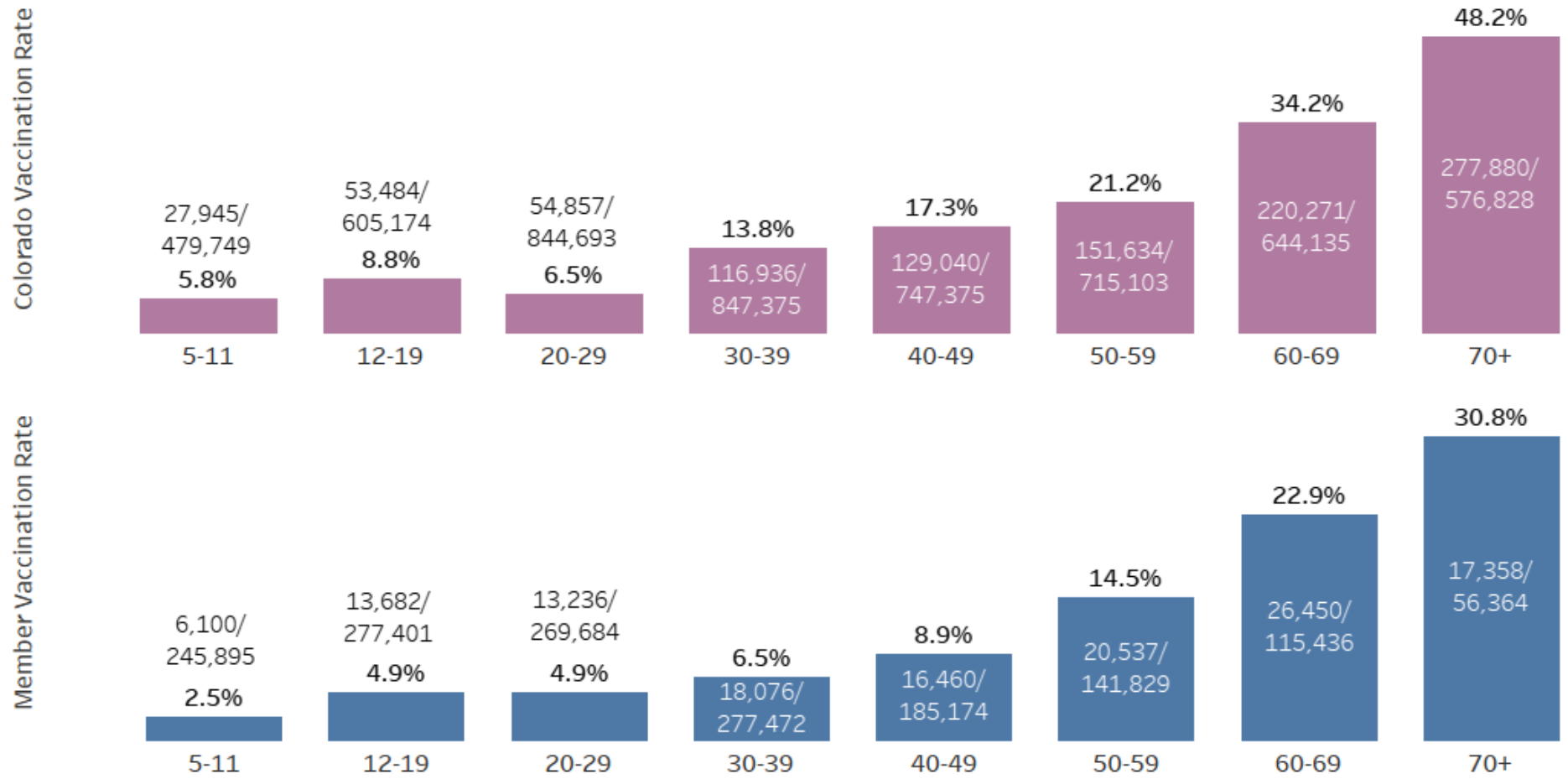

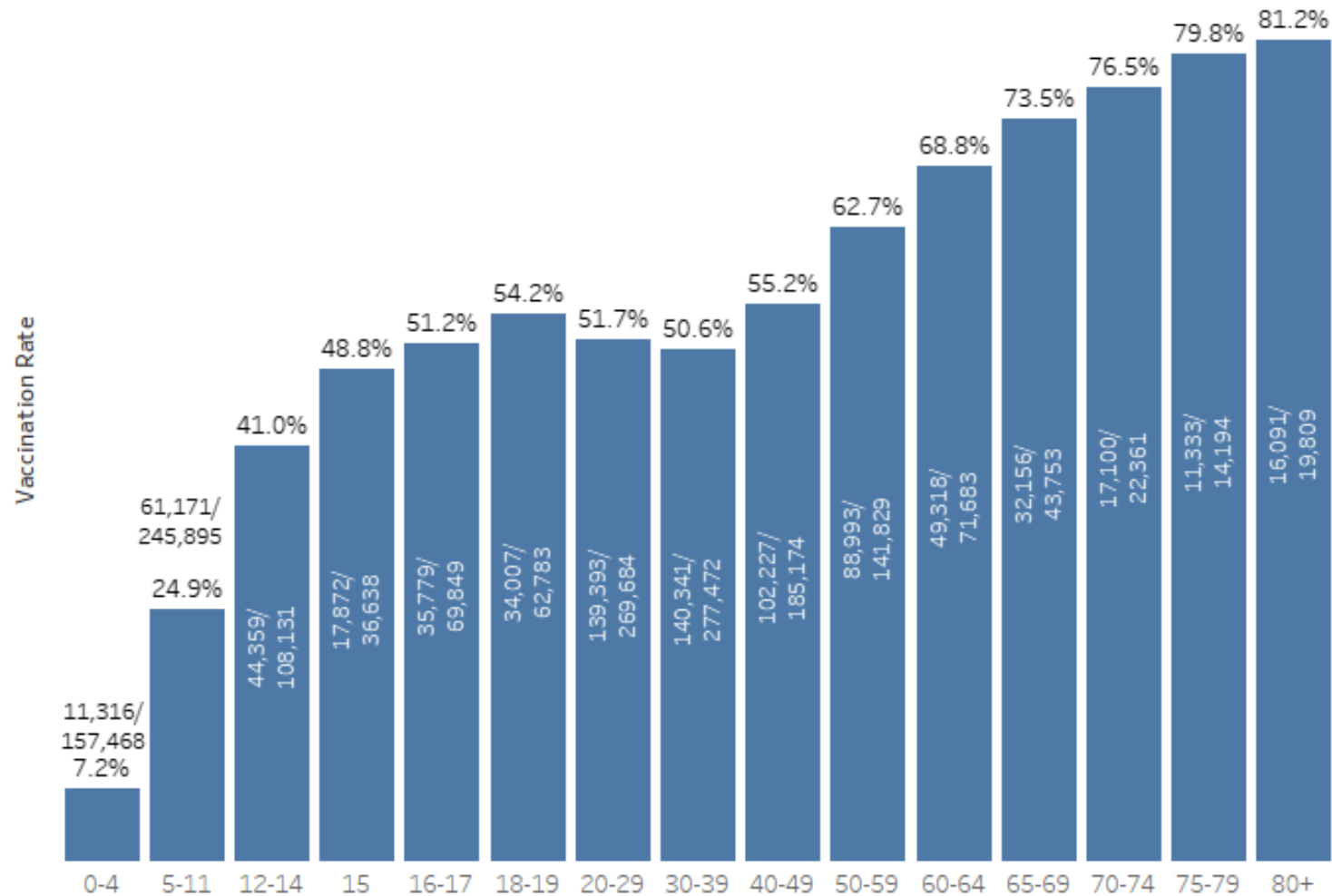

Medicaid and CHP+ COVID-19 Vaccine Rates by Age Group

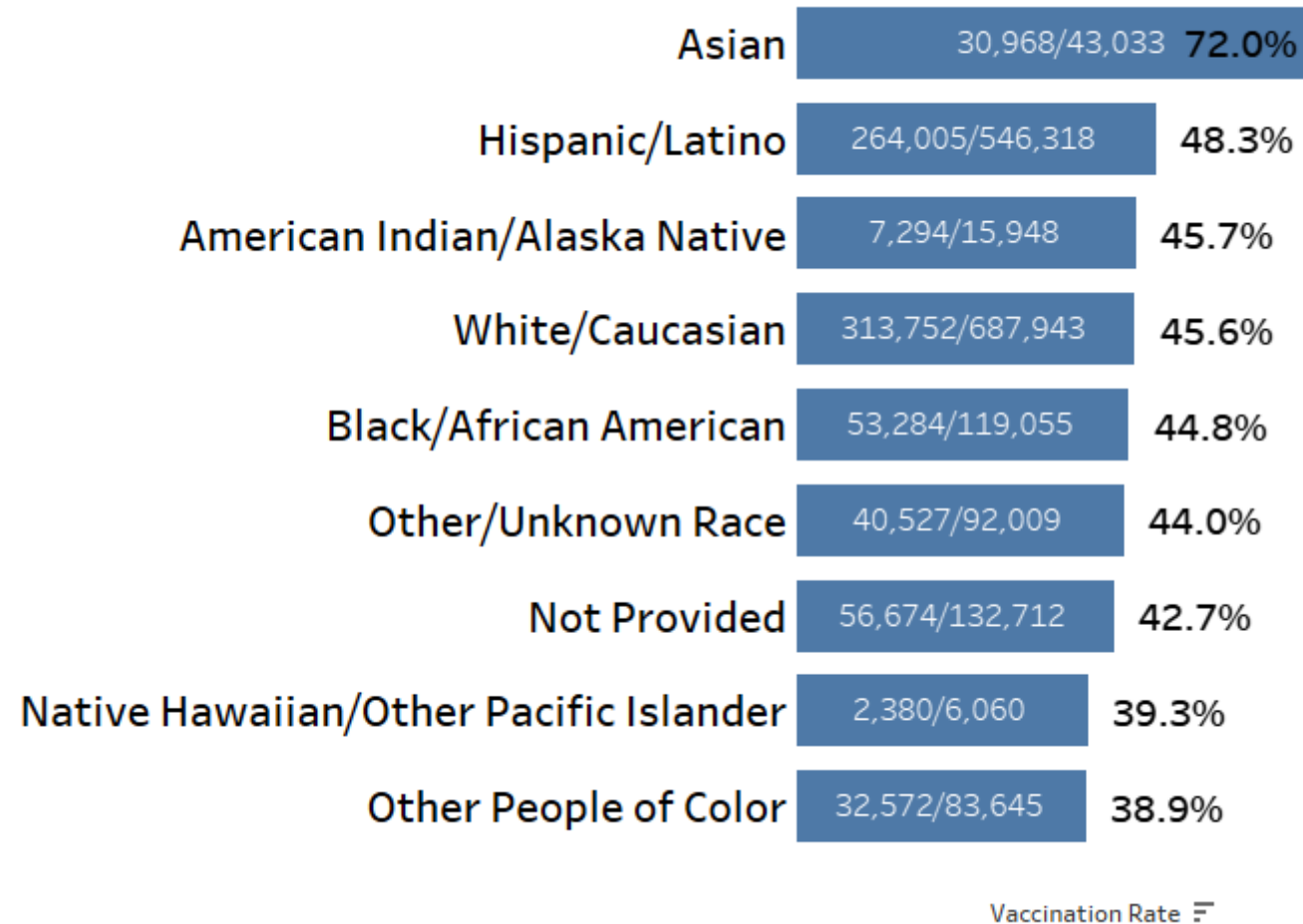

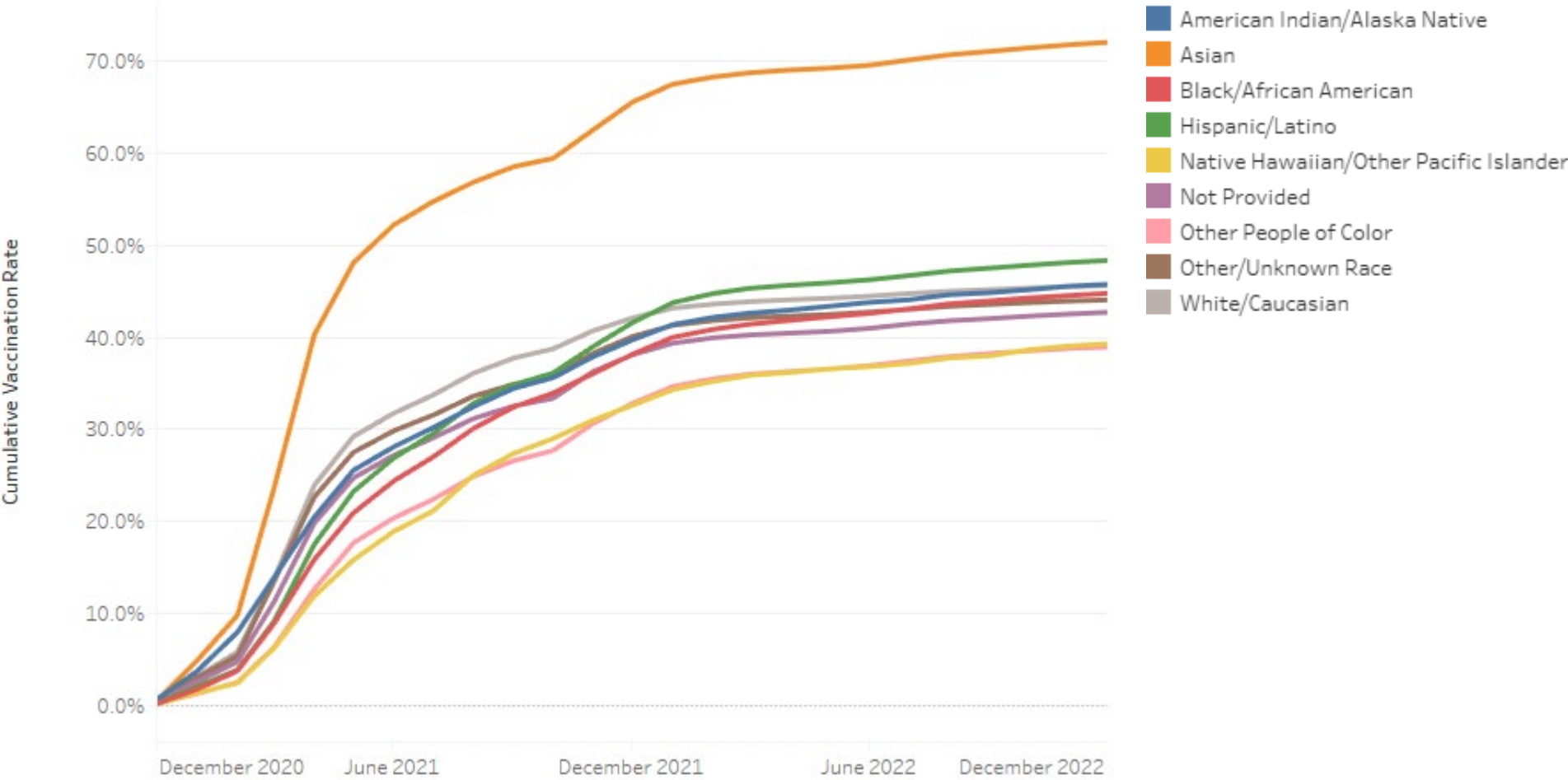

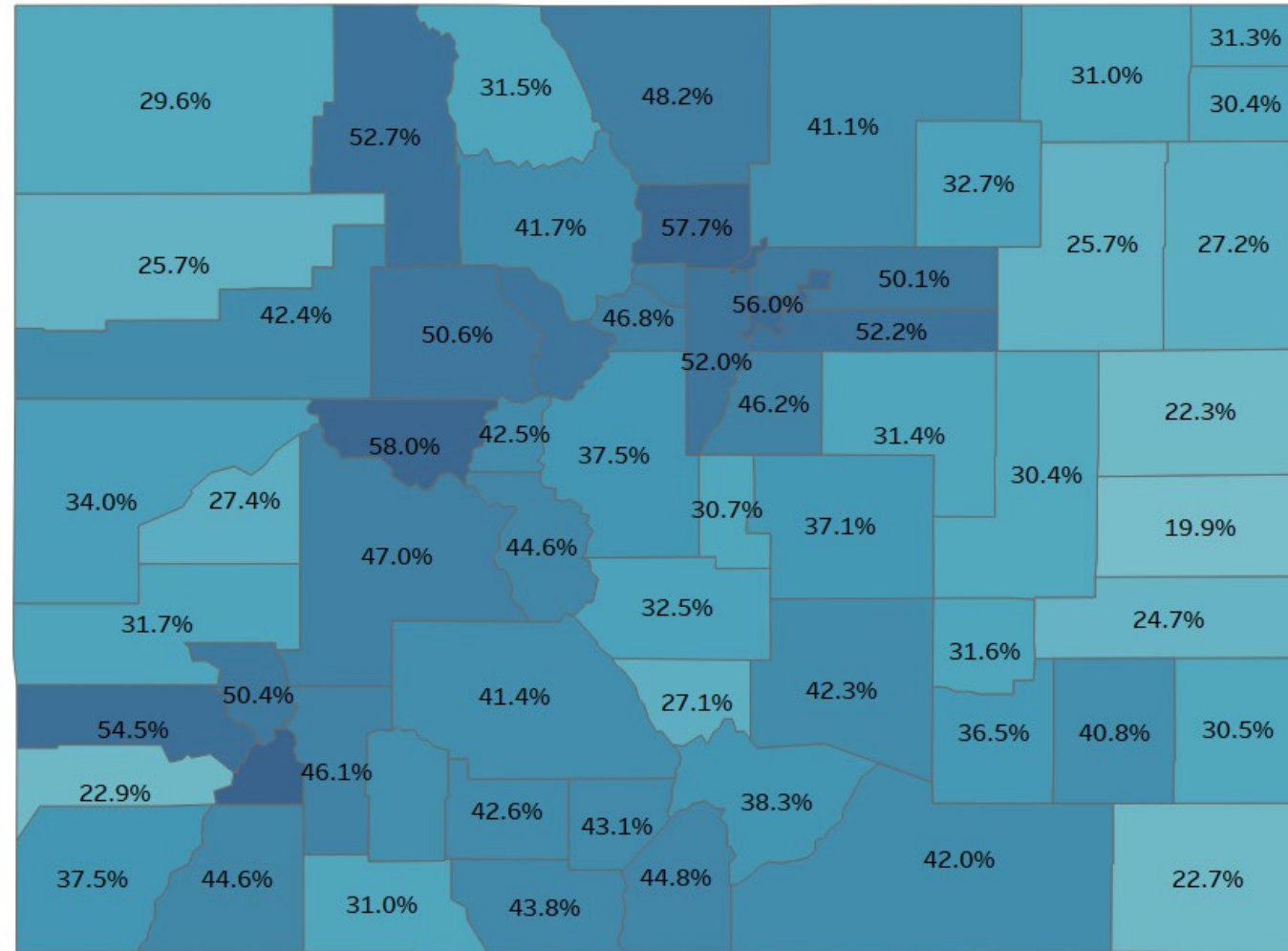

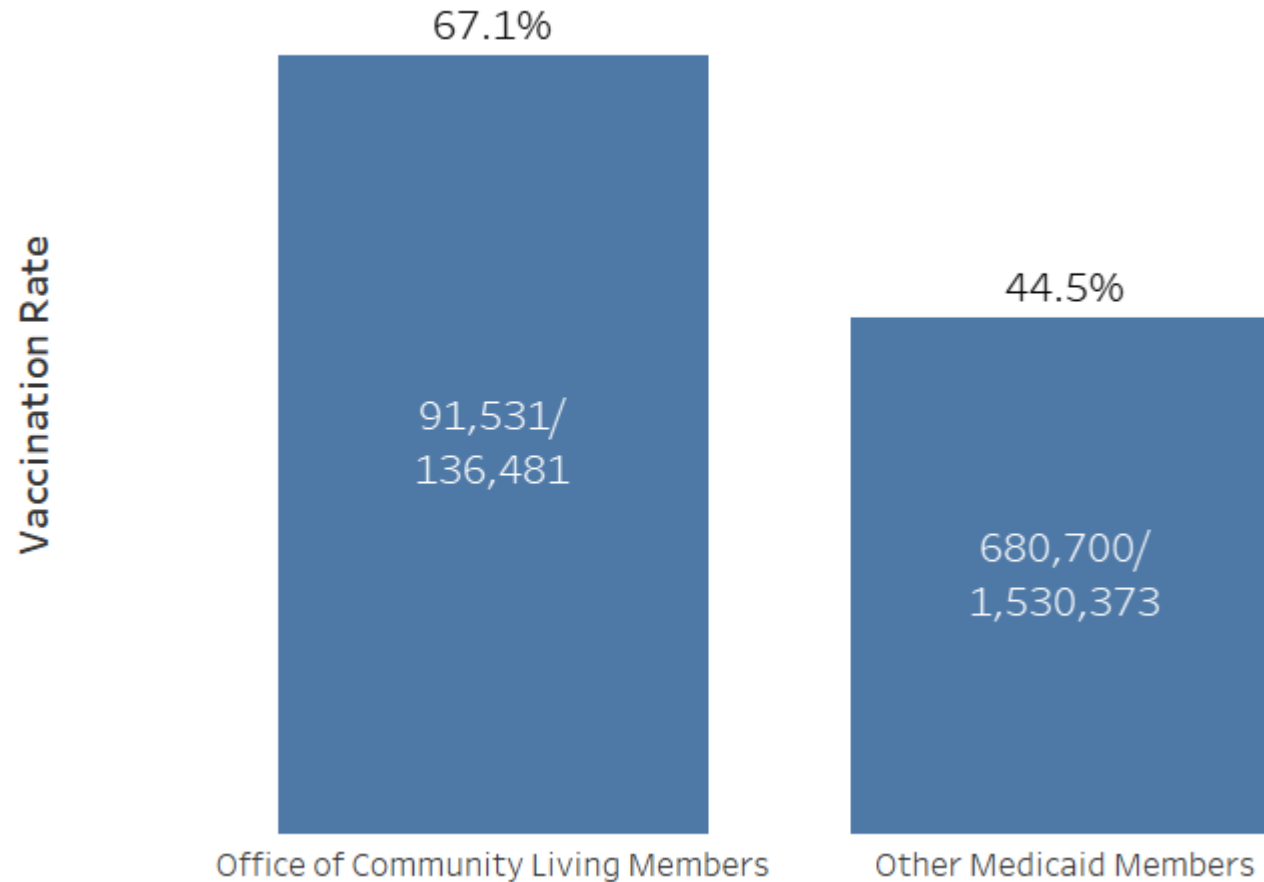
Medicaid and CHP+ COVID-19 Vaccine Rates by County

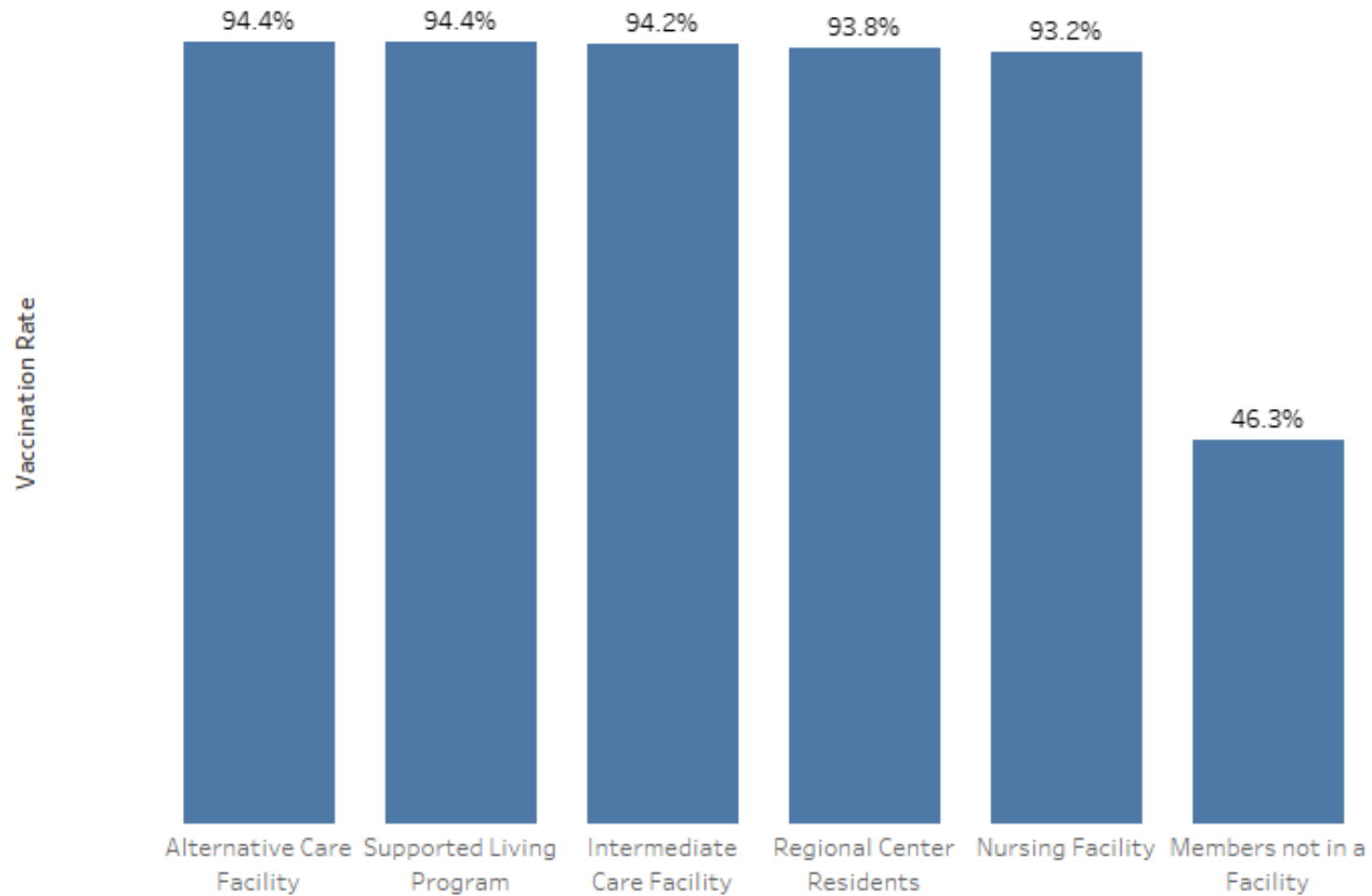

Medicaid COVID-19 Vaccine Rates for Office of Community Living Members (All ages)



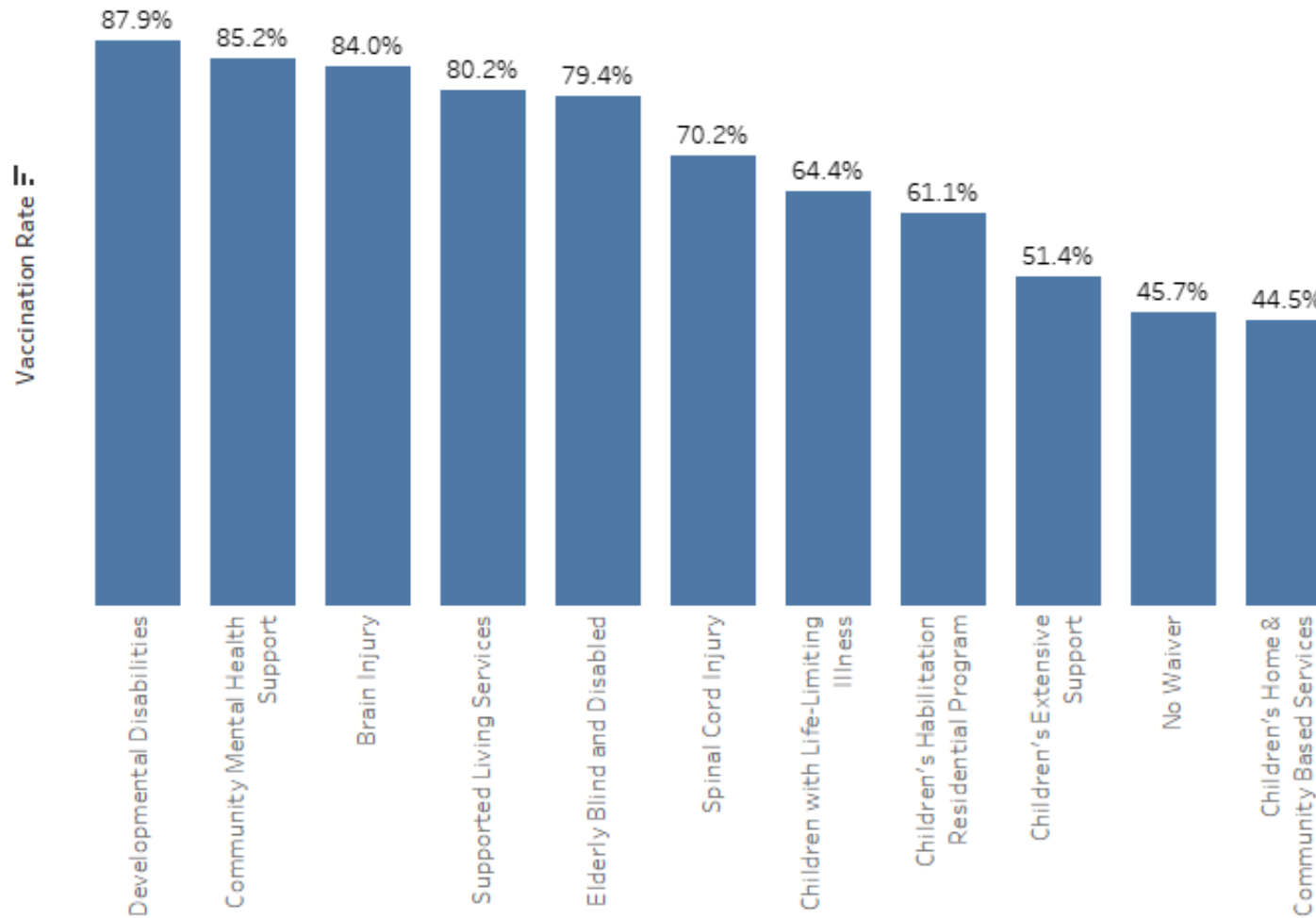

Medicaid COVID-19 Vaccine Rates by Facility (All ages)



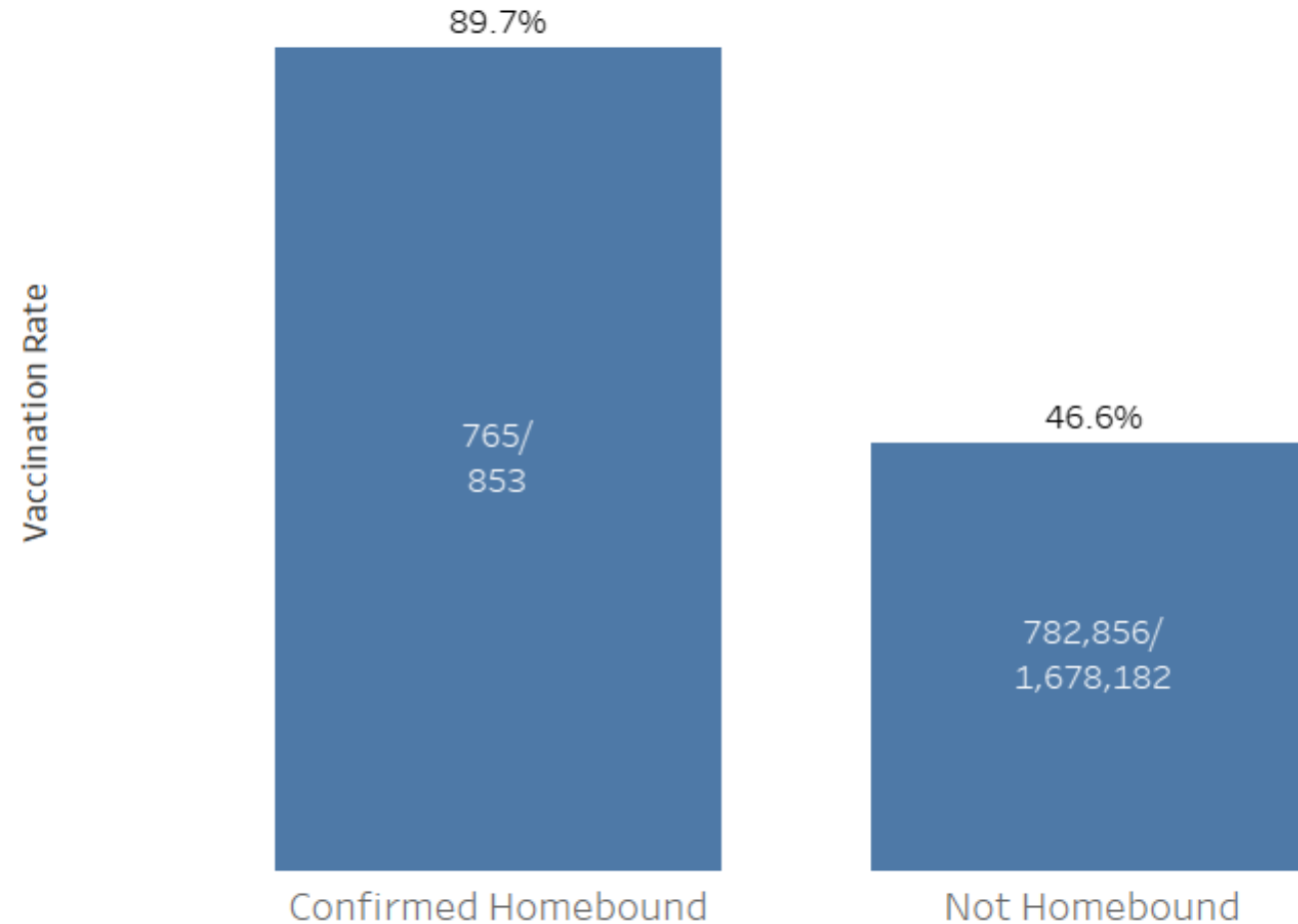
