### Information & Background

Doulas seeking to become an approved provider with Health First Colorado (Colorado's Medicaid program) must meet the qualifications and education requirements established in either the:

- Certification Pathway - hold a certification as a certified doula from a certifying body approved by the department. OR
- Experience Pathway - demonstrate the minimum requirements and submit all required documentation. For more information on this pathway, visit [the doula webpage](#).

Note: A designation of being an approved training organization for the certification pathway is given to organizations that have applied to be listed on the Doula website and met the minimum requirements. This designation does not constitute an endorsement of the services provided by the training organization. It is the responsibility of the individual seeking to become a certified doula to determine if any given training meets their specific preferences and requirements.
