





- Request for Proposals released December 2022 for providers in newly defined services areas
- By July 21, 2023 all 20 areas had a provider who was notified of HCPF intent to award
- Total of 15 agencies across 20 defined service areas

# **Transition Phasing Timeline**

- Phase 1 Transitions: August October 2023
  - November 2023: First group of CMAs fully transitioned
- Phase 2 Transition: November-February 2024
  - March 2024: Second group of CMAs fully transitioned
- Phase 3 Transitions: March June 2024



# CHCBS Member Transition

Private Case Management agencies serving members across the state transitioned in Phase 3 to ensure continuity of care for members, families and staff in the Children's Home and Community Based Services waiver.

# Waiver Changes

As of July 1st, 2024, Case Management is no longer a direct service in the CHCBS waiver.

Members were automatically enrolled in the Wellness Education Benefit (WEB) services in May 2024. This ensures members have a monthly billable service therefore avoiding ineligibility.

# Follow Up Post Transition

To ensure CHCBS members have the smoothest transition possible, the department will be doing the following:

- All ongoing CMAs will have received an Overview of CHCBS Training (June 24th)
  - Private CMAs supported in the development of the training.
- Monitoring of contact by the CMAs through the state database system in July and August
  - Targeted outreach to CMAs not meeting contract requirements
