Per the decision in February to add providers to neuro/psych testing, Discuss/Approve language added to Codes 96130, 96131, 96132, 96133, 96136, 96137, 96138, 96139 "If psychological testing services are performed by an intern or unlicensed service provider, services must be supervised and at the direction of a licensed provider, even though their presence is not required during administration. The licensed service provider ensures that the testing environment offers adequate privacy and confidentiality and maximizes the examinee's performance.	John	Committee attendees will consult with their clinical staff and submit feedback to John with any edits.

All providers may perform diagnostic psychological and neuropsychological tests only if these services fall within their scope of practice."		
Providers allowed for 96146	John	Agreed we would not add additional providers. Attendees will review CMS language about providers with their clinical staff/providers to suggest any possible clarifying language.

One of the directives that came from this consultant was the issue of federally funded services requiring a licensed signature on all services rendered. So for services like Case Management, Skills Training and Development, or Clubhouse services which are allowed to be rendered by staff who are unlicensed, notes would need to be co-signed by a licensed provider. Is it the understanding of the committee that this is the case for these services? I'm hearing mixed responses on this issue.
