## The American Rescue Plan Act

- The American Rescue Plan Act (ARPA) was passed by Congress on March 11, 2021
- Section 9817 of ARPA supports HCBS services, including behavioral health components
  - o 1915 (c) Home and Community-Based (HCBS) Waivers
  - Personal Care
  - Targeted Case Management
  - Home Health Care
  - Private Duty Nursing
  - Program of All Inclusive Care for the Elderly (PACE)
  - Behavioral Health

# Public Health Emergency Extension



- Recently extended on April 12, 2022 for an additional 90 days
  - Current potential expiration is July 11, 2022
- Federal declaration put into place in Jan 2020
- Requires HCPF to maintain eligibility for all members enrolled during the PHE
- Provides an additional 6.2% federal funding match while PHE is in place per Families First Coronavirus Relief Act

## **ARPA Extension**

After national advocacy, associations are reporting (and CMS has verbally confirmed) that CMS will be extending the time allowed for spending ARPA HCBS to March 31, 2025



- Do not yet have written guidance from CMS
- Provides no additional funds
- Gives one more year to spend the approx. \$530M
- More information to come once we receive the final announcement





#### Budget by Type of Project







# LTHH, PDN, and PPC

- Transitioning the management and oversight of Long-Term Home Health (LTHH), Private Duty Nursing (PDN), and Pediatric Personal Care from Health Programs Office (HPO) to Office of Community Living (OCL)
  - These benefits are traditionally long-term in nature
  - Hospice, EPSDT, and Pediatric Behavioral Therapy will not be included as part of the transition
- Good timing to allow for aligning benefits as we plan for Community First Choice (CFC)
- Formal transition date of July 1, 2022
- Following the transition this summer, the Department will begin holding public stakeholder meetings with interested parties about these benefits, UR/UM of these services, and next steps



# **Upcoming Grant Opportunities**

- ARPA HCBS includes 13 grant projects
  - Eligible applicants vary across the projects, but will include, providers, community-based organizations, & non-profits
- RFP currently out for a financial vendor to manage grant contracting and invoicing
  - Benefits: Ease of communication, standardization across grant projects, & faster contracting
- Get prepared!
  - Request for Applications will be posted on our ARPA webpage & emailed out through our email list
    - Sign up now for the email list & check the website often
  - All grantees will be required to be validated- Check your status!
    - CO Secretary of State
    - Federal System for Award Management
  - Start planning Most applications will have 30 days from posting to submission

### **ARPA Home Modification Enhancement**

- Effective January 1, 2022, members on the below Home and Community-Based (HCBS) waivers, will have access to an additional \$10,000 in Home Modification funding:
  - Elderly, Blind and Disabled (EBD) EBD, CMHS, BI, SCI, SLS, and CES
  - Community Mental Health Supports (CMHS)
  - Brain Injury (BI)
  - Spinal Cord Injury (SCI)
  - Supported Living Services (SLS)
  - Children's Extensive Supports (CES)
- New home modification requests to be used under this available funding will be accepted until November 30, 2023
  - Projects must be reviewed and completed by March 31, 2024
- Members should contact their case manager through the Single Entry Point (SEP) or Community Centered Board (CCB) to access this funding
  - Funding approval will follow the same process for accessing the home modification benefit



#### Call To Action



A temporary rate increase using Home and Community-Based Services (HCBS) American Rescue Plan Act (ARPA) funding was implemented on Nov. 4, 2021. A 2,11% increase has been applied retroactively to April 1, 2021, and will be in effect through July 31, 2022, but providers must submit or adjust

Do not lose out on the increase. Be sure to submit your claims or adjust your paid claims ASAP!
