

## Community First Choice State Plan Amendment (SPA)

### What is a State Plan?

- Definition: A Medicaid state plan is an agreement between a state and the Federal government describing how that state administers its Medicaid program.
- It gives an assurance that a state will abide by Federal rules and may claim Federal matching funds for its program activities.
- The state plan sets out groups of individuals to be covered, services to be provided, methodologies for providers to be reimbursed and the administrative activities that are underway in the state.

# What is a State Plan Amendment (SPA)?

- When a state is planning to make a change to its program policies or operational approach, states send state plan amendments (SPAs) to the Centers for Medicare & Medicaid Services (CMS) for review and approval
- States also submit SPAs to request permissible program changes, make corrections, or update their Medicaid state plan with new information
- The addition of Community First Choice (CFC) to the Colorado State Plan requires a SPA. CMS provides a SPA template for state to complete specific to adding CFC

### **SPA Approval Process**

- When a state proposes an amendment to its state plan, they send their documentation to the Center for Medicaid and Medicare Services (CMS)
- CMS has 90 days to make a decision on the SPA
  - CMS has the ability to "stop the clock" and take more than 90 days by requesting additional information
- Unlike waivers, once a SPA is approved it does not expire

## CFC SPA Outline - What's Included?

- Language in the SPA:
  - ➤ Broad, simple overview of the program and its' intention
  - Universal words that CMS uses to describe Home and Community-Based services, rather than what we use in Colorado
