


## **Community First Choice**

#### Goal of CFC: Making HCBS accessible for more Medicaid members with expanded options and availability for self-directed care

- **Consumer Directed Attendant Support Services**





## Breaking Down CFC Services for SLS and DD waiver members



### **DD Waiver Services vs CFC Services**

 Members on the DD waiver all have a residential provider agency that provides 24/7 supports or access to 24/7 supports. There cannot be any duplication of services between waivers and CFC. Residential services include the provision of ADL/IADL care and therefore CFC Personal Care, Homemaker, IHSS, and CDASS would be duplicative of residential services.

| There cannot be any duplication of convices between waivers and CEC   |   |  |

- There cannot be any duplication of services between waivers and CFC. Therefore, an SLS waiver member will not be able to receive CFC Personal Care while at Day Habilitation
- If there is an assessed need for Personal Care outside of Day Habilitation, the member will access these services through CFC
  - > SLS members have the option to use IHSS or CDASS for these services

### Person-Centered Budget Algorithm (PCBA)

- Replaces the Supports Intensity Scale/Support Levels as required by SB 16-192
- The PCBA is a universal process that uses the Colorado Single Assessment (CSA) data and Person-Centered Support Planning for all HCBS populations
- Provides consistent method for evaluating budgets for all members receiving Home and Community Based Services (HCBS)
- The Department is developing additional exceptions processes to help ensure everyone is supported to live safely and thrive in their home and communities



## **Benefits of Using the PCBA**

- Transparent, objective, and equitable approach to support a person-centered support planning process
- Make sure people get the right services, at the right time, in the right amounts and place
- Avoid subjective judgement in resource allocation
- Gives members the flexibility to prioritize and access the services and supports that help them live lives of their choosing in the community




## **PCBA is Universal**

- The PCBA will be run in the "background" and will be based on data collected in the CSA
  - The CSA includes the Level of Care Screen (LOC) and Needs Assessment and is conducted for all Members seeking or receiving Long Term Support Services (LTSS)
- All members, regardless of waiver, will have a PCBA that will be used to determine their total budget range of services
- All services (Waiver and CFC) will be included in the calculation of total cost




### **PCBA in Service Planning**
