## 4) Liability and CPR Requirements

- a) The Department shared information on CPR requirement (slide 17)
  - a. Colorado's Good Samaritan Law provides legal protection for individuals administering CPR in emergencies.
  - b. CPR certification is required for doulas enrolling as Health First Colorado (Medicaid) Doulas to ensure the delivery of high-quality care.
  - c. The Department is investigating whether a list of available CPR courses can be compiled and shared.
  - d. DAC comments:
    - e. Some members expressed concerns about access, cost, and relevance to doula work.
    - f. Possible financial barriers were noted, with members exploring free or low-cost CPR training options.



- i. It is unclear where people can obtain CPR training and whether all CPR training is suitable. It would be helpful to have a list of CPR courses, including their locations and pricing.
  - (a) Comment from the Department: *In the training provided on the doula webpage for enrollment, adult and infant CPR is specified.*
- ii. The cost of CPR certification and re-certification is a barrier.
  - (a) DAC Member Question: Could the Department or grant funding cover the cost of CPR training?
- iii. Language and accessibility may be barriers.
- iv. There are some concerns about liability or working out of scope as a Doula if required to perform CPR.
- v. A suggestion was made to make CPR training optional but encouraged.
- vi. Recommendation from Laurel H. in chat: I recommend that the CPR requirement be removed. If it isn't removed, we would like to suggest that HCPF increase information about which CPR course meets the requirement and what low-cost or no-cost options are available to help expand access for Doulas to enroll.

- b) The Department shared information on the liability insurance requirement (slide 18) and set up the focus of the discussion to be focused on what barriers Doulas encounter when trying to get liability insurance.
  - a. DAC comments/questions
    - i. Some think the cost of liability insurance is a big issue.
      - (a) Some think it is the number one reason Doulas are not enrolling in Health First Colorado as a provider.
    - ii. Some suggested it is not clear which liability insurance is needed since there isn't a specific Doula liability insurance.
    - iii. It is unclear what to obtain liability insurance from - could the Department list the liability insurance providers?
    - iv. Some think that having liability insurance does not align with the community orientation of what a Doula is.
    - v. Some feel that why liability insurance is required is unclear, and what liability insurance covers is also unclear.



- vi. Some feel that if a member or community member hears that a Doula doesn't have liability insurance, it may land wrong.
- vii. Comment from the Department: Entering the paraprofessional space is relatively new, and it has always been a requirement for Health First Colorado providers to carry liability insurance.
- viii. Recommendation voted on: We recommend that HCPF remove the requirement of liability insurance for Doulas. While that removal is in process, we recommend that HCPF list the liability insurance providers on the website.
