# Provider Stabilization Fund Rule Update

## - Primary Care Definition

- Primary Care - Care that deals with the individual rather than an organ system or an abnormal physiology and provides an array of services covering the preventive, diagnostic, and therapeutic needs of patients, including referral and coordination of care to other services. For purposes of the Provider Stabilization Fund, primary care may include other services based on a patient's needs including dental, comprehensive behavioral health, and vision.

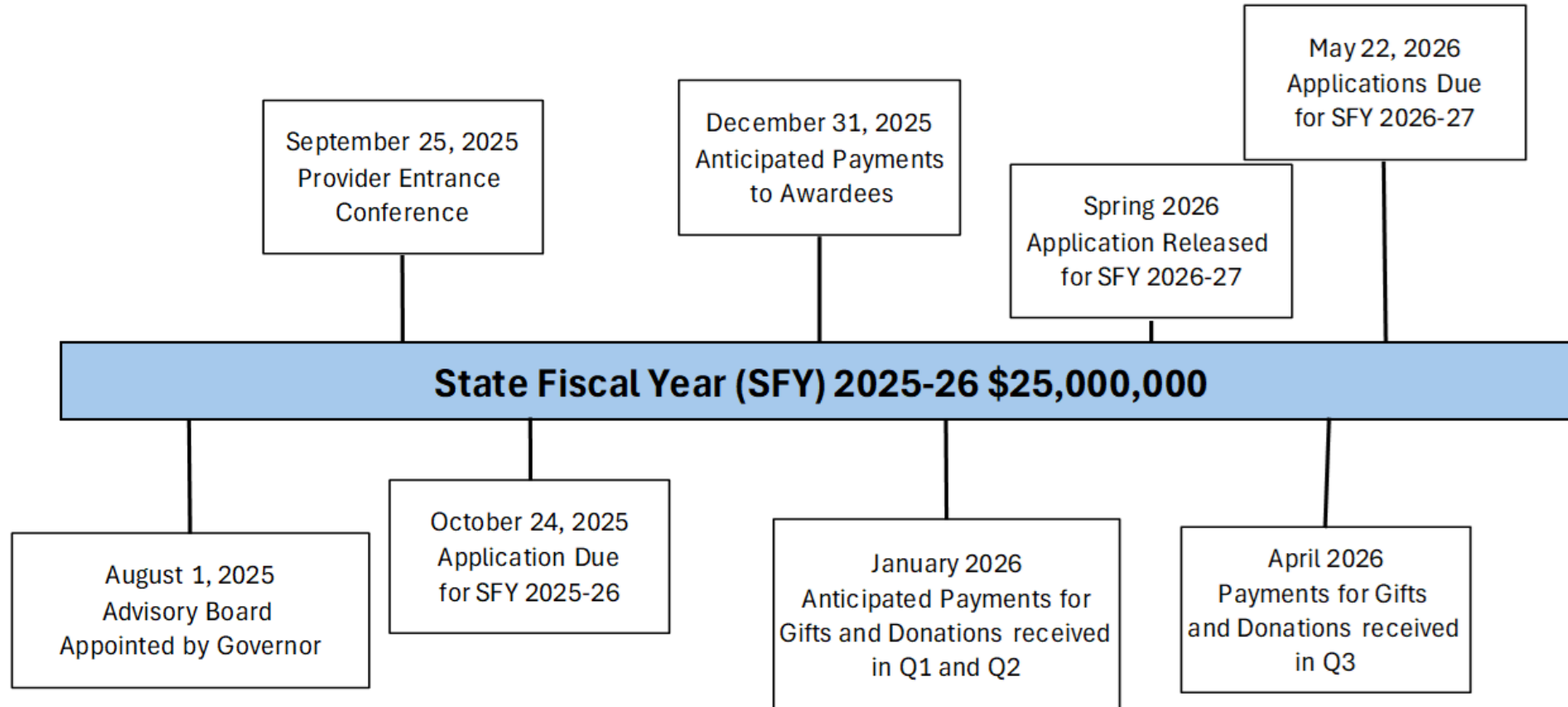

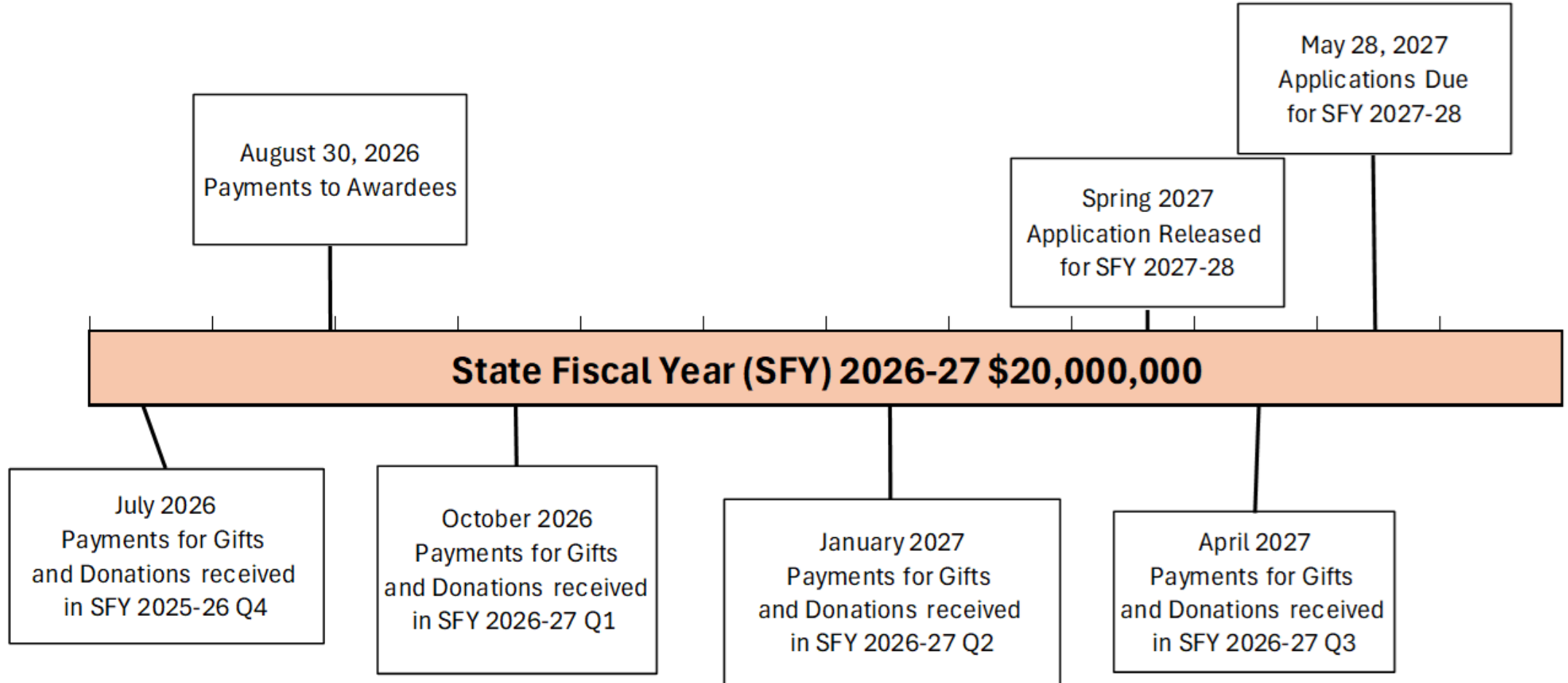
