Program Overview



Program Overview Doula

- Doula benefit program for members who are pregnant or have given birth
- Member eligibility criteria:
 - Eligible for Health First Colorado
 - Be pregnant or have given birth within the last 365 days





Program Overview Doula

- Doula benefit includes three categories of service:
 - 1. Prenatal support
 - 2. Continuous labor and delivery support
 - 3. Postpartum support
- Service limits are based on each member
- More than one doula may see each member
- If a doula identifies needs beyond approved services, they should reach out to the member's Regional Accountable Entity (RAE) for care coordination



Program Overview Doula

- Benefit program intends to leverage community-based doula model
 - Improves outcomes for pregnant people
 - Continuous labor support
 - Wraparound pre and postnatal care
- Not a substitute for clinical obstetric care or behavioral health care with licensed providers







Program Overview Lactation Support Services

- Benefit introduced December 1, 2024
- Result of legislation HB 22-1289
- Rules governing program outlined in <u>Code of Colorado Regulations</u>
 - 10 C.C.R. 2505-10 8.732.7






Program Overview Lactation Support Services

- Program gives access to services including training and counseling lactating members about breastfeeding and lactation
- Comprehensive, skilled care and evidence-based information
- Member eligibility criteria:
 - Eligible for Health First Colorado
 - Be a pregnant, postpartum or pediatric member who is breastfeeding



Program Overview Lactation Support Services

- Prior authorization not required
- No amount, duration or scope limitations for lactation support services benefit
- Service delivery options:
 - In-person OR telehealth
 - 1-on-1 **OR** group setting




Provider Enrollment Provider Type Definitions

Rendering provider: individual who performed the billed service

Billing provider: entity that receives reimbursement for the billed service

Referring provider: individuals who only prescribe, refer or order for Health First Colorado members





Provider Enrollment Rendering Providers - Doula

Doula benefit program providers must be enrolled in Health First Colorado under either of these provider types:

1. Doula - PT 79

2. Lactation Support Service Provider

International Board-Certified Lactation Consultant (IBCLC) - PT 70 Certified Lactation Counselor (CLC) - PT 71 Certified Lactation Educator (CLE) - PT 71

- Meets doula qualifications per 10 C.C.R. 2505-10 8.734.4
- May provide doula service without a separate provider type 79 enrollment



Provider Enrollment Eligible Rendering Providers - Doula

Doula support services may only be provided by individuals who meet qualifications of either:

1. Certification Pathway

 Hold a certification as a certified doula from a certifying body approved by the department, a list of approved doula training organizations can be found on the <u>doula webpage</u> under the heading Forms for Doula Provider Enrollment > Approved Doula Training Organizations

2. Experience Pathway

• Demonstrate all requirements are met



Provider Enrollment Rendering Providers - Doula

Forms required to enroll as a doula provider type

Both Pathways:

- Signed Attestation for either the Certification or Experience Pathway
- Signed Doula Code of Conduct
- Current CPR Certification

Certification Pathway:

Certificate from an approved doula training organization

Experience Pathway:

- Four Letters of Recommendation
- Initial Required Competencies on the Experience Pathway



Provider Enrollment Cross-Billing

- Enrolled doula providers who meet IBCLC, CLC or CLE qualifications may provide lactation support without separate provider type 70 or 71 enrollment.
 - Doula providers are required to submit a copy of their current lactation certification and must receive verification that the submission was approved prior to rendering or billing for lactation support services.
- Enrolled **lactation support service** providers (IBCLC, CLC, or CLE) who meet doula qualifications may provide doula services without separate provider type 79 enrollment.



Provider Enrollment Cross-Billing

Guidance for Doula Providers adding Lactation Services

Enrolled doula providers are required to submit a copy of their current certification through the Provider Web Portal as one of the following:

- Certified International Board-Certified Lactation Consultant (IBCLC) with current certification by the International Board of Lactation Consultant Examiners (IBLCE)
- Certified Lactation Counselor (CLC) with current certification by the Academy of Lactation Policy and Practice, Inc. (ALPP)
- Certified Lactation Educator (CLE) with current certification by the Childbirth and Postpartum Professional Association (CAPPA)



Provider Enrollment Rendering Providers - Lactation Support Services

1. Lactation Consultant (IBCLC)

- Provider type 70, specialty code 215
- Enrollment type: Individual Within a Group
 OR Billing Individual
- Provider must be certified IBCLC

2. Lactation Counselor or Educator (CLC or CLE)

- Provider type 71, specialty code 216
- Enrollment type: Individual Within a Group
- Provider must be certified CLC or CLE





Provider Enrollment Eligible Rendering Providers - Lactation Support Services

- Lactation support services may only be provided by enrolled individual providers with training in advanced lactation support
- Un-enrolled providers may not bill
 - Example: supervised interns, persons undergoing training to become a CLE, CLC, or IBCLC
- Other provider types may provide lactation support services if it is within their scope of practice and provider has training in advanced lactation support





Provider Enrollment Eligible Rendering Providers - Lactation Support Services

- International Board-Certified Lactation Consultant (IBCLC) PT 70
- Certified Lactation Counselor (CLC) PT 71
- Certified Lactation Educator (CLE) PT 71
- Certified Professional Midwife (CPM)/Direct Entry Midwife (DEM) PT 69
- Certified Midwife (CM) PT 80
- Certified Nurse Midwife (CNM) PT 22
- Licensed Physician (MD) PT 05
- Licensed Osteopath (DO) PT 26
- Licensed Physician Assistant (PA) PT 39
- Licensed Advanced Practice Nurse (APN) PT 41
- Licensed Registered Nurse (RN) PT 24 (enrolled as a Non-Physician Practitioner-Individual)
- Enrolled Doula providers who meet IBCLC, CLC or CLE qualifications PT 79



Provider Enrollment Supervision Requirements - Lactation Support Services

- International Board-Certified Lactation
 Consultants (IBCLCs) may provide lactation
 support services without supervision
- Certified Lactation Counselors (CLCs) and Certified Lactation Educators (CLEs) may only provide lactation support services under general supervision
 - May render services but do not bill directly
 - Claims must be submitted through group
 - Claims must identify the CLC/CLE with their National Provider Identifier (NPI) number as the rendering provider

Provider types (PT) qualified to supervise:

- Physicians (MDs) PT 05/65
- Osteopaths (DOs) PT 26
- Physician Assistants (PAs) PT 39
- Advanced Practice Nurses (APNs) PT 41
- Certified Nurse Midwives (CNMs) PT 22
- International-Board Certified Lactation Consultants (IBCLCs) - PT 70




Provider Enrollment Provider Type Definitions

Rendering provider: individual who performed the billed service

Billing provider: entity that receives reimbursement for the billed service

Referring provider: individuals who only prescribe, refer or order for Health First Colorado members





Provider Enrollment Billing Providers: Individual - Doula

Billing Individual - bills directly for themselves

- Individuals complete only one enrollment application regardless of enrollment type and number of service locations
- Must enroll using the individual's Social Security Number (SSN)



Provider Enrollment Billing Providers: Group - Doula

- Individual within a Group affiliates to a group and the group bills
- Group provider types that may bill for doula services include:
 - Clinic provider type 16
 - Non-physician Practitioner Group provider type 25
 - Lactation/Doula Professional Group provider type 72
 - Billing provider type 72 must have at least one (1) IBCLC or doula affiliated with the group
 - Group practice consisting of any of the following professionals who are enrolled with the Department as approved providers:

International Board-Certified Lactation Consultant (IBCLC), Certified Lactation Counselor (CLC), Certified Lactation Educator (CLE), Doula

Refer to <u>Doula Billing Manual</u> for group-specific billing guidelines



Provider Enrollment Billing Providers: Individual - Lactation Support Services

Billing Individual - bills directly for themselves

- Individuals complete only one enrollment application regardless of enrollment type and number of service locations
- Must enroll using the individual's Social Security Number (SSN)
- Eligible individual billing providers:
 - International Board-Certified Lactation Consultant (IBCLC) PT 70
 - Certified Midwife (CM) PT 80
 - Certified Nurse Midwife (CNM) PT 22
 - Licensed Physician (MD) PT 05
 - Licensed Osteopath (DO) PT 26
 - Licensed Advanced Practice Nurse (APN) PT 41
 - Enrolled Doula providers who meet IBCLC, CLC or CLE qualifications PT 79



Provider Enrollment Billing Providers: Group - Lactation Support Services

- Individual within a Group affiliates to a group and the group bills
- Group provider types that may bill for lactation support services include:
 - Federally Qualified Health Center (PT 32)
 - Rural Health Clinic (PT 45)
 - Indian Health Services (PT 61)
 - Clinic (PT 16)
 - Non-physician Practitioner Group (PT 25)
 - Lactation/Doula Professional Group (PT 72)
- Refer to <u>Lactation Support Services Billing Manual</u> for group-specific billing guidelines



Provider Enrollment Billing Providers: Facility - Lactation Support Services

Facility - submits claims for services, income reported through Employer Identification Number (EIN), separate NPI required for each service location

- Group provider types that may bill for lactation support services include:
 - Supply (PT 14)
- When claim is submitted using supplier as billing provider, use NPI of provider who rendered service
- This rendering provider does not need to be affiliated with the group for claim to process




Provider Enrollment Provider Type Definitions

Rendering provider: individual who performed the billed service

Provider Enrollment Referring Providers - Doula & Lactation

- Doula and lactation support services are provided as preventive services and require a referral
- Referring providers must be enrolled in Health First Colorado
 - List NPI on claim
 - Failure to revalidate will result in claim denial



Provider Enrollment Referring Providers - Doula

Eligible referring provider types:

- Physicians (PT 05/65)
- Physician Assistants (PT 39)
- Advanced Practice Nurses (PT 41)
- Nurse Midwives (PT 22) and Certified Professional Midwives/Direct Entry Midwives (PT 69)
- Licensed Psychologist (PT 37) and Licensed Behavioral Health Clinical (PT 38)



Provider Enrollment Referring Providers - Lactation Support Services

Eligible referring provider types:

- Physicians (PT 05/65)
- Osteopaths (PT 26)
- Physician Assistants (PT 39)
- Advanced Practice Nurses (PT 41)
- Nurse Midwives (PT 22)
- Certified Midwife (CM) (PT 80)
- Certified Professional Midwife (CPM) / Direct Entry Midwife (DEM) (PT 69)
- Non-Physician Practitioner-Individual (PT 24)





Billing & Payment

Billing & Payment Third-Party Liability (TPL)

- Third-party liability (TPL) refers to outside insurance or resources a member may have in addition to Health First Colorado
- Special bypass edits are in place when claims are submitted by the following provider types:
 - PT 70 Lactation Consultant
 - PT 72 Lactation/Doula Professional Group
 - PT 79 Doula



Billing & Payment Reporting Units of Service

- Timed procedure codes are used for services delivered on any single day
 - Units are reported in 15-minute increments
- Untimed procedure codes are not defined by a specific timeframe
 - Units are reported based on the number of times the procedure is performed





Billing & Payment Reporting Units of Service

- Providers should not bill for services performed for less than 8 minutes
- Providers should bill a single 15-minute unit for treatment greater than or equal to 8 minutes through and including 22 minutes

| Billed Units Increment | Time Spent in Direct Patient Contact |
|------------------------|--------------------------------------|
| 1 unit of service | 8 minutes through 22 minutes |
| 2 units of service | 23 minutes through 37 minutes |
| 3 units of service | 38 minutes through 52 minutes |
| 4 units of service | 53 minutes through 67 minutes |
| 5 units of service | 68 minutes through 82 minutes |
| 6 units of service | 83 minutes through 97 minutes |
| 7 units of service | 98 minutes through 112 minutes |
| 8 units of service | 113 minutes through 127 minutes |

Example:

A member received a total of 60 minutes of prenatal doula birth worker services codes using HCPCS "timed" code T1032 which is defined in 15-minute units, on a given date of service.

The provider would then report four (4) units of code T1032.



Billing & Payment **Documenting Units of Service**

- Lactation support service providers and doulas must maintain documentation in accordance with 10 CCR 2505-10 8.130.2 that complies with state and federal regulations
- Providers must retain records indicating dates and precise times at which direct services provided to member began and ended
- Timestamps are critical for validating number of units of service billed









Billing & Payment Procedure Codes & Modifiers - Doula

- Procedure Codes
 - T1032 = prenatal and postpartum services (timed)
 - T1033 = labor and delivery services (untimed)
- Modifiers for telemedicine delivery, claim field completion instructions, and claim example available in the <u>Doula Billing Manual</u>






Billing & Payment Coding Table - Doula

| | | (Telemedicine service delivery not allowed) | |
| Doula birth worker services, postpartum | 12 units of service (180 minutes) per member | T1032 | Z39.1 |
| | pregnancy | (Telemedicine service delivery allowed) | |



Billing Managed Care Plans - Doula

- Doula services are not included in managed care plans
 - Still a covered benefit for members enrolled in those plans
- Bill claims to Fiscal Agent





- Procedure code S9443 is used for all lactation support services
- Modifier codes indicating individual (U1) or group settings (U2)
 - Group session (modifier U2) must be instructor-led breastfeeding education group
 - Claim for payment may be submitted for each enrolled Health First Colorado member that received services in the group session
- Modifiers for telemedicine delivery, claim field completion instructions, and claim example available in the <u>Lactation Support Services Billing Manual</u>



| Procedure Code | Description | First Position Modifier | Second Position Modifier |
|----------------|---|---|--|
| S9443 | Lactation Support Services Telemedicine service delivery is allowed. | U1 = individual session U2 = group session | U3 = 8-22 minutes U4 = 23-37 minutes U5 = 38-52 minutes U6 = 53-67 minutes U7 = 68-82 minutes U8 = 83-97 minutes U9 = 98-112 minutes UA = 113-127 minutes |



- The provider should bill the claim under the eligible member for whom the visit was scheduled, or most closely aligns with the provider's scope of practice.
- Example:
 - Pediatrician would bill under the Health First Colorado enrolled breastfeeding child
 - Obstetrician would bill under the Health First Colorado enrolled lactating

member



When billing for lactation support services for twins, multiple infants or tandem breastfeeding, providers have two options:

- 1. Bill for extended time spent with the lactating member; OR
- 2. Bill separately for time spent with each breastfeeding child. Providers will need to ensure to bill for distinct and separate identifiable amounts of time for each pediatric member.



Billing Referring Providers

- Referring (or "recommending")
 providers are required on doula and
 lactation support services claims
- Providers must maintain record of recommendation for each member before initiating lactation care

- National Provider Identifier (NPI) of recommending provider actively enrolled in Health First Colorado must be indicated on claim
 - Ordering, Prescribing and Referring (OPR) field

OPR Field on Professional Claims

- Provider Web Portal field is labeled "Referring Provider"
- Paper claims use field 17.b
- Batch submissions use loop 2420 with qualifier DK (Ordering), DN (Referring) or DQ (Supervising)



Billing Members on Managed Care Plans - Doula

- Doula services are not included in Health First Colorado physical health managed care plans
 - Still covered as "wrap-around" benefits
- All claims for lactation support services should be billed to the Department's fiscal agent (Gainwell Technologies) even if member is attributed to a Health First Colorado managed care plan





Billing

Members on Managed Care Plans - Lactation Support Services

- Lactation support services are not included in Health First Colorado physical health managed care plans
- Lactation support services are still covered benefits for members enrolled in those plans as "wrap-around" benefits of the plan, similar to Doulas

To bill for services rendered to members on Child Health Plan Plus (CHP+)

- Providers must have active contract with a CHP+ Managed Care Organization (MCO)
- Providers should submit claims to the MCO once member is enrolled into an MCO



Billing Place of Service Codes

- Prenatal and postpartum doula care and lactation support services can be provided in a variety of settings: member's home, clinics and provider offices, community-based settings, or via telehealth
- Visit setting should be indicated on claim using "Place of Service" code
- Specific allowed "Place of Service" codes can be found in the <u>Doula Billing</u> <u>Manual</u> & <u>Lactation Support Services Billing Manual</u>
- Telehealth services must adhere to the <u>Telemedicine Billing Manual</u>



Billing Place of Service Code Restrictions


- Doula labor and delivery services
 cannot be provided via telemedicine
- Lactation support services benefit does not apply when delivered:
 - In an Inpatient Hospital setting (place of service code 21)
 - In a Freestanding Birth Center setting (place of service code 25)

- HCPCS codes for lactation support services cannot be billed for dates on or during the date span of delivery and inpatient stay
- More information specific to these restrictions can be found in the <u>Obstetrical Care</u> <u>Billing Manual</u>



Billing Dates of Service

- Two dates of service are available on claim submission
- Single date of service submissions should be entered in "From" field only
- Span billing is not permitted





Lactation support services include education, counseling, and assistance for common breastfeeding issues, along with skilled, evidence-based care for more complex lactation issues Lactation support can be in-person or via telehealth in a 1-on-1 or group setting before childbirth and after delivery. Who is Eligible for Lactation Support Services? Pregnant people, postpartum people, and children who are breastfeeding are eligible for lactation support services. Enrollment Ouick Guide

Follow the steps listed to become an approved Health First Colorado (Colorado's Medicaid program) and Child Health Plan Plus (CHP+) lactation provider.

Step 1. Acquire a National Provider Identifier

- A Type 1 NPI will be required when registering as an individual lactation provider.
- ◆ A Type 2 NPI will be required when registering as a Lactation/Doula Professional Group.
- ◆ Apply for an NPI through the NPPES website

Step 2. Gather Necessary Documents and

- Provider enrollment forms can be found on the Providers Forms web page under the "Provider Enrollment & Updates Forms"
- Ensure you have all the necessary information available to complete the application.

Step 3. Complete the Application

Once steps 1 and 2 are complete, you can complete the lactation provider application

◆ From the "Find Your Provider Type" page (hcpf,colorado,gov/find-your-provider-type), scroll down to find your provider type (Lactation Consultant; Lactation Counselor or

Educator: or Lactation/Doula Professional Group) and review the information in that provider type's section. Then, scroll down to the bottom of the page and click on "Continue to Enrollment Type".

- ◆ From the "Enrollment Types" page (hcpf.colorado.gov/enrollment-types) find, review, and download the checklist for your provider type. Then, scroll down and click the "Go to Application" button.
- ◆ Click the "Enrollment Application" link on the left-side of the Provider Enrollment Portal.
- Follow the prompts to submit the verification documentation needed.

Step 4, Complete Background Check

• After submitting your application, it will trigger a request for a background check. You will have 30 days to complete your fingerprinting, and the Application Tracking Number (ATN) will be associated with your Colorado Bureau of Investigation (CBI) report.

Fingerprinting: scroll down the page for more info.

- · Notification of acceptance depends on several factors. If an application is returned to the provider for additional information, a prompt response can prevent further delays. Approval timelines vary based on how quickly the provider submits the requested information and schedules a site visit.
- . Once approved, a notification will be sent to the contact information provided in the enrollment application, confirming the approval. At this point, you will be an approved Heath First Colorado






