Scholarship Opportunity Update

- Funds will support training and certification of eligible individuals, to increase the workforce outlined in <u>SB 23-288</u> by providing education and resources needed to complete programs and enroll as a Health First Colorado provider.
- Criteria: must be an approved doula training organization.
- Considering awarding up to four organizations.

Scholarship Opportunity Feedback

- 1. How many individuals could be trained and supported in the range of \$1,500 \$3,000 per individual ("needs based")?
- 1. Can training organizations provide support and assistance to doulas to enroll as a Health First Colorado provider?

Scholarship Feedback Continued

- 3. Can the newly trained doulas be affiliated with the training organization?
- 3. Is \$25,000 sufficient for one organization, with 10% toward oversight?
