#### 2. Required Provisions:

- A. In accordance with Section 4.B. and Exhibit C, Section 5.3. of the Original Contract, the State hereby exercises its option to increase the quantity of the Services at the rates stated in the Original Contract, as amended.
  - i. A total of \$1,000,000 of unused funds is deducted from State Fiscal Year 2025 and added to State Fiscal Year 2026 for CMES DDI activities.
  - ii. A total of \$175,000 is added to State Fiscal Year 2026 for Pregnancy Services under SB25-183 (SCR59936).
