



Comprehensive Safety Net Provider Prospective Payment System (PPS) Code List

Fact Sheet February 2024

This document presents the services/codes that are included in the PPS reimbursement design for Comprehensive providers. As a high level summary of Medicaid-covered behavioral health services, please note:

- There are 153 distinct codes included in the Medicaid Capitated Behavioral Health Benefit.
- There are 144 codes included in the PPS (listed in the chart below). There are 9 codes NOT included in the Comprehensive PPS (listed after chart). This aligns with the scope of services identified by Behavioral Health Administration (BHA) rules.
- 10 codes are “add-on” codes and will not trigger an encounter (these are highlighted in orange in the chart below).
- All codes are allowed for any covered diagnosis (mental health or substance use disorder) except those indicated in the chart below: S = SUD Only (4 codes) ; M = MH Only (3 codes).

- 90870 Electroconvulsive Therapy (ECT)
- 00104 Anesthesia for Electroconvulsive Therapy
- H0010 Clinically managed residential withdrawal management: ASAM level 3.2WM, per diem
- H0011 Clinically managed residential withdrawal management: ASAM level 3.7WM, per diem
- H0017 Behavioral Health; residential (hospital residential treatment program), without room and board, per diem
- H0018 Behavioral Health; short-term residential (non-hospital residential treatment program), without room and board, per diem
- H0019 Behavioral Health; long-term residential (non-medical, non-acute care in a residential treatment program where stay is typically longer than 30 days), without room and board, per diem
- H0020 Alcohol and/or drug services; Methadone administration and/or service (provision of the drug by a licensed program)
- H2036 Alcohol and/or other drug treatment program, per diem
