### **Purpose and Audience:**

The purpose of this Informational Memo is to inform stakeholders of upcoming engagement meetings hosted by the Department of Health Care Policy & Financing (Department) in conjunction with the Department of Housing (DOH) to discuss and receive feedback on proposed changes to Home Modification procedures. This meeting is open to all interested stakeholders, including Home and Community-Based Services (HCBS) waiver members, guardians and relatives of members, advocates, providers and Case Management Agencies (CMAs) serving individuals who receive Home Modifications/Home Accessibility Adaptations within the HCBS Supported Living Services (SLS) waiver, Children’s Extensive Supports (CES) waiver, Elderly, Blind and Disabled (EBD) waiver, Community Mental Health Supports (CMHS) waiver, Brain Injury (BI) waiver, and the Spinal Cord Injury (SCI) waiver.



**Information:**

The Department has received feedback from stakeholders who have identified opportunities to update elements of the Home Modification/Home Accessibility Adaptation benefit. The Department, in conjunction with DOH, will hold monthly stakeholder engagement meetings to discuss these opportunities within the Home Modification benefit. There will be time allotted during each engagement meeting for a "Question & Answer" segment for Stakeholders to ask questions surrounding the Home Modification benefit.
