### **Purpose and Audience:**

The Department of Health Care Policy & Financing (the Department) is preparing to renew the following Home and Community-Based (HCBS) waivers in 2020: Children with Life Limiting Illness (CLLI) and Persons with Spinal Cord Injury (SCI). The purpose of this Informational Memo is to invite all interested stakeholders to presentations regarding the renewal of the CLLI and SCI waivers.

### **Information:**

The Department will be presenting on the CLLI waiver renewal during the first portion of the Children's Disability Advisory Committee (CDAC) on Wednesday, October 9, 2019 and will be presenting on the SCI waiver renewal during the first portion of the SCI Advisory Committee meeting on Friday, October 11, 2019. Full meeting details are listed below.

The Department would like to use these presentations as an opportunity for stakeholders to become involved in the renewal of the CLLI and SCI waivers. The presentations will discuss the HCBS waiver application renewal process, the Department's timeline, and provide an overview of the content in a waiver application. The goal of the presentations is to allow stakeholders to engage Department staff as the waiver application language is edited and prepared for submission to the Centers for Medicare & Medicaid Services (CMS).

Stakeholders will have an additional opportunity to provide the Department with feedback on the CLLI and SCI waiver renewals during the Public Noticing Period in February 2020.

All comments received by the Department will be reviewed and taken into consideration and will either be implemented or a rationale for not implementing a suggestion will be explained. The Department will create a Listening Log to record the comments and the Department's responses. The Listening Log will be published after the public comment period ends.
