### **Purpose and Audience:**

The Colorado Department of Health Care Policy & Financing (Department) is proposing revisions to portions of 10 CCR 2505-10 §8.300 – §8.600 to be effective January 1, 2021. Stakeholders are invited to attend a presentation of the proposed regulation revisions and to review the draft rule revisions during the public rule review. Stakeholders who may be interested include members receiving Home and Community-Based Services (HCBS) and their families or representatives, advocates, and Case Management Agencies (CMAs).

### **Information:**

The Department is proposing technical changes to 10 CCR 2505-10 §8.300, 8.400, 8.500, and 8.600. Technical revisions include, but are not limited to, correcting grammatical and typographical errors, removing outdated terminology or references, and eliminating antiquated regulations. These proposed revisions will also reflect waiver amendments submitted to Centers for Medicare & Medicaid Services (CMS) that will make permanent some of the changes made in response to the Coronavirus pandemic.

There will be two opportunities for stakeholders to receive an overview of the proposed changes; the same information will be provided at each of the following meeting dates:
