Purpose and Audience:

The purpose of this Informational Memo is to provide county Department of Human Service (DHS) agencies an update from the Colorado Department of Health Care Policy & Financing (Department) regarding the transition of two Single Entry Point (SEP) agencies and information regarding the new agencies that will be providing SEP services. Please see the accompanying chart for agency information.

Information:

On July 1, 2021 the following SEP agencies will be transitioning to a new Case Management Agency. County DHS agencies should be prepared to receive and provide information regarding long-term services and support (LTSS) from and to all incoming agencies, as they had previously received from the outgoing agencies. This communication includes but is not limited to the Department of Social Services Information Form (DSS-1), referrals and communications, LTSS applications, case escalations and Level of Care (LOC) certifications.
