The Colorado Department of Health Care Policy & Financing (HCPF) invites the public to comment on proposed waiver amendments to nine (9) of Colorado's Home and Community-Based (HCBS) 1915(c) waivers: Persons with Brain Injury (BI), Children's Extensive Supports (CES), Children's Home and Community-Based Services (CHCBS), Children's Habilitation Residential Program (CHRP), Community Mental Health Supports (CMHS), Complementary and Integrative Health (CIH), Developmental Disabilities (DD), Elderly, Blind, and Disabled (EBD), and Supported Living Services (SLS).

#### Information:

HCPF intends to submit waiver amendments to the Centers for Medicare & Medicaid Services (CMS) on Friday, Sept. 15, 2023. HCPF will request an effective date of Jan. 1, 2024, for the amendments.

The proposed waiver amendments include the following changes:

- Home Modification Lifetime Cap Update (BI, CMHS, EBD, CIH)
- Home Modification and Home Accessibility Adaptations Formal Language
  Addition (BI, CES, CIH, CMHS, EBD, SLS)
- Increase Expense Limit for HCBS Transition Services Setup (BI, CMHS, DD, EBD, CIH, SLS)
- CHRP Benefit Titles Reformatting (CHRP)
- Vehicle Modification Language Addition (CES, SLS)
- Parent Education Service Name Change (CES)
- Wellness Education Benefit (WEB) Addition (CHCBS)
- Development of Respite Specialties (CES, CHRP)
- Overnight Respite Clarification (CHRP)
- Removal of Old Age Pension (OAP) Standards (EBD, BI, CMHS)
