The Colorado Department of Health Care Policy & Financing (HCPF) invites the public to comment on proposed waiver amendments to six (6) of Colorado's Home and Community-Based (HCBS) waivers:

- Elderly, Blind, and Disabled (EBD),
- Children with Life Limiting Illness (CLLI),
- Children's Home and Community-Based Services (CHCBS),
