Purpose and Audience:

The purpose of this Informational Memo is to inform members, families, advocates, Case Management Agencies and Children’s Habilitation Residential Program (CHRP) provider agencies of the elimination of the headings for Intensive Support and Transition Support Services for Wraparound Services and Child and Youth Mentorship.

Wraparound services include Wraparound Planning and Prevention and Monitoring.

Background Information:

Child and Youth Mentorship and Wraparound Services, which include Wraparound Plan and Prevention and Monitoring, are now standalone services and no longer require differentiation between “Intensive Supports” and “Transition Supports”.

The Department of Health Care Policy and Finance (HCPF) previously implemented the addition of HA and HI modifiers for the purpose of service tracking. Because there is no longer a need to track these services separately, HCPF removed the requirement to distinguish between "intensive" and "transition" supports for services.

This policy and operational change is intended to allow members to access the critical Wraparound Services and Child and Youth Mentorship more efficiently. Members will not lose any service because of the removal of the “Intensive Supports” and “Transition Supports” headers and modifiers.

Wraparound Services and Child and Youth Mentorship Service Codes

To support this change, HCPF will utilize the following procedure codes and modifiers for Wraparound Services and Child and Youth Mentorship.

- Wraparound Plan H2021 U9 HA TL
- Prevention and Monitoring H2021 U9 HA HN
- Youth and Child Mentorship H2021 U9 HA HM

To minimize impact, the “HI” modifier will be discontinued in the Bridge for Prior Authorizations effective Nov. 1, 2024. The “HI” modifier will continue to pay, if the line is already authorized on the member’s prior authorization. At the member’s Continued Stay Review (CSR), the “HA” modifier should be used on Prior Authorization Requests (PARs) in alignment with the CHRP Rates Sheet

Case Management Agency Information

For PARs authorized during the member’s CSR with Wraparound plan, Prevention and Monitoring, and Child and Youth Mentorship lines, use the code with the “HA” modifiers in the [CHRP Rates Sheet](#) that matches the service.

Provider Agency Information

Provider agencies should bill the codes that are authorized on the PARs. Current codes will continue to pay if there is an “HA” or “HI” modifier to avoid disruptions in paying claims. Within the next year, the “HI” modifier will be phased out of PARs and Wraparound Service and Child and Youth Mentorship claims will only have the “HA” modifier.
