The Colorado Department of Health Care Policy & Financing (HCPF) invites the public to comment on proposed waiver amendments to nine (9) of Colorado's Home and Community-Based (HCBS) waivers:

- Children's Extensive Supports (CES)
- Developmental Disabilities (DD)

- Children's Habilitation Residential Program (CHRP)
- Supported Living Services (SLS)
- Community Mental Health Supports (CMHS)
- Complementary and Integrative Health (CIH)

HCPF intends to submit the amendments to the Centers for Medicare & Medicaid Services (CMS) on September 19, 2025. HCPF will request an effective date of January 1, 2026 for the amendments.
