Purpose and Audience:

The purpose of this Operational Memo is to inform county departments of human/social services departments (counties) of the Colorado Department of Health Care Policy and Financing's FY 2024-25 County Administration Allocation based on enhanced and non-enhanced Medicaid administration funding split.

Information:

For State Fiscal Year (SFY) 2024-25, the Colorado General Assembly has appropriated \$123 million dollars in HCPF administrative funding for county departments of human/social services. Of the total appropriation:

• \$83,998,353 million is allocated to counties for eligible administrative expenses, which is split between \$56,527,147 million for federal enhanced match expenditures and \$27,471,206 for federal non-enhanced match expenditures. This represents approximately a 9% increase in the annual allocation from FY 2023-24 to FY 2024-25 and does include the standard local share requirement;

- \$8,224,384 million is for performance incentives through the County Incentives Program, which is state funds-only and reimburses the county for local share expended during the fiscal year;
- \$1 million is for the County Grant Program, split between competitive and targeted grants and is federal and state funds-only with no local share;
- \$9,520,463 is for work relating to the unwinding of the Continuous Coverage provisions resulting from the COVID-19 PHE; this funding is term-limited and is scheduled to sunset by June 30, 2025; for FY 2024-25, this does not include the standard local share requirement, as the General Assembly authorized additional state funding to cover the local share. This funding will not be extended past FY 2024-25;
- The remaining \$20,305,030 million is in excess federal and local funds spending authority that is available to help cover county costs when state funds have been exhausted.

The approved funding splits between federal, state and local shares for county administration funding are:

Eligible Expenditures and Enhanced vs. Non-Enhanced Activities

Eligible expenditures are limited to those that are necessary for the county to fulfill its role in the Medicaid State Plan, which is the state's agreement with the federal government. The county's role in the Medicaid State Plan is limited to functions relating to eligibility, enrollment and supporting functions, including customer service, program integrity, and other required functions that support eligibility and enrollment. Expenditures that are not related to the county's role in the Medicaid State Plan, that are duplicative of federal and state spending or that HCPF has determined are not eligible expenditures may not draw down federal and state funds. If the county is unsure whether an expenditure is eligible for federal and state reimbursement, please contact the HCPF contact listed below.
