## Purpose and Audience:

The purpose of this Informational Memo is to inform eligibility sites of the 2026 Social Security Cost of Living Adjustment (COLA). Please share this memo with all affected Adult and Long Term Care Medicaid eligibility staff, supervisors, and outside agencies, as appropriate. The monthly Social Security and Supplemental Security Income (SSI) benefits will increase 2.8% for the 2026 benefit year. The purpose of the COLA is to ensure purchasing power of Social Security and SSI benefits is not eroded by inflation. It is based on the percentage increase with the Consumer Price Index for Urban Wage

Earners and Clerical Workers from the third quarter of the last year COLA was determined to the third quarter of the current year.
