Background and Intent of HB 21-1085

Created a regulatory and service system to provide secure transportation services to individuals experiencing a behavioral health crisis.

Intent to:

- Provide a patient-centered approach
 - Create accountability and parity
- Free up resources to create a more effective alternative to traditional ambulance services and law enforcement





CDPHE'S Statutory Obligations

for urgent secure transportation services to be adopted by the Board of Health by July 1, 2022

[Section 25-3.5-311, C.R.S.]

Collect data from secure transportation providers and annually make data publicly available

[Section 25-3.5-313, C.R.S.]

Counties' Statutory Obligations

Ensure compliance with minimum standards and license all secure transportation services, beginning no later than January 1, 2023

Set fees for all licenses, vehicle permits, and renewals

Issue separate vehicle permits for each vehicle being used by the secure transportation service

[Section 25-3.5-309, C.R.S.]

HCPF's Statutory Obligations

Create a benefit for secure transportation by January 1, 2023

Research and create a plan to establish secure transportation services, which may include supplemental and coordinated community response services, to be implemented by July 1, 2023

[Section 25-5.5-328, C.R.S.]







Regulatory Development - Stakeholder Process

- Worked closely with diverse group of stakeholders who currently provide secure transportation services across the state between September 2021 and March 2022
- Representation from behavioral health agencies, ground ambulance agencies, security companies, other state agencies, consultants, and advocates
- Minimum standards adopted by the Colorado Board of Health in June 2022 (6 CCR 1011-4, Standards for Secure Transportation Services)





County Responsibilities

The Board of County Commissioners of the county in which the secure transportation service is based will be responsible for issuing licenses and vehicle permits for such transports, complaint processing, and enforcement of the rules.





County Responsibilities - Part 3, County Issuance of Licenses and Vehicle Permits

The county shall ensure that the secure transportation service complies with the general requirements for County licensure of secure transportation services and permitting of secure transportation vehicles





Provider Responsibility - Part 6, Data Collection and Reporting Requirements

- "Data collection and reporting on utilization to the department by a licensee..." (Section 25-3.5-311 C.R.S.)
- Annual reporting for the calendar year prior due no later than March 1 each year (beginning 2024) (6 CCR 1011-4, Part 6)
- Data will be summarized and made publically available by CDPHE by July 1st following each March 1st submission deadline





Data Requirements - Parts 6

Secure Transportation services shall submit... the following data for the previous calendar year:

- (A) The total number of transports
- (B) The total number of adults (18+) served
- (C) The total number of minors (17 and under) served
- (D) The type of location where individuals were picked up/dropped off



Data Requirements - Parts 6 Cont'd

Secure Transportation services shall submit... the following data for the previous calendar year:

- (E)The total number of individuals who were transported more than one time
- (F)The total number of transports that the service was declined due to lack of S.T. resources
- (G)Demographic information (e.g., zip code, totals by location, gender, race & ethnicity)
- (H)The total number of clients transported who were not on involuntary holds





Data Reporting: Process & Timeline

- 1/1/2023-12/31/2023: Transports occur and are documented in spreadsheet by service
- 3/1/2024: Data due to CDPHE
- 7/1/2024: Data will be summarized and made publically available by CDPHE

- Minimum necessary
- Locked to standardize







Colorado Data Dictionary

Required Variables for Secure Transports, 2023

Each client should be entered on a unique row. Every column must be completed for all clients.

Secure Transportation Service Name

Definition: The secure transportation service's name as listed on county issued license.

Values: Free text appropriate service name

Unique Transport Number

Definition: The unique number automatically assigned by the service for each transport. This

should be a unique number for the service for all of time.

Values: String between 3-50 characters

Transport Date

Definition: The date the responding unit began transport of the client.

Values: MM/DD/YYYY
Example: 12/01/2020

Client Age Group

Definition: The client's age group (either calculated from date of birth or best

approximation).

Values: 184

17 and under

Data Dictionary

- All elements and their appropriate responses defined
- Standardized
- Available to download

Submission Process & Data Privacy

- To protect client information, data submission must be encrypted prior to sending to the department. To do that, you must complete the following steps:
- Navigate to https://securemail.state.co.us/securereader/init.jsf?brand=7dad83d6 and register your email.
- 2. Create a password for your email encryption account
- 3. Click 'New Message' and complete the email as you typically would.
- 4. Attach the Secure Transportation Spreadsheet from your agency, address email to cdphe.securetransportationdata@state.co.us and click 'Send'.




- Will align with current transportation <u>mileage rates</u>


BHST Implementation Timeline

Current Responsibilities



Ensure compliance with minimum standards and license secure transportation services by Jan 1, 2023

Medical Services Board Rule Review

- Data Collection
- Obtain appropriate licenses and permits
 - Optional: Enroll staff as NEMT provider if interested in providing return trip

NEMT Enrollment

- Non-Emergent Medical Transportation
 - Provider differences
 - BHST requires providers have CPR and First Aid
 - NEMT requires providers have BLS
- HCPF <u>Provider Enrollment</u>
 - Allow up to one month for processing
