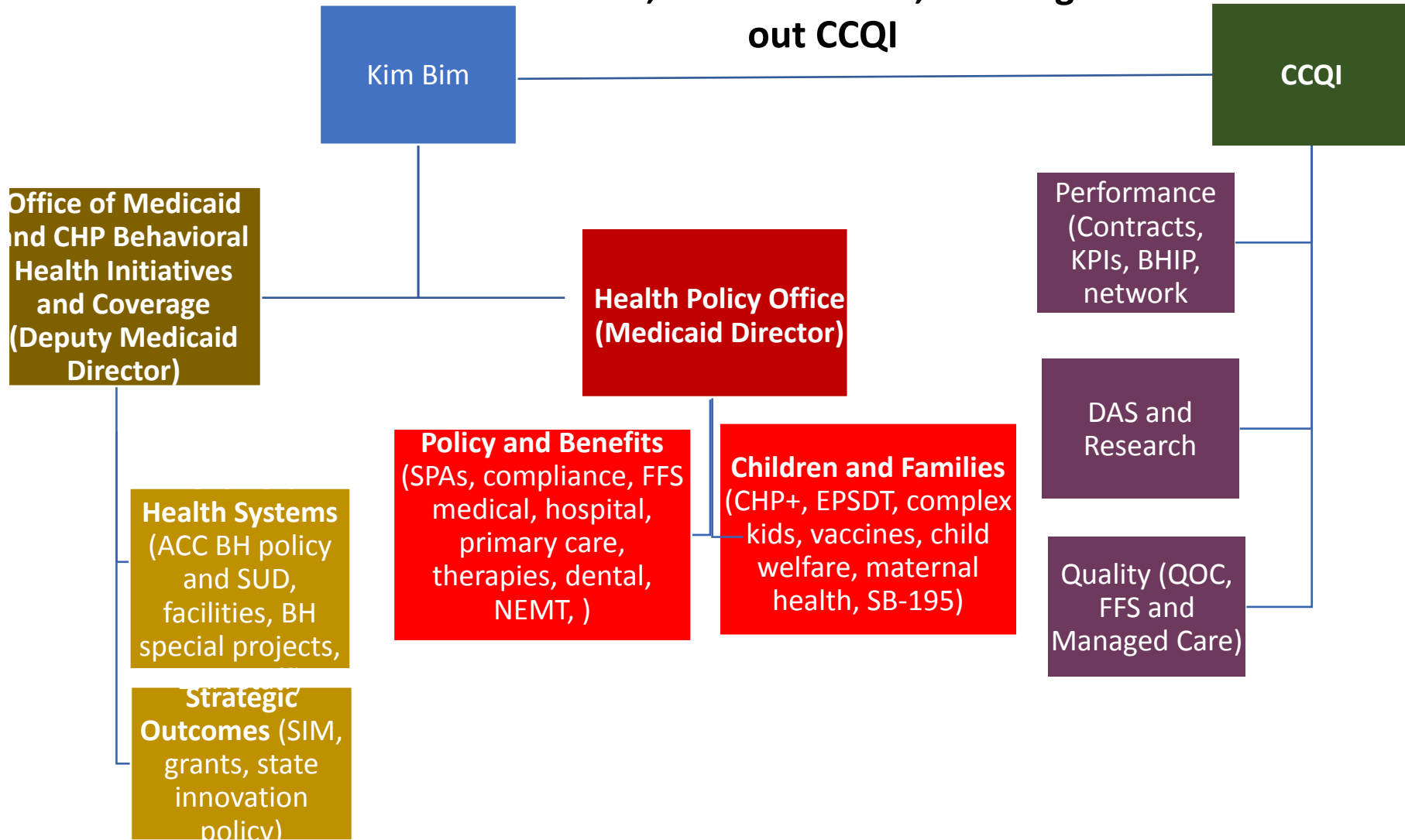

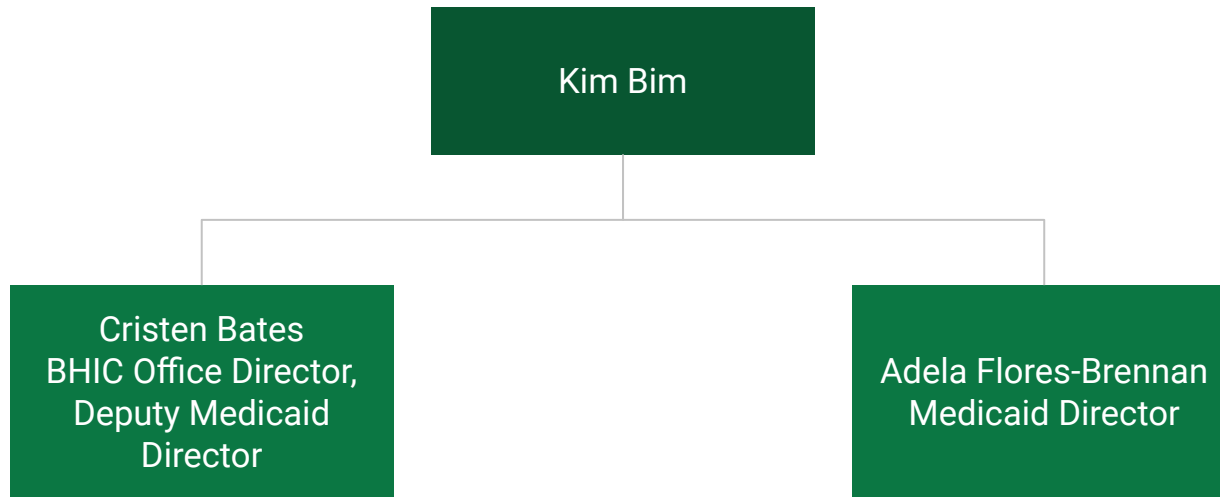
County Leadership Meeting

Changes: Rationale

- Focus on behavioral health and alignment with new Behavioral Health Authority
- Significant increase in staff per ARPA and new legislation
- ARPA projects in behavioral health
- Alignment with Department of Early Childhood and equity focus on maternal and child health

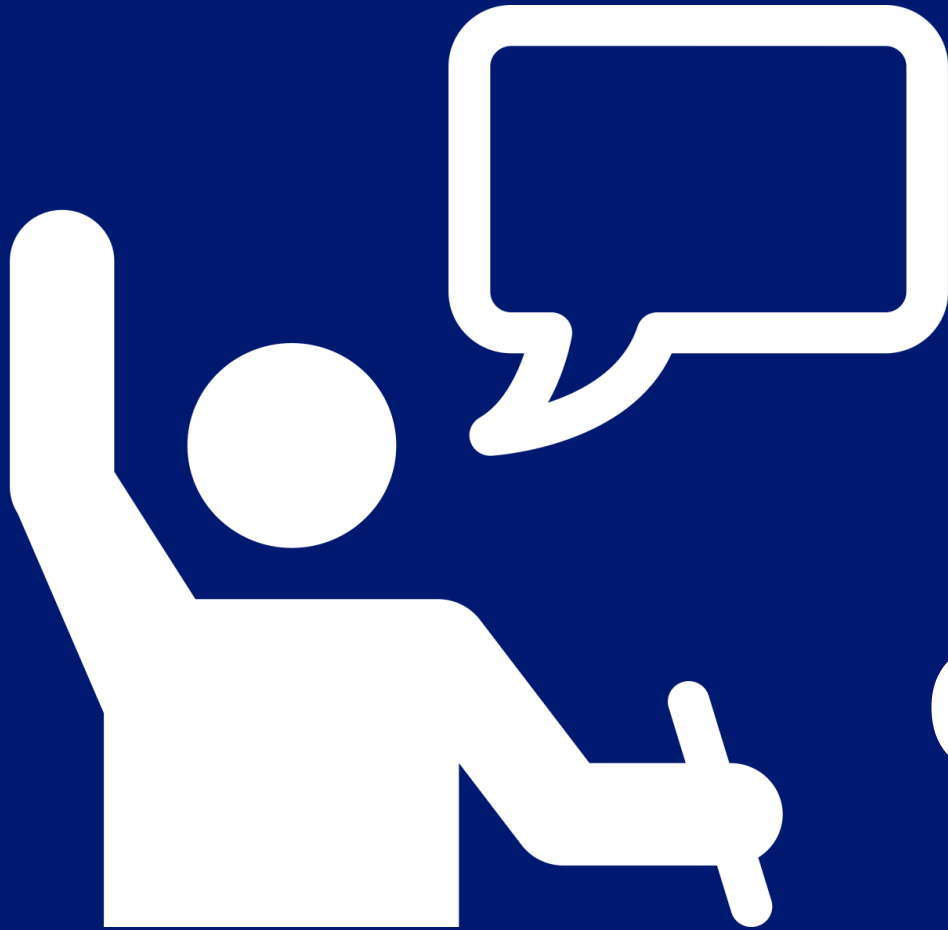
Update Medicaid Director Role, New BH Office, Building out CCQI





Partnership with BHA

- BHA is setting the system/provider standards & vision
- HCPF will be executing on that vision, and supporting provider standards with payment models
- Expectation is that ALL HCPF BH efforts will have BHA engagement, and that HCPF provide input on most BHA efforts
- Key goal is to educate all partners on federal responsibilities that HCPF must meet
